1. Three Signature Project Schemes projects: (Kwun Tong District) - Construction of Music Fountains at Kwun Tong Promenade; (Wan Chai District) - Construction of Moreton Terrace Activities Centre and (Tai Po District) - Improving the Tourist Facilities at Lam Tsuen Wishing Square
