Paper for the House Committee Report on Multistakeholder Forum on ''Investing in Healthy and Active Ageing for Sustainable Growth'' and Asian Forum of Parliamentarians on Population and Development Standing Committee Meeting on Active Ageing

1. Purpose

This report summarizes key observations at the Multistakeholder Forum on "Investing in Healthy and Active Ageing for Sustainable Growth" and Asian Forum of Parliamentarians on Population and Development Standing Committee Meeting on Active Ageing (the Forum) held at The New World Saigon Hotel in Ho Chi Ming City, Vietnam, from 15 to 17 August 2017.

2. Background

- a. The Forum was jointly organised by six unique parties ¹ with the overarching goal of discussing the challenges and opportunities presented by rapid ageing Asia-Pacific economies and exploring ways to enhance cross-border and cross-sectoral cooperation between multiple jurisdictions. An approximate of 150 delegates were invited and expected to attend the Forum comprising of senior government officials, corporate leaders, researchers and international/non-government organisation representatives.
- b. The Legislative Council of the Hong Kong SAR of the People's Republic of China ("LegCo") received an invitation on 21 April 2017 to nominate up to three LegCo Members to attend the Forum. Hon Elizabeth QUAT, Hon YUNG Hoi-yan and I were nominated. Expenses incurred in attending the Forum were charged to the Overseas Duty Visit accounts of the attendees.

3. The Forum

The Forum lasted for three days and brought together 20 high-calibre speakers. Of the 20 speakers, there were 2 keynote addresses and 18 presentations.

Additionally, there was a planned visit to Ben Tre city to observe the management and day to day operations of social/community centres around the area on 16 August.²

4. Observations

It was highlighted in the Forum that an ageing population comes with serious consequences. Six points were particularly relevant to the topic in question, and were executively summarised as follows:^{3, 4}

- i. Rapid population ageing is a common challenge that transcends national boundaries and requires a multisectoral approach. Rapid population ageing was identified in Healthy Asia Pacific 2020 as an urgent issue that should be jointly addressed by both private and public sector - as it requires the involvement of parliamentarians, the various levels of national and local government, the business sector, the healthcare sector, civil society, and the elderly themselves. Population ageing and the resultant increase in the demand for healthcare services for the elderly began in industrialized economies and has begun spreading like a wave to affect middle-and low-income economies in the Asia-Pacific region – of which, Japan is a notable example.
- ii. Immediate action is needed to formulate appropriate policies to meet the needs of increasing numbers of elderly persons. The multifaceted nature of the issue calls for the strong commitment of parliamentarians, LegCo Members in the instance of Hong Kong, who can play a crucial role in cutting across the jurisdictions of various government branches to formulate comprehensive policies.
- iii. Ageing populations present a challenge, but healthy and active ageing can be turned into opportunities – expanding products, services and even the job market. Innovations in healthcare, internet technologies and management logistics can likewise promote healthy ageing and address the rising needs of elderly care. Active participation of elderly persons in the economy, moreover, can have a positive impact if

appropriate social and economic structures are put in place. Therefore, enabling the ageing population to carry on a productive life for as long as they are willing and/or capable to do so.

- iv. An ageing population is not only an economic challenge, but it is also inherently a health and security issue. As healthcare improves along with technological advancements, the burden of an ageing population will inevitably become more noticeable. Countermeasures such as that set out by in the Sustainable Development Goals (SDGs) is imperative to ensure that no one, regardless of age and gender—and especially no one among the more vulnerable groups—is left behind.
- v. Community-based care systems are the key to long-term care. The reason why this is the case is that not only is it more cost-effective, as it shifts the level of responsibility to the community instead of the government, but more importantly, community-based care systems respond to the desire of elderly persons better. That is to remain at home and age in place.⁵ Furthermore, this model/approach is also highly replicable in middle-to-low-income countries. The only limiting factor to this approach is the mindset/culture of citizens within a given area.
- vi. Regional cooperation is crucial for the development of care workers and the promotion of their effective circulation within the region. This is possible by signing of bilateral and multilateral agreements (e.g., MRAs). Caregiver training and qualifications need to be standardized and harmonized across different jurisdictions to enable and encourage circulation within and outside any given region in Asia. That is notwithstanding how essential it is to give adequate social recognition to care workers, protect their human and labour rights, and ensure opportunities for their career development.

Recommendation: Evidence-based policy is needed to successfully address the challenges of rapid population ageing. The appropriate metrics and indicators must be identified and utilized at the national and international levels to find holistic and pragmatic policy solutions. While each country must find its way of caring for the welfare of its elderly population in keeping with the local context, it is essential to build a solid foundation to facilitate local and international management of ageing populations by prioritizing global, regional and national policy discussions.

[Appendix 2] About the Speakers⁶

Abu Bakar, Faridah⁷

Faridah Abu Bakar is a medical doctor with Master's in Public Health, currently working as Deputy Director of Family Health in the Family Health Development Division of the Ministry of Health Malaysia for the past four years.

Asato, Wako⁸

Wako Asato is associate professor of the Graduate School of Letters at Kyoto University, Japan. He is a sociologist specializing in social welfare and migration in East and Southeast Asia. Since 2000, he has been conducting extensive fieldwork, particularly in the Philippines, Indonesia, Thailand, Singapore, Taiwan, Hong Kong, and Japan on migration and social integration. 2010), where she led the Programme Support and Global Quality Standards Team, responsible for promoting program coherence and innovation under the UN development system. Prior to that, she was UNFPA representative in Sri Lanka and country director in the Maldives (2003–2007), supporting the development and implementation of program operations as well as the humanitarian response to the devastating 2004 Asian tsunami. [Appendix 3] Backgrounds of Co-Organisers (Except Governments)²⁵

AFPPD²⁶

The Asian Forum of Parliamentarians on Population and Development (AFPPD) is a network of 29 national committees of parliamentarians from Asia-Pacific countries. AFPPD promotes advocacy and parliamentary actions on population and development issues at the global, regional and national levels. For the past 35 years, AFPPD has been playing a crucial role in engaging parliamentarians across the region in a wide variety of issues related to population and development. AFPPD's current model for change is aimed at educating and motivating parliamentarians to take up the challenge of bringing about legislative reforms and drive change on population and development issues outlined in the Programme of Action of the International Conference on Population and Development (ICPD PoA), the ICPD Beyond 2014, as well as the Agenda 2030 for Sustainable Development.

AFPPD is governed by the General Assembly; managed by the Executive Committee; advised by three Standing Committees on its strategic priorities, namely, active ageing, investing in youth and gender equality and women's empowerment; and supported by the Secretariat located in Bangkok, Thailand.

ERIA²⁷

On 23 August 2006, during the 13th Consultation held between the ASEAN Economic Ministers and the Ministry of Economy, Trade and Industry of Japan (AEM-METI) in Kuala Lumpur, the name 'Economic Research Institute for ASEAN and East Asia (ERIA)' appeared for the first time.

In this meeting, Mr Toshihiro Nikai, Japan's Minister of Economy, Trade and Industry, proposed to establish a think tank called ERIA that would approximate an East Asia version of the Organisation for Economic Cooperation and Development (OECD) and committed to contribute more than 10 billion yen in 10 years. A joint media statement of said consultation later stated that the ASEAN Ministers welcomed Japan's proposal and requested Japan to discuss it further with the ASEAN Secretariat.

In response to this, then ASEAN Secretary General, Mr Ong Keng Yong, initiated the creation of an ERIA Expert Group chaired by Dr Hadi Soesastro, Senior Fellow at the Centre for Strategic and International Studies (CSIS), Indonesia, and composed of experts from 16 East Asia Summit (EAS) countries and the ASEAN Secretariat. The Expert Group had intensive discussions on the overall idea of ERIA, in particular, its objectives, activities, structure, research themes, and capacity building program.

At the Second East Asia Summit held on 15 January 2007 in Cebu, Philippines, Mr Shinzo Abe, Prime Minister of Japan, formally proposed to establish ERIA and the EAS Leaders welcomed said proposal. Thereupon, on 1 April 2007, the Expert Group agreed on the Points of Convergence on the Institutional Set-Up of ERIA, which defined the objectives, activities and policy interface of ERIA. In addition, two test-run research projects were started through a collaboration among 16 regional research institutes. One was titled 'Developing a Roadmap toward East Asian Economic Integration', which was reported to the ASEAN Economic Ministers Meeting in August 2007, and the other was the 'Energy Security in East Asia', which was reported to the East Asia Energy Ministers' Meeting also in August 2007. Based on the results of these projects and thorough discussions of the Expert Group, the formal establishment of ERIA was agreed upon by all the leaders of the East Asia Summit at the Third East Asia Summit in Singapore on 21 November 2007.

Help Age International²⁸

HelpAge International is an international NGO that helps older people claim their rights, challenge discrimination, and overcome poverty, so that they can lead dignified, secure, active and healthy lives.

Five organisations from Canada, Colombia, Kenya, India and the United Kingdom set up HelpAge International in 1983 to provide a network to support older people worldwide.

HelpAge International now has well over 100 affiliates and works with more than 200 other partners in more than 70 countries.
