**Report No. 24/16-17 of the House Committee on Consideration of
Subsidiary Legislation and Other Instruments**

Purpose

This report gives the outcome of the consideration of the House Committee on subsidiary legislation the period for amendment of which will expire at the Council meeting of 12 July 2017.

Subsidiary legislation considered

2. The House Committee has considered the following items of subsidiary legislation:

3. The House Committee formed two subcommittees to study items (1) and (2) respectively in detail at its meeting on 26 May 2017. The first Subcommittee made a verbal report at the House Committee meeting on 30 June 2017, and provided Members with a written report vide LC Paper No. CB(1)1255/16-17 on 5 July 2017. The second Subcommittee reported its deliberations at the House Committee meeting on 16 June 2017 vide LC Paper No. CB(4)1220/16-17.

4. In respect of items (3) to (6), the House Committee considered it not necessary to form any subcommittee to study these four items of subsidiary legislation.

Note: The House Committee formed a subcommittee to study the following two items of subsidiary legislation at its meeting on 16 June 2017. The Council passed at its meeting of 5 July 2017 a resolution moved by Hon Jeremy TAM, Chairman of the Subcommittee, to extend the period for amending these two items of subsidiary legislation to the first Council meeting of the next session. Details of these two items of subsidiary legislation are as follows:
