I Proposed meetings on 10 and 21 January 2017

<u>The Chairman</u> informed members that the third and fourth meetings had been scheduled as follows:

(a) 10 January 2017, from 4:30 pm to 6:30 pm, to meet with academics/experts and the Administration to discuss the economic benefits and social roles of bazaars; and

Action

- (b) 21 January 2017, from 9:00 am to 1:00 pm, to meet with deputations/individuals and the Administration to discuss issues relating to markets and wider issues relating to policies on bazaars.
- 2. As suggested by the Chairman, Dr Fernando CHEUNG and Mr SHIU Ka-chun, the following academics would be invited to give views at the Subcommittee meeting on 10 January 2017:
 - (a) Mr CHOW Sung-ming of the Hong Kong Polytechnic University;
 - (b) Prof NG Mee-kam of the Chinese University of Hong Kong;
 - (c) Dr LEUNG Chi-yuen of the Hong Kong Polytechnic University; and
 - (d) Prof MA Kwok-ming and Prof IP Iam-chong of the Lingnan University.
- 3. As regards the meeting on 21 January 2017, the Chairman suggested inviting representatives from trade associations/organizations of Yen Chow Street Hawker Bazaar, Stanley Market and Graham Market. Mr SHIU Ka-chun suggested inviting representatives from Kam Sheung Road Flea Market and Mr LEUNG Yiu-chung suggested inviting trade associations/organizations of Ladies Market and Temple Street Night Market to share their experience in operating bazaars.

- 4. <u>The Chairman</u> welcomed representatives of the Administration and deputations/individuals to the meeting, and reminded them that their written submissions and views presented at the meeting would not be covered by the protection and immunity provided under the Legislative Council (Powers and Privileges) Ordinance (Cap. 382).
- 5. <u>The Subcommittee</u> received views from 40 deputations/individuals attending the meeting, and noted the seven written submissions provided by organizations/individuals which/who had not attended the meeting (Index of proceedings attached at **Appendix**).

(*Post-meeting note*: Three written submissions tabled at the meeting (Chinese version only) were issued to members vide Lotus Notes e-mail on 20 December 2016.)

- 6. <u>The Subcommittee</u> noted the following views expressed by deputations and individuals:
 - (a) the development of bazaars (including night markets) would (i) boost local economy and tourism, (ii) assist the grass-root people, housewives and elderly people to support their living by enabling them to lease sites at affordable rents to sell their products, and (iii) alleviate poverty;
 - (b) the Government should provide details on the application and consultation procedures for setting up bazaars;

Action

- (c) the use of "naked flame", instead of electricity, should be allowed in Lunar New Year bazaars and cooked food bazaars with proper firefighting and first aid facilities in place;
- (d) the Government should allow the public to set up bazaars during the first three days of the Lunar New Year and formulate a regulatory regime to ensure the smooth operation of Lunar New Year bazaars;
- (e) the Government should launch a pilot scheme by setting up bazaars at suitable locations in some districts with a view to extending the successful experience to other districts;
- (f) the Government should formulate long-term policies, provide assistance (including financial assistance) and facilities (e.g. community kitchens to assist bazaar operators to prepare food for sale), and simplify application procedures (including establishing a one-stop platform) to facilitate interested parties, in particular the grass-root people, in setting up bazaars;
- (g) before a comprehensive bazaar policy was in place, the Government should adopt a lenient approach in taking enforcement actions against street hawking activities, especially during the Lunar New Year;
- (h) the Government should consider (i) identifying suitable sites with high visitor flow in each district (e.g. pedestrian precinct, public spaces near MTR exits and open spaces in public rental housing estates) for setting up of bazaars, (ii) converting existing public markets with low occupancy into cooked food bazaars, (iii) converting the sites used for Lunar New Year Fairs for organization of Lunar New Year bazaars, and (iv) issuing new hawker licences;
- (i) the Government could make reference to the experience of Taiwan to allow non-governmental organizations ("NGOs"), local residents and hawkers to directly participate in the management of bazaars; and
- (j) instead of relying on District Councils ("DCs"), the Government should consider setting up district bazaar committees (地區墟市 委員會) to facilitate discussion of bazaar proposals by relevant

stakeholders (e.g. NGOs, hawkers, DC members and the Food and Environmental Hygiene Department).

Motions

- 7. At 12:52 pm, the Chairman informed the Subcommittee that she had received three motions from Mr Nathan LAW, Mr LEUNG Kwok-hung and Dr KWOK Ka-ki. Members had no objection to the Subcommittee proceeding with the motions. The Chairman invited the three members to speak on their motions.
- 8. <u>Mr Nathan LAW</u> spoke on his motion. The terms of the motion were as follows –

"墟市文化歷史悠久,街頭小販、路邊檔、地攤等不但為市民提供價廉物美的消費選擇,同時已成為香港人的集體回憶和生活文化。有見墟市隨着社會發展而日漸衰落,本會促請當局研究於全港五大選區各區選一年宵市場作試點,在農曆新年期間設立熟食墟市,藉此促進社區經濟、保留本土特色文化。"

(Translation)

"The culture of bazaars boasts a long history, whereas on-street hawkers, street stalls, sidewalk vendor stalls and so on not only offer affordable alternatives of consumption to members of the public but have also become part of the collective memories and living culture of the people of Hong Kong at the same time; given the decadence of bazaars along with the development of the community, this Subcommittee urges the authorities to look into the prospect of selecting a Lunar New Year Fair from each of the five major constituencies of Hong Kong as trial points for the establishment of cooked food bazaars during Lunar New Year with a view to fostering community economy and preserving the unique local culture."

- 9. <u>The Chairman</u> put Mr LAW's motion to vote. All members present at the meeting voted for the motion. The motion was passed.
- 10. <u>Mr LEUNG Kwok-hung</u> spoke on his motion. The terms of the motion were as follows
 - "本會促請當局研究於全港五大選區各區設一行人專用區作試點,在 農曆新年期間設立熟食墟市。"

(Translation)

"That this Subcommittee urges the authorities to look into the prospect of assigning a pedestrian precinct for each of the five major constituencies of Hong Kong as pilot points for the establishment of cooked food bazaars during Lunar New Year."

- 11. <u>The Chairman</u> put Mr LEUNG's motion to vote. One member voted against and all other members voted for the motion. The motion was passed.
- 12. <u>Dr KWOK Ka-ki</u> spoke on his motion. The terms of the motion were as follows –

"本會促請政府當局於農曆新年期間對街頭擺賣活動寬鬆執法。"

(Translation)

"That this Subcommittee urges the Administration to relax the enforcement actions against on-street hawking activities during Lunar New Year."

13. <u>The Chairman</u> put Mr KWOK's motion to vote. Two members abstained from voting and all other members present at the meeting voted for the Motion. The motion was passed.

(*Post-meeting note*: The terms of the motions were circulated to members vide LC Paper No. CB(1)351/16-17(11) on 21 December 2016.)

Follow-up actions to be taken by the Administration

- 14. The Administration was requested to provide information on:
 - (a) details of the application procedures for setting up bazaars in various districts, and factors and criteria adopted by the Administration in vetting the applications;
 - whether applications for setting up bazaars or Poon Choi feasts involving heating activities using "naked flame" (明文) were subject to different application procedures; details on the types of licences required, the consultation processes, and factors and criteria adopted by the Administration in vetting such applications;

Action

- (c) the Administration's response to Subcommittee members' suggestion of establishing a one-stop platform to facilitate the public in making applications for setting up bazaars;
- (d) a list of bazaar applications submitted to the 18 DCs in the past three years and their results of applications, including whether the applications involved heating activities using naked flame;
- (e) a list of potential sites in each of the 18 districts that might be considered for setting up bazaars, and the criteria adopted by the Administration in considering whether a site was suitable for establishing a bazaar;
- (f) the Government's policy on community kitchens;
- (g) the Administration's response to the three motions passed at the meeting; and
- (h) the Administration's response to the views raised by deputations at the meeting and concerns in their submissions.

(*Post-meeting note*: The Administration's written response was issued vide LC Paper No. CB(1)450/16-17(11) on 17 January 2017.)

		(a) the Government adopted a positive attitude towards a bottom-up approach in coming up with specific proposals for developing bazaars;	
		(b) when suitable sites had been identified by organizations for establishing bazaars and support from local communities and respective District Councils ("DCs") had been obtained, the Government would facilitate liaison with relevant bureaux and departments, provided that the bazaars would not compromise public order and safety, food safety and environmental hygiene and obstruct public passageways;

On enforcement actions against street hawking activities during the Lunar New Year, the Government reiterated that if the hawking activities involved selling of dry goods, verbal warning would be given to the hawkers concerned and dispersal action would be taken. However, if the hawking activities involved selling of cooked food, particularly using "naked flame" on crowded passageways, enforcement action would be taken. The Government noted a member's view that frontline enforcement officers should adopt a tolerating attitude towards street hawking activities during the Lunar New Year.
