## Subcommittee on Issues Relating to Bazaars Information and statistics related to hawker and hawker stall

As requested, the Government provides the following information –

1. Please provide the monthly statistics since the implementation of the Hawker Assistance Scheme

To reduce the fire risks posed by on-street hawking activities, the Government has implemented a five-year Hawker Assistance Scheme ("the Scheme") for licensed hawkers in 43 fixed-pitch hawker areas. Apart from relocating those hawker stalls situated directly in front of staircase discharge points of buildings or obstructing emergency vehicular access, we also provide a one-off grant to hawkers who are not required to relocate their stalls under the above arrangements for carrying partial or full reconstruction of their stalls in-situ to meet the prescribed fire-resisting specifications. Hawkers who opt for voluntary surrender of their hawker licences to the Government will be paid an ex-gratia payment. This helps expedite the release of vacant pitches and facilities the relocation of stalls which pose higher fire risks.

Some hawkers have taken this opportunity to reconstruct their hawker stall structures for attaining a higher fire safety standard. At the same time, this enhances the functionality and appearance of their stalls and improve thes overall layout and design of individual hawker areas. These also help enhance their operating environment. Some large hawker areas, e.g. Fa Yuen Street in Mong Kok, Apliu Street in Sham Shui Po and Jardine's Crescent in Wan Chai, have undergone a major revamp of hawker stalls. Please see Annex for the figures in connection with the implementation of the Scheme.

2. Please provide the plan and timetable for re-issue of hawker licences in respect of the vacant fixed pitches arising from the scheme

Under the Scheme, when hawkers surrender the licences and vacate the respective pitches, they will be granted an ex-gratia payment. The vacated pitches were used for relocating hawker stalls in front of staircase discharge points of buildings or obstructing the operation of emergency vehicles. In the process, the Department would also rationalise the layout of pitches in the hawker areas, bringing about a face-lift to the environment. We are monitoring closely the implementation of the relocation plans and the availability of vacant pitches, and consider the optimal time for conducting a review on whether or not to issue new on-street fixed-pitch hawker licences. During the review, we will take into account the circumstances of individual hawker areas, including their fire safety and environmental hygiene situations, the business environment, comments of relevant departments, as well as the views of the relevant District Councils and local residents.

3. Please provide the prosecution figures respectively for illegal hawkers and licenced hawkers for the past 5 years

For the past 5 years from 2012 to 2016, the number of prosecution cases for illegal hawkers and licenced hawkers respectively under FEHD are set out in the table below –
