## **Family Council**

Established in 2007, the Family Council (the Council) has been serving as a cross-sector and cross-bureau platform for examining family-related policies and promoting a culture of loving families in the community. Subsequent to a review in 2012-13, the Council was re-constituted under a non-official Chairman with effect from 1 April 2013 with a view to strengthening its advisory role. At present, there are 15 non-official members from different backgrounds; three ex-officio members (namely the Chairpersons of the Commission on Youth, Elderly Commission and Women's Commission); and four Government representatives (namely Secretary for Home Affairs, Secretary for Education, Secretary for Labour and Welfare and Head of the Central Policy Unit or their representatives). The current membership and the terms of reference of the Council are attached.

- 2. The work of the Council mainly includes the following three aspects
  - (a) advising Government bureaux and departments on the application of family perspectives in the policy formulation process;
  - (b) advocating cherishing the family and promoting family core values as a main driver for social harmony through organising various programmes and activities; and
  - (c) conducting researches and surveys to foster a better understanding of the issues relating to the family.
- 3. The Council briefs Members of the Panel on Welfare Services on the progress of its work on a biennial basis. Since the previous briefing on 13 June 2016, the Council has continued to collaborate with various sectors in the community to enhance the functions of families and create a pro-family environment.

# Terms of Reference of the Family Council

- (a) To advocate for cherishing the family as a main driver for social harmony; and to promote a family-based support network to forge closer and harmonious relationships amongst family members;
- (b) To advise the Government on the formulation of policies and strategies for supporting and strengthening the family and on development of related programmes/activities; and to monitor their implementation;
- (c) To advise the Government on the integration of family policies and related programmes across different bureaux and departments for individual age and gender sectors to ensure effective coordination;
- (d) To plan/implement programmes and activities for particular age and/or gender sectors; and rationalise the work of the Elderly Commission, the Women's Commission and the Commission on Youth; and
- (e) To initiate research to promote better understanding of matters related to the family as necessary.
