1. Issues relating to the relocation of Yen Chow Street Temporary Hawker Bazaar

December 2016

At the meeting on 18 October 2016, the Chairman suggested that the Panel should discuss issues relating to the relocation of Yen Chow Street Temporary Hawker Bazaar and deputations should be invited to give views on the subject.

At the meeting between the Chairman, the Deputy Chairman and the Secretary for Food and Health to discuss the work plan of the Panel for the 2016-2017 session ("the work plan meeting") held on 31 October 2016, it was agreed that the item be placed on the agenda for the regular meeting in December 2016.

2. Working environment of outsourced cleansing workers of the Food and Environmental Hygiene Department

December 2016

At the work plan meeting on 31 October 2016, the Chairman expressed concern that it was reported by the media that outsourced cleansing workers of the Food and Environmental Hygiene Department ("FEHD") had to change their uniforms and take rest breaks in outdoor areas. It was agreed that FEHD's current arrangements on providing venues for changing facilities and breaks for outsourced cleansing workers be discussed at the Panel meeting in December 2016.

3. Site formation and associated infrastructural works for development of columbarium at Sandy Ridge Cemetery

December 2016

Item proposed by the Administration.

The Administration plans to brief the Panel on the subject in December 2016.

4. Creation of a directorate post in Food and Health Bureau for handling duties under the food safety portfolio

December 2016

Item proposed by the Administration.

The Administration plans to consult the Panel on the above staffing proposal in December 2016.

5. Regulation of animal feed for livestock and cultured fish and the presence of veterinary drug residues

December 2016/ January 2017

At the meeting on 15 October 2015, Dr Hon Helena WONG expressed concerns about the regulation of animal feed for livestock and cultured fish and the presence of veterinary drug residues, including antibiotics, in meat and aquatic products for human She considered that the Panel should consumption. discuss these issues at a Panel meeting. In her letter dated December 2015 (LC Paper CB(2)422/15-16(01)), Dr WONG reiterated her concerns and requested early discussion of the item. (Please also see item 6 below.)

Proposed timing for discussion

6. Public consultation on the proposed regulatory framework governing veterinary drug residues in food and food animals

December 2016/ January 2017

According to the Administration, it is considering measures to strengthen control over veterinary drug residues in food and food animals in order to enhance food safety and it plans to launch a public consultation on the proposed regulatory framework in due course.

At the meeting on 18 October 2016, the Chairman and Dr Hon Pierre CHAN considered that arrangements should be made by the Administration for early discussion of items relating to veterinary drug residues (i.e. items 5 and 6).

At the work plan meeting on 31 October 2016, the Administration agreed to provide an information paper on its work on these fronts by end of December 2016. Members will be invited to consider the need of discussing items 5 and 6 as a combined item (e.g. "Use of veterinary drugs in food animals and cultured fish and surveillance of veterinary drug residues in food and food animals" as previously suggested by the Administration) at a meeting, after the Administration's provision of the information paper.

7. Annual report regarding the dialogue between the Secretary for Food and Health and the District Councils ("DCs")/the Environmental Hygiene Committees under DCs on matters related to keeping Hong Kong clean

January 2017

Item proposed by the Administration.

The Administration plans to report on the subject matter in January 2017.

Proposed timing for discussion

8. Enhanced mosquito prevention and control measures in face of threats from Zika Virus Infection

January 2017

Item proposed by the Administration.

The Administration plans to brief the Panel on the subject matter in January 2017.

9. Implementation of the Demerit Points System for licensed food premises

January 2017

At the work plan meeting on 31 October 2016, the Chairman expressed concern about the implementation of the Demerit Points System by FEHD. It was proposed that the subject be scheduled for discussion at the Panel meeting in January 2017.

10. Update on the use of the bivalent avian influenza vaccine in local chicken farms

January 2017

Item proposed by the Administration.

The Administration plans to report on the subject matter in January 2017.

11. Provision and management of public markets

January 2017

The Subcommittee on Issues Relating to Public Markets formed under the Panel in the Fifth Legislative Council ("LegCo") had completed its work. During the course of deliberations, the Subcommittee made a number of recommendations for enhancing the operating environment and business competitiveness of public markets (please refer to paragraph 36 of the Subcommittee's report (LC Paper No. CB(2)2142/14-15(01)) for details). In recommending that the Panel should follow up with the Administration

the various issues raised therein, the Subcommittee specifically requested the Administration to consult the Panel on its proposals, if any, for rental adjustment mechanism for public market stalls in the first quarter of 2017 at the latest (paragraph 31 of the report refers).

In her letter dated 2 November 2015 (LC Paper No. CB(2)201/15-16(01)), Hon Alice MAK expressed concern about the lack of public markets in newly developed districts. Hon MAK considered that the Administration should comprehensively review its policy in respect of the planning and provision of public markets in Hong Kong and suggested that the matter be discussed by the Panel.

At the meeting on 18 October 2016, Hon Michael TIEN considered that the Administration should report to the Panel on its progress in following up the recommendations made in the Subcommittee's report. Hon Jeremy TAM considered that the Administration should also update members on its progress in following up the recommendations of the consultancy study on improving the operating environment of public markets. Hon Andrew WAN also expressed concern about the cessation of construction of public markets by the Administration.

On 20 October 2016, Hon Andrew WAN wrote to the Chairman requesting for discussion at the Panel meeting on 8 November 2016 of his proposal for setting up a subcommittee to study issues relating to public markets and bazaars. It was agreed in principle at the work plan meeting on 31 October 2016 that the subcommittee proposed by Hon WAN, if appointed, should take up relevant issues, including the provision and management of public markets. (Please refer to Hon WAN's letter dated 2 November 2016 (LC Paper No. CB(2)99/16-17(01)) for his revised proposal on setting up under the Panel a subcommittee on policy issues.)

Proposed timing for discussion

12. Retrofitting of air conditioning in public markets

January 2017

At the meeting on 18 October 2016, Hon LEUNG Che-cheung expressed a wish that the Administration should review the threshold for retrofitting air-conditioning systems in existing public markets and provide an update on the installation progress of air-conditioning systems in various public markets.

It was agreed in principle at the work plan meeting on 31 October 2016 that the subcommittee proposed by Hon Andrew WAN, if appointed, should take up this matter as well.

13. Report on the Food Surveillance Programme for 2016

February 2017

Item proposed by the Administration.

The Administration proposed to report on the subject in February 2017. (Please also see items 14 and 15 below.)

14. Regulating activities of vegetable smuggling and reviewing the standards of pesticide residues in food

February 2017

At the meeting on 18 October 2016, the Chairman suggested discussing at a future meeting the feasibility of regulating activities of vegetable smuggling as well as reviewing the standards of pesticide residues in food and the existing mechanism for determining the maximum residue limits and extraneous maximum residue limits under the Pesticide Residues in Food Regulation (Cap. 132CM).

At the work plan meeting on 31 October 2016, the Administration agreed to update members on the current position of the above subjects when reporting on the Food Surveillance Programme for 2016.

15. Issues relating to food safety

February 2017

At the meeting on 18 October 2016, Dr Hon KWOK Ka-ki expressed concern about the co-operation agreement signed by the Centre for Food Safety ("CFS") of FEHD and the Shenzhen Entry-Exit Inspection and Quarantine Bureau in April 2016 and the role of CFS in ensuring food safety under the new arrangement. At the work plan meeting on 31 October 2016, the Administration was requested to provide an information paper by end of January 2017 on the co-operation agreement on inspection and quarantine arrangement at Qianhai to facilitate members' consideration of whether the matter should be further discussed by the Panel at the February regular meeting.

Dr KWOK also requested at the meeting on 18 October 2016 that the Administration should be requested to liaise with the Mainland authorities to make arrangements for members to visit registered farms in the Guangdong Province to better understand the regulation and operation of those registered farms which supplied food to Hong Kong. At the work plan meeting on 31 October 2016, the Administration undertook to relay Dr KWOK's request to the Mainland authorities for consideration.

16. Public Consultation on the way forward for the live poultry trade

March 2017

Item proposed by the Administration.

At the meeting on 18 October 2016, the Chairman suggested that the Panel should follow up with the Administration on the outcome of the consultancy study on the future of the live poultry trade. The Administration plans to brief the Panel on the subject in March 2017. (Please also see item 17 below.)

Proposed timing for discussion

17. Wholesale market consultancy study

March 2017

At the meeting on 10 June 2014, members noted that the Administration had commissioned a consultant to study the present-day functions and purpose of the wholesale business in the sale of fresh food produce, and analyze the geographical spread of the five existing wholesale markets from the perspective of land use and food safety. The Administration undertook to revert to the Panel when the outcome of the consultancy study was ready. At the meeting on 15 October 2015, Hon Steven HO expressed a wish that arrangements be made for early discussion of this subject.

At the work plan meeting on 31 October 2016, the Administration was requested to update members on the latest progress of the wholesale market consultancy study, in particular the feasibility study on relocating Cheung Sha Wan Temporary Wholesale Poultry Market and Yau Ma Tei Fruit Market, when reporting to the Panel on the public consultation on the way forward for the live poultry trade (item 16 above refers).

18. Regulating the production of organic food

March 2017

At the meeting on 18 October 2016, the Chairman suggested discussing the regulation of the production of organic food and certification of organic food products at a future meeting. At the work plan meeting on 31 October 2016, the Administration was requested to brief members on the subject matter in March 2017.

19. Public consultation on the proposed regulation of heavy metals in food

March 2017

At the meeting on 9 October 2014, Dr Hon Helena

WONG expressed concern about the safety standards for heavy metals in food and urged the Administration to review the relevant legislation for regulating the presence of heavy metals in food. She hoped that the Panel would discuss the subject matter at a Panel meeting. She reiterated her concern about the need for reviewing the Food Adulteration (Metallic Contamination) Regulations (Cap. 132V) at the meeting on 18 October 2016.

Noting that the Administration plans to launch a public consultation, at the work plan meeting on 31 October 2016, the Chairman requested the Administration to brief the Panel on the subject matter in March 2017.

20. Implementation of the Nutrition Labelling Scheme

March 2017

Item proposed by the Administration.

The Administration plans to brief the Panel on the subject in March 2017.

21. Implementation of the Convention on the Conservation of Antarctic Marine Living Resources in Hong Kong

2nd quarter of 2017

Item proposed by the Administration.

At the meeting on 11 March 2014, members were briefed on the Administration's proposal to introduce a control scheme for the trading of toothfish by way of a piece of legislation for the implementation of the Convention on the Conservation of Antarctic Marine Living Resources in Hong Kong. Members noted that the Administration would engage relevant stakeholders (including seafood traders and importers) and seek their views on the proposed control scheme.

Proposed timing for discussion

The Administration plans to brief the Panel on the subject in the second quarter of 2017.

22. Review of fees for liquor licences

2nd quarter of 2017

Item proposed by the Administration.

At the work plan meeting on 31 October 2016, the Administration was requested to brief the Panel on the results of its review on the fees for liquor licences in the second quarter of 2017.

23. Liquor licensing system in Hong Kong and regulation of upstairs bars

2nd quarter of 2017

At the meeting on 10 October 2013, Dr Hon Priscilla LEUNG expressed concern about problems caused by upstairs bars and the Liquor Licensing Board's considerations in assessing liquor licence applications from them. She suggested the Panel continue to follow up the subject.

At the meeting on 8 April 2014, members noted the research report on "Liquor licensing system in selected places" prepared by Research Office, Information Services Division of the LegCo Secretariat. Hon Tommy CHEUNG suggested the Panel discuss the subject of liquor licensing system in Hong Kong and invite deputations from the trade concerned to give views at a future meeting.

At the work plan meeting on 31 October 2016, the Administration was requested to report to the Panel on the subject in the second quarter of 2017.

Proposed timing for discussion

24. Reduction of sugar and salt content in food

2nd quarter of 2017

Item proposed by the Administration.

The Administration plans to update the Panel on the relevant work of the Government in reducing sugar and salt content in food in the second quarter of 2017.

25. Government Laboratory's work in respect of food safety and other services

2nd quarter of 2017

Item proposed by the Administration.

The Administration plans to brief the Panel on the subject in the second quarter of 2017.

26. Implementation of the Food Safety Ordinance

2nd quarter of 2017

Item proposed by the Administration.

The Administration plans to update the Panel on the subject in the second quarter of 2017. (Please also see item 27 below.)

27. Outcome of the comprehensive review of the food-safety related penalties

2nd quarter of 2017

Having regard to the views of the members of the Subcommittee on Food and Drugs (Composition and Labelling) (Amendment) (No. 2) Regulation 2014, the Administration undertook to conduct a comprehensive review of the food safety-related penalties under the Public Health and Municipal Services Ordinance (Cap. 132) and its subsidiary legislation, as well as the Food Safety Ordinance (Cap. 612) ("FSO") in 2015. The Administration also agreed to report the outcome of the study to the Panel. (Paragraphs 29 and

30 of the Subcommittee's report (LC Paper No. CB(2)256/14-15) refers.)

The Subcommittee on Three Regulations Relating to Control Regime for the Import of Eggs also proposed that the Administration should report the progress of the review to the Panel (please see paragraphs 24 to 26 of its report (LC Paper No. CB(2)2123/14-15) for details).

At the work plan meeting on 31 October 2016, the Administration was requested to update members on the progress of its review when reporting to the Panel on the implementation of FSO in the second quarter of 2017 (item 26 above refers).

28. Update on Best Practices on Cooking Oils in Use

2nd quarter of 2017

Item proposed by the Administration.

The Administration plans to brief the Panel on the subject in the second quarter of 2017.

29. Rodent prevention and control measures

2nd quarter of 2017

Item proposed by the Administration.

The Administration plans to brief the Panel on the subject in the second quarter of 2017.

30. Policies on promoting the development of the agricultural and fisheries industries

2nd quarter of 2017

At the meeting on 18 October 2016, Hon Steven HO suggested that the Panel should follow up with the Administration on the following issues:

(a) the Government's proposals of establishing an

Agricultural Park and designating "Agricultural Priority Areas" under the New Agriculture Policy;

- (b) the impact of the changes to the fisheries policy of the Mainland (e.g. the implementation of the annual fishing moratorium in the South China Sea and the provision of fuel subsidy to fishermen by the Mainland authorities) on the Government's implementation of various loan schemes for local fishermen; and
- (c) the assistance provided for fish farmers affected by natural disasters.

Regarding (a), the Administration proposed at the work plan meeting on 31 October 2016 to report to the Panel on the progress of initiatives under the New Agriculture Policy in the second quarter of 2017.

Regarding (b) and (c), the Administration will brief the Panel on the matters when ready.

31. Issues relating to animal welfare

2nd quarter of 2017

At the meeting on 9 December 2014, members noted the letter from Hon Claudia MO expressing concern about the import and sale of products made with fur of dogs and cats as well as the Administration's response to her letter (LC Paper Nos. CB(2)408/14-15(01) and (02)). At the request of Hon MO, members agreed that the subject be included in the list of outstanding items for discussion.

The Subcommittee on Issues Relating to Animal Welfare and Cruelty to Animals formed under the Panel in the Fifth LegCo had completed its work and made a number of recommendations for enhancing animal welfare and combating acts of animal cruelty (please refer to paragraph 37 of the Subcommittee's

report (LC Paper No. CB(2)1704/15-16) for details). The Subcommittee also recommended that the Panel should follow up with the Administration the issues raised during the deliberations of the Subcommittee.

At the meeting on 18 October 2016, Hon Michael TIEN requested the Administration to report to the Panel its progress in following recommendations made by the Subcommittee. Chairman also considered that the Panel should continue to follow up the safety of pet food with the Hon KWONG Chun-yu and Hon Administration. Claudia MO shared the view that the Administration should consider reviewing relevant legislation to afford better protection to animals and setting up animal police teams to investigate into cases of animal cruelty and abandonment.

On 18 October 2016, Hon Claudia MO wrote to the Chairman requesting for discussion at the November meeting of her proposal for setting up a subcommittee under the Panel to study issues relating to animal rights. It was agreed in principle at the work plan meeting on 31 October 2016 that the subcommittee proposed by Hon MO, if appointed, should take up the above issues relating to animal rights.

32. Public consultation on the proposed regulation of cooked meat

At the special meeting on 3 September 2014, members expressed concern about inadequate regulation of cooked meat and considered that the subject should be followed up by the Panel. The Administration advised that it would review the relevant legislation and seek the views of LegCo Members and the trade.

At the meeting on 9 October 2014, Dr Hon Helena WONG hoped that the Administration would brief the

Panel as early as possible on the progress of the review on legislation relating to the regulation of cooked meat. At the meeting on 18 October 2016, she reiterated her concern and requested that the Administration should report to the Panel on the subject.

33. Consultation results of the proposed introduction of the pre-market safety assessment on genetically-modified food

34. Ancillary facilities for storage and distribution of chilled meat and poultry

At the meeting on 9 October 2014, Hon Michael TIEN expressed concern about the lack of ancillary facilities for wholesaling of chilled meat and poultry. He pointed out that the trade had made repeated requests for the setting up of an approved distribution and storage centre by the Government for the chilled meat and poultry with a view to reducing food safety risks. He hoped that the Panel would follow up the subject matter.

At the meeting on 15 October 2015, Hon Steven HO and Hon Michael TIEN both expressed concern about the slow progress of the Administration in taking forward the initiative of setting up an approved distribution and storage centre for chilled meat and poultry. They requested for early discussion of the subject matter by the Panel.

Proposed timing for discussion

35. Regulating and monitoring the activities of oyster culture in Hong Kong

To be confirmed

At the meeting on 9 February 2010, in the light of the concerns raised by Hon WONG Yung-kan, a suggestion was made that the issue of regulating and monitoring the activities of oyster culture within Hong Kong waters should be discussed by the Panel at a future meeting.

During the discussion of the implementation of FSO at the meeting on 11 July 2012, Hon WONG Yung-kan expressed worry about the over-expansion of oyster culture in Shenzhen Bay. He urged the Administration to step up the regulatory measures for oyster culture, including the introduction of a licensing mechanism.
