Council meeting of 6 December 2017

**Proposed resolutions under Article 75 of the Basic Law
to amend the Rules of Procedure**

Members have been informed vide LC Paper No. CB(3) 176/17-18 that 12 Members will move a total of 12 proposed resolutions which comprise 49 proposals to amend the Rules of Procedure (“RoP”) of the Legislative Council at the above meeting.

2. Members are invited to note that 22 Members have given separate notice to move a total of 88 amending motions to 10 of the above 12 proposed resolutions. The President has ruled that 23 amending motions are admissible¹ as follows:

- (a) in accordance with RoP 30(3)(a), the President has directed that 17 of the 23 admissible amending motions be printed in the terms in which they were handed in on the Agenda of the Council (**4th to 7th, 9th, 10th, 11th, 13th, 14th, 15th and 17th to 23rd amending motions in the Appendix**); and
- (b) under RoP 30(3)(b), the President has directed that six amending motions be printed on the Agenda of the Council with such alterations as he has directed (**1st, 2nd, 3rd, 8th, 12th and 16th amending motions in the Appendix**).
