LC Paper No. COA 1/17-18 invited nomination of Members for election to the Committee on Access to the Legislature's Documents and Records ("CoA") to be held at the House Committee meeting on 27 October 2017.

2. In accordance with Rule 74A(2)(d) of the Rules of Procedure ("RoP"), the maximum number of Members to be elected to CoA shall be 10. The following 10 nominations were received by 23 October 2017, i.e. the deadline for nomination:

In accordance with the nomination and election procedure endorsed by the House Committee at its meeting on 28 March 2014, no poll needs to be taken at the House Committee meeting on 27 October 2017 for election to CoA as the number of nominations received is equal to the maximum number of members to be elected. The Chairman of the House Committee shall declare the nominees duly elected.

4. The term of office of the elected members to CoA, under Rule 74A(3) of RoP, will be one year or until the next House Committee meeting held for the election of members, whichever is the earlier.
