| <p>Hon Jeremy TAM Man-ho wrote to the Panel on 24 October 2016 (LC Paper No. CB(4)27/16-17(02)) proposing to discuss the regulation of unmanned aircraft systems ("UAS").</p> <p>The Administration will update the Panel on the results of the consultancy studies on reviewing the existing regulatory framework for the operation of UAS commissioned by the Civil Aviation Department.</p> | |

| <p>Pursuant to the Scheme of Control Agreements with the two power companies, a tariff review will be conducted by the Government and the respective power company towards the end of each year. The two power companies will announce their tariff for 2018 after the review and explain their cases to the Panel if there is any adjustment.</p> | |

- 4. Proposed making of the subsidiary legislation under Merchant Shipping (Safety) Ordinance (Cap. 369), Merchant Shipping (Prevention and Control of Pollution) Ordinance (Cap. 413) and Merchant Shipping (Seafarers) Ordinance (Cap. 478) for implementation of the International Code for Ships Operating in Polar Waters ("Polar Code") of IMO** January 2018

The Administration will seek the Panel's endorsement on the legislative proposal to incorporate requirements relating to safety, environmental protections and seafarers' qualifications under the Polar Code into local legislation, with a view to regulating navigation in waters surrounding the two poles.

- 5. Update on the tendering system for petrol filling station sites and follow-up to the auto fuel study conducted by the Competition Commission** January or
February 2018

Hon James TO Kun-sun, Hon WU Chi-wai and Hon Andrew WAN Siu-kin jointly wrote to the Panel on 31 May 2017 (LC Paper No. CB(4)1137/16-17(01)) proposing to discuss the Government's review of the tendering system for petrol filling station sites and its exploration of various structural reform options to further competition in the auto-fuel market. The Administration's response to the letter has been circulated to members via LC Paper No. CB(4)1265/16-17(01).

7. Hong Kong Tourism Board Work Plan for 2018-2019

February 2018

The Hong Kong Tourism Board will present its work plan for 2018-2019, and brief the Panel on the overview of Hong Kong tourism industry in 2017 and the outlook of 2018.

8. Proposed making and amending of the subsidiary legislation under the Merchant Shipping (Safety) Ordinance (Cap. 369) and the Merchant Shipping (Seafarers) Ordinance (Cap. 478) for implementation of SOLAS and the International Convention on Standards of Training, Certification and Watchkeeping for Seafarers ("STCW Convention") of IMO

March 2018

The Administration will seek Panel's endorsement on proposed legislative amendments to implement –

- (i) the latest requirements under SOLAS governing the construction and survey, as well as the requirements on fire protection and firefighting appliances of ships; and
- (ii) the latest requirements governing the training and qualifications of seafarers on ships using low flashpoint fuels under the STCW Convention.

9. Report on the work of the Competition Commission

March 2018

At the work plan meeting on 2 November 2017, Hon Alvin YEUNG proposed to discuss the update on implementation of the Competition Ordinance (Cap. 619) on a yearly basis. The Competition Commission will brief the Panel on its progress in implementing the Competition Ordinance in March 2018.

10. Combating against drink and drug boating

The Administration will seek the Panel's endorsement on the legislative proposal to combat drink and drug boating for enhancing marine safety.

The Administration will seek the Panel's support for creating two directorate posts in the Civil Aviation Department in support of the three-runway system ("3RS") project at the Hong Kong International Airport ("HKIA").

12. Update on the development of the three-runway system at the Hong Kong International Airport

April or May 2018

At the Panel meeting on 12 October 2017, Hon Jeremy TAM Man-ho proposed to discuss the 3RS development, including the construction progress and project expenditure, on a yearly basis. He also requested the Administration/Airport Authority Hong Kong to provide a progress report every half-year on this subject.

13. Further development of Hong Kong's port

June or July 2018

At the Panel meeting on 12 October 2017, Hon Claudia MO proposed to discuss the further development of the Hong Kong's port to sustain its competitiveness.

Marine Department in relation to the Vessel Collision Incident near Lamma Island on 1 October 2012 ("the Report"). As new Panel members might not be fully aware of the issue, arrangements should be made by the Administration to again make available the Report for Panel members' perusal.

The Administration has made arrangements similar to that in 2015 for Legislative Council Members to peruse the redacted Report at a designated venue under a confidentiality agreement. Hon James TO Kun-sun wrote to the Panel on 26 June 2017 (LC Paper No. CB(4)1316/16-17(01)) requesting the Panel to discuss the Report.

At the Panel meetings on 12 and 30 October 2017, Hon James TO Kun-sun requested for early discussion of this subject. At the work plan meeting on 1 November 2017, the Administration agreed to provide a written response in this regard.

16. Imposition of a mandatory cooling-off period for consumer contracts

At the Panel meeting on 18 October 2016, Hon Andrew WAN, Dr Hon Helena WONG Pik-wan and Hon Michael TIEN Puk-sun proposed to discuss the imposition of a mandatory cooling-off period for consumer contracts and relevant measures to enhance consumer protection. Hon Andrew WAN Siu-kin also proposed to discuss matters relating to the scope and operation of the Consumer Legal Action Fund.

Dr Hon Elizabeth QUAT and Hon LUK Chung-hung raised similar requests in their letters to the Panel dated 20 October and 25 October 2016 respectively (LC Paper Nos. CB(4)27/16-17(01) and CB(4)38/16-17(01)).

At the work plan meeting on 2 November 2016, the Administration advised that the Consumer Council was conducting a research study concerning cooling-off period. The Administration will brief the Panel on the outcome of the study in due course.

Hon LUK Chung-hung wrote to the Panel on 28 March 2017 (LC Paper No. CB(4)777/16-17(01)) proposing discussion on the subject after the completion of the review on the arrangements for the supply of centralized LPG to public housing estates.

The Administration is reviewing the prevailing arrangements for renewing contracts for the supply of centralized LPG to existing public housing estates and will brief the Panel on the outcome after completion of the review.

18. Reform of regulatory regime for pleasure vessels

The information provided by the Administration on this subject is set out in LC Paper Nos. CB(4)1280/16-17(02) and CB(4)1301/16-17(01).

At the Panel meeting on 12 October 2017, Hon Starry LEE Wai-king proposed to arrange a joint duty visit with the Panel on Financial Affairs to the Bay Area to better understand the economic and financial initiatives brought by this development plan.

22. Proposed Member's Bill to amend the Electricity Ordinance (Cap. 406)

Hon LUK Chung-hung wrote to the Panel on 11 October and 15 November 2017 (LC Paper Nos. CB(4)36/17-18(01) and CB(4)222/17-18(01)) requesting to discuss a proposed Member's Bill to amend the Electricity Ordinance (Cap. 406) to impose restrictions for resale of electricity to a third party, with a view to avoiding landlords of sub-divisions of flat units overcharging their tenants on the use of electricity. At the work plan meeting on 2 November 2017, the Administration agreed to provide a written response in this regard.
