5. Proposed creation of two directorate posts in the Civil Aviation Department in support of the three-runway system project at the Hong Kong International Airport

May 2018

The Administration will seek the Panel's support for creating two directorate posts in the Civil Aviation Department in support of the 3RS project at the Hong Kong International Airport.

6. Proposed making and amending of the subsidiary legislation under the Merchant Shipping (Prevention and Control of Pollution) Ordinance (Cap. 413) and Merchant Shipping (Seafarers) Ordinance (Cap. 478), and amending the Freight Containers (Safety) Ordinance (Cap. 506), for implementation of the International Convention for the Prevention of Pollution from Ships ("MARPOL"), the International Convention on Standards of Training, Certification and Watchkeeping for Seafarers ("STCW Convention") and the International Convention for Safe Containers ("CSC") of IMO

June 2018

The Administration will seek Panel's endorsement on proposed legislative amendments to implement –

- (i) the latest requirements under MARPOL for data collection of fuel oil consumption and recording engine operation status within specified areas;
- (ii) the latest requirements governing the training and qualifications of seafarers on passenger ships and ships using low flashpoint fuels under the STCW Convention; and
- (iii) the latest requirements governing the safety of handling, stacking and weighing of freight containers under CSC.

7. **Proposed amendments to Merchant Shipping (Local Vessels) (General) Regulation (Cap. 548F) and Merchant Shipping (Local Vessels) (Safety and Survey) Regulation (Cap. 548G)** June 2018

The Administration will seek Panel's endorsement on the proposed legislative amendments to strengthen the requirements on provision of lifejackets on local vessels and to implement safety measures during major events at sea.

8. **Further development of Hong Kong's port** June or July 2018

At the Panel meeting on 12 October 2017, Hon Claudia MO proposed to discuss the further development of the Hong Kong's port to sustain its competitiveness.

9. **Update on the tendering system for petrol filling station sites and follow-up to the auto fuel study conducted by the Competition Commission** July 2018

Hon James TO Kun-sun, Hon WU Chi-wai and Hon Andrew WAN Siu-kin jointly wrote to the Panel on 31 May 2017 (LC Paper No. CB(4)1137/16-17(01)) proposing to discuss the Government's review of the tendering system for petrol filling station sites and its exploration of various structural reform options to further competition in the auto-fuel market. The Administration's response to the letter has been circulated to members via LC Paper No. CB(4)1265/16-17(01).

10. **Combating drink and drug boating** July 2018

The Administration will seek the Panel's endorsement on the legislative proposal to combat drink and drug boating for enhancing marine safety.

At the Panel meeting on 18 October 2016, Hon James TO Kun-sun proposed to discuss the Report of the Transport and Housing Bureau's Investigation into Staff Conduct in the Marine Department in relation to the Vessel Collision Incident near Lamma Island on 1 October 2012 ("the Report"). As new Panel members might not be fully aware of the issue, arrangements should be made by the Administration to again make available the Report for Panel members' perusal.

The Administration has made arrangements similar to that in 2015 for Legislative Council ("LegCo") Members to peruse the redacted Report at a designated venue under a confidentiality agreement from April to May 2017. Hon James TO Kun-sun wrote to the Panel on 26 June 2017 (LC Paper No. CB(4)1316/16-17(01)) requesting the Panel to discuss the Report.

At the Panel meetings on 12 October, 30 October, 12 December 2017 and 22 January 2018, Hon James TO Kun-sun requested for early discussion of this subject. The Administration's responses on this subject are set out in LC Paper Nos. CB(4)285/17-18(01) and CB(4)453/17-18(01).

Hon Holden CHOW Ho-ding wrote to the Panel on 25 January 2018 (LC Paper No. CB(4)536/17-18(01)) requesting the Administration to make arrangements again for LegCo Members to peruse the redacted version of the Report under a confidentiality undertaking. The Administration has been requested to provide a response to the letter.

12. Imposition of a mandatory cooling-off period for consumer contracts

At the Panel meeting on 18 October 2016, Hon Andrew WAN, Dr Hon Helena WONG Pik-wan and Hon Michael TIEN Puk-sun proposed to discuss the imposition of a mandatory cooling-off period for consumer contracts and relevant

measures to enhance consumer protection. Hon Andrew WAN Siu-kin also proposed to discuss matters relating to the scope and operation of the Consumer Legal Action Fund.

Dr Hon Elizabeth QUAT and Hon LUK Chung-hung raised similar requests in their letters to the Panel dated 20 October and 25 October 2016 respectively (LC Paper Nos. CB(4)27/16-17(01) and CB(4)38/16-17(01)).

At the work plan meeting on 2 November 2016, the Administration advised that the Consumer Council was conducting a research study concerning cooling-off period. The Administration will brief the Panel in due course.

13. Arrangements for the supply of centralized liquefied petroleum gas ("LPG") to existing public housing estates

At the Panel meeting on 18 October 2016, Dr Hon Helena WONG Puk-sun proposed to discuss the competition situation of the prices of domestic liquefied petroleum gas.

Hon LUK Chung-hung wrote to the Panel on 28 March 2017 (LC Paper No. CB(4)777/16-17(01)) proposing discussion on the subject after the completion of the review on the arrangements for the supply of centralized LPG to public housing estates.

The Administration provided information on the Hong Kong Housing Authority's new arrangements following a review for the supply of centralized LPG to public housing estates after expiry of the existing contracts on 21 December 2017 (LC Paper No. CB(4)397/17-18(01)).

14. Issues relating to online consumers' rights and interests

16. Development of the Guangdong-Hong Kong-Macao Bay Area in respect of the tourism, shipping and logistics, and value-added service industries

Hon Holden CHOW Ho-ding wrote to the Panel on 24 May 2017 (LC Paper No. CB(4)1280/16-17(01)) requesting information and discussion on the tourism, shipping and logistics, as well as value-added service industries in the Guangdong-Hong Kong-Macao Bay Area ("the Bay Area"). The information provided by the Administration on this subject is set out in LC Paper Nos. CB(4)1280/16-17(02) and CB(4)1301/16-17(01).

At the Panel meeting on 12 October 2017, Hon Starry LEE Wai-king proposed to arrange a joint duty visit with the Panel on Financial Affairs to the Bay Area to better understand the economic and financial initiatives brought by this development plan. The Chairman has written to the Secretary for Constitutional and Mainland Affairs seeking his assistance in this respect.

17. Proposed Member's Bill to amend the Electricity Ordinance (Cap. 406)

Hon LUK Chung-hung wrote to the Panel on 11 October, 15 November 2017 and 8 January 2018 (LC Paper Nos. CB(4)36/17-18(01), CB(4)222/17-18(01) and CB(4)464/17-18(01)) requesting to discuss a proposed Member's Bill to amend the Electricity Ordinance (Cap. 406) to impose restrictions for resale of electricity to a third party, with a view to avoiding landlords of sub-divisions of flat units overcharging their tenants on the use of electricity. The Administration's response is set out in LC Paper No. CB(4)409/17-18(01). At the Panel meeting on 22 January 2018, Hon LUK Chung-hung requested for early discussion of this subject.
