Subject

At the meeting on 11 March 2014, members were briefed on the Administration's proposal to introduce a control scheme for the trading of toothfish by way of a piece of legislation for the implementation of the Convention on the Conservation of Antarctic Marine Living Resources in Hong Kong. Members noted that the Administration would engage relevant stakeholders, including seafood traders and importers, and seek their views on the proposed control scheme.

The relevant bill (i.e. Conservation of Antarctic Marine Living Resources Bill) has been included in the 2017-2018 Legislative Programme provided by the Administration on 13 October 2017. The Administration has indicated its intention to introduce into the Council the bill in the second half of the 2017-2018 legislative session. It also plans to brief the Panel on the subject in April 2018 after completion of the consultation with the trade in March.

6. Policy initiatives related to land premium and traffic impact assessment issues of pre-cut-off columbaria

At the meeting on 12 December 2017, the Panel was briefed on the Administration's work progress in relation to the implementation of the Private Columbaria Ordinance (Cap. 630) ("the Ordinance") in the initial six-month period following enactment, including the two policy initiatives to address the land premium and traffic impact assessment issues of

pre-cut-off columbaria seeking a licence under the Ordinance. There was a suggestion that the Panel should hold a public hearing to receive public views on the two policy initiatives.	

In its supplementary paper submitted to the Panel on 5 January 2018 responding to key issues of concern to members raised at the meeting in December 2017 (LC Paper No. CB(2)645/17-18(01)), the Administration proposed that the Panel might consider holding the public hearing in or after April 2018, as the status on the applications for specified instruments received by the Private Columbaria Licensing Board would be better known after 29 March 2018 (i.e. the deadline for pre-cut-off columbaria to submit their applications). Having considered the Administration's response, members agreed to schedule the public hearing in late April 2018 or shortly afterwards.

8. Government's policy on bazaar activities

9. Outcome of the review of food-safety related penalties	2 nd quarter of 2018
<p>Having regard to the views of the members of the Subcommittee on Food and Drugs (Composition and Labelling) (Amendment) (No. 2) Regulation 2014, the Administration undertook to conduct a review of the food safety-related penalties under the Public Health and Municipal Services Ordinance (Cap. 132) and its subsidiary legislation, as well as the Food Safety Ordinance (Cap. 612) ("FSO"). The Administration agreed to report to the Panel on the outcome of the review (paragraphs 29 and 30 of the Subcommittee's report (LC Paper No. CB(2)256/14-15) refers).</p> <p>The Subcommittee on Three Regulations Relating to Control Regime for the Import of Eggs also proposed that the Administration should report the progress of the review to the Panel (paragraphs 24 to 26 of its report (LC Paper No. CB(2)2123/14-15) refers).</p> <p>The Administration has advised that it would brief members on its review of the maximum levels of penalties of offences under FSO and its subsidiary legislation in the second quarter of 2018.</p>	
10. Food safety surveillance mechanism for imported food	2 nd quarter of 2018
<p>On 9 October 2017, the Administration provided an information paper entitled "Food Safety Surveillance Mechanism for Imported Food" (LC Paper No. CB(2)2188/16-17(01)) for members' reference. At the meeting on 12 October 2017, Hon Helena WONG requested the Administration to brief members on the content of the Administration's paper which covered the developments of the incident concerning the quality of Brazilian frozen and chilled meat and poultry meat and the follow-up actions taken by CFS in response to the incident of suspicious health</p>

11. Outcome of the Trap-Neuter-Return Trial Programme for Stray Dogs	2 nd quarter of 2018

The Administration plans to brief the Panel on the outcome of the trial programme in the second quarter of 2018.	
12. Liquor licensing system in Hong Kong: enhancement measures	2 nd quarter of 2018
Dr Hon KWOK Ka-ki proposed in his letter dated 27 October 2017 (LC Paper No. CB(2)178/17-18(01)) and at the Panel meeting on 14 November 2017 early discussion on the composition and operation of the Liquor Licensing Board. The Administration's response (LC Paper No. CB(2)290/17-18(01)) to issues and concerns raised in Dr KWOK's letter was issued on 14 November 2017.	
At the meeting on 10 October 2013, concerns were raised about the nuisances caused by upstairs bars and the Liquor Licensing Board's considerations in assessing liquor licence applications from these establishments. It was suggested that the Panel should follow up the subject.	
At the meeting on 8 April 2014, members noted the research report on "Liquor licensing system in selected places" prepared by the Research Office, Information Services Division of the Legislative Council ("LegCo") Secretariat. There was a suggestion that the Panel should discuss the liquor licensing system in Hong Kong at a future meeting and invite deputations

13. Liquor licence fee adjustment: outcome of consultation	To be confirmed
Item proposed by the Administration.	
At the meeting on 11 July 2017, the Panel was briefed on the Government's proposal to adjust liquor licence fees and the measures put in place to improve the liquor licensing regime.	
The Panel then held a special meeting on 22 September 2017 to receive public views on the subject. Concurrently, the Administration consulted stakeholders on the fee adjustment proposal at liaison meetings with the trade in September and October 2017. The Administration will revert to the Panel on the outcome of the consultation and update the Panel on the proposed way forward, when ready.	
14. Construction works of the Agricultural Park Phase 1	End 2018/ early 2019

15. Progress of the major initiatives under the New Agriculture Policy	To be confirmed
To keep members abreast of the latest developments of the major initiatives underpinning the New Agriculture Policy ("NAP"), the Administration provided the Panel with an information paper reporting on the matter in July 2017 (LC Paper No. CB(2)1857/16-17(01)). The Administration undertook to keep the Panel informed of the implementation progress of NAP, including the proposed establishment of an Agricultural

Park ("Agri-Park"), the Sustainable Agricultural Development Fund and designation of Agricultural Priority Areas.	
At the meeting on 9 January 2018, Dr Hon KWOK Ka-ki and Dr Hon Helena WONG suggested that the Panel should hold a special meeting as early as possible to discuss the implementation progress of NAP, the construction of Agri-Park and the designation of Agricultural Priority Areas and to receive public views on these issues. On 10 January 2018, Dr KWOK, Hon Tanya CHAN and Hon Jeremy TAM jointly wrote to the Chairman reiterating the same request (LC Paper No. CB(2)691/17-18(01)). The Administration has been requested to provide a reply on its plan and timetable for discussing the matters at a Panel meeting, to facilitate members' consideration of the timing for discussion. On 16 January 2018, the Administration provided the Panel with a paper reporting on the progress of the major initiatives under NAP (LC Paper No. CB(2)721/17-18(01)).

At the meeting on 9 January 2018, Dr Hon CHIANG Lai-wan expressed a wish that arrangement be made for discussion of this subject in the third quarter of 2018.

18. Implementation of the human-poultry segregation measures at retail outlets for the live poultry trade	To be confirmed
Item proposed by the Administration.	
19. Use of veterinary drugs in food animals and cultured fish and surveillance of veterinary drug residues in food and food animals	To be confirmed
At the meeting on 15 October 2015, concerns were raised about the regulation of animal feed for livestock and cultured fish and the presence of veterinary drug residues, including antibiotics, in meat and aquatic products for human consumption. It was suggested that the Panel should discuss the subject matter at a Panel meeting.	
According to the Administration, it was considering measures to strengthen control over veterinary drug residues in food and food animals and planned to launch a public consultation on a proposed regulatory framework.	
On 3 January 2017, the Administration provided the Panel with an information paper on its work plan regarding antimicrobial resistance ("AMR") (LC Paper No. CB(2)519/16-17(01)). At the Panel meeting on 10 January 2017, members considered it necessary for the Administration to explain at a meeting in detail its work progress in tackling the threat of AMR.	
In recognition of the major threat posed by AMR to global public health, the Administration has set up a High Level Steering Committee on AMR ("HLSC") to formulate strategies and action plans for tackling AMR in Hong Kong. The Expert Committee on AMR ("Expert Committee") formed under HLSC has made recommendations to HLSC. Taking into account the recommendations of the Expert Committee and the "One Health" framework which apprehends the correlation among human, animal and environment

health and that AMR must be tackled at all three levels, HLSC has formulated a holistic Action Plan on AMR. On 10 July 2017, the Administration formally launched the Action Plan (2017-2022). The issue was discussed by the Panel on Health Services at its meeting on 17 July 2017, and members of this Panel were invited to join the discussion.	
At the work plan meeting held on 3 November 2017, the Administration advised that it would brief members on the implementation of the Hong Kong Strategy and Action Plan on AMR to tackle issues related to local livestock farms, when ready.	
20. Policies on promoting the development of the fisheries industry	To be confirmed
At the meeting on 18 October 2016, Hon Steven HO suggested that the Panel should follow up with the Administration on the following issues:

<p>At the special meeting on 3 September 2014, members expressed concern about inadequate regulation over cooked meat and considered it necessary for the Panel to follow up the matter. The Administration advised that it would review the relevant legislation and seek the views of LegCo Members and the trade before deciding on the way forward.</p>	
22. Government Laboratory's work in respect of food safety and other services	To be confirmed
<p>Item proposed by the Administration.</p>	<p>The Administration plans to brief members on the re-development of the Food Safety Laboratory of the Government Laboratory, once ready.</p>
23. Wholesale market consultancy study	To be confirmed
<p>At the meeting on 10 June 2014, members noted that the Administration had commissioned a consultancy study on the present-day functions and purpose of the wholesale business in the sale of fresh food produce, and analyse the geographical spread of the five existing wholesale markets from the perspectives of land use and food safety. The Administration undertook to revert to the Panel when the outcome of the consultancy study was ready.</p>

24. Ancillary facilities for storage and distribution of chilled meat and poultry At the meeting on 15 October 2015, concern was raised about the lack of ancillary facilities for wholesaling of chilled meat and poultry. Noting that the trade had made repeated requests to the Government for the setting up of an approved distribution and storage centre for chilled meat and poultry with a view to reducing food safety risks, members requested for early discussion of the subject. 25. Regulating and monitoring the activities of oyster culture in Hong Kong At the meeting on 9 February 2010, a suggestion was raised that the issue of regulating and monitoring the activities of oyster culture within Hong Kong waters should be discussed by the Panel at a future meeting. During the discussion on the implementation of FSO at the Panel meeting on 11 July 2012, concerns were expressed about the over-expansion of oyster culture in Shenzhen Bay and the need of introducing in Hong Kong a licensing mechanism for regulating the activities of oyster culture. 26. Measures to facilitate the establishment of co-operative societies In his letter dated 12 December 2016 (LC Paper No. CB(2)413/16-17(01)), Hon CHU Hoi-dick expressed concern on the need for the Administration to review the Co-operative Societies Ordinance (Cap. 33) and draw up measures for promoting local community economy by facilitating the establishment of co-operative societies.
