Action

I. Election of Chairman (and Deputy Chairman)

Election of Chairman

Mr Abraham SHEK Lai-him, the member who had the highest precedence in the Council among members of the Subcommittee to Follow Up the Issues Related to the Wang Chau Development Project ("the Subcommittee") present at the meeting, presided over the election of Chairman of the Subcommittee. He invited nominations for the chairmanship of the Subcommittee.

- 2. <u>Ms YUNG Hoi-yan</u> nominated Ms Alice MAK Mei-kuen and the nomination was seconded by Mr LUK Chung-hung. <u>Ms MAK</u> accepted the nomination.
- 3. <u>Mr Abraham SHEK</u> invited other nominations for the chairmanship. <u>Dr KWOK Ka-ki</u> nominated Mr CHU Hoi-dick and the nomination was seconded by Mr Andrew WAN. <u>Mr CHU</u> accepted the nomination.

4. As there was no other nomination, <u>Mr Abraham SHEK</u> announced a vote by secret ballot. After all members present had cast their votes, <u>Mr SHEK</u> invited Ms YUNG Hoi-yan, who had nominated Ms Alice MAK, and Dr KWOK Ka-ki who had nominated Mr CHU Hoi-dick, to oversee the counting of votes. Of the members present for voting, 14 members voted for Ms Alice MAK Mei-kuen and 11 voted for Mr CHU Hoi-dick. <u>Mr SHEK</u> declared that Ms Alice MAK Mei-kuen was elected the Chairman of the Subcommittee. <u>Ms Alice MAK</u> then took over the chair.

Election of Deputy Chairman

- 5. <u>The Chairman</u> invited nominations for the deputy chairmanship.
- 6. <u>Mr SHIU Ka-fai</u> nominated Mr Wilson OR Chong-shing and the nomination was seconded by Mr CHAN Kin-por.
- 7. <u>Mr Andrew WAN Siu-kin</u> nominated Mr CHU Hoi-dick and the nomination was seconded by Mr KWONG Chun-yu. <u>Mr CHU</u> accepted the nomination.
- 8. <u>The Chairman</u> announced a vote by secret ballot. After all members present had cast their votes, <u>the Chairman</u> invited Mr SHIU Ka-fai and Mr Andrew WAN who had nominated the two candidates to oversee the counting of votes. Of the members present for voting, 14 members voted for Mr Wilson OR and 11 voted for Mr CHU Hoi-dick. <u>The Chairman</u> declared that Mr Wilson OR was elected the Deputy Chairman of the Subcommittee.

Members of the public should be invited to expressed views at the meeting. The Chairman instructed that the Administration be requested to provide relevant discussion papers.
