- 1. Co-location arrangement at the control point for the Guangzhou-Shenzhen-Hong Kong Express Rail Link ("XRL")**

Item proposed by Hon Dennis KWOK, whose letter on the subject had been circulated to members vide LC Paper No. CB(2)707/12-13 on 27 February 2013. At the meeting on 1 March 2013, members agreed that the subject be discussed at a future meeting. Members also agreed that members of the Panel on Administration of Justice and Legal Services and representatives from the Department of Justice would be invited to attend when the subject was discussed.

The Administration advised that co-location arrangement at the control point concerned was part and parcel of the XRL project spearheaded by the Transport and Housing Bureau ("THB"), which would provide information to the Panel on Transport on the co-location arrangement of immigration and customs facilities at the control point as part and parcel of the XRL project in due course.

The subject of co-location arrangements at the control point for XRL was discussed at the meeting of the Subcommittee on Matters Relating to Railways on 14 December 2015.

At the meeting on 28 October 2016, Hon Claudia MO suggested that the item be arranged for discussion.

A paper and a booklet on "Customs, Immigration and Quarantine Arrangements of the Hong Kong Section of the Guangzhou-Shenzhen-Hong Kong Express Rail Link" were issued to members of the House Committee vide LC Paper No. CB(2)1966/16-17 on 25 July 2017.

The subject of "Customs, Immigration and Quarantine Arrangements of the Hong Kong Section of the Guangzhou-Shenzhen-Hong Kong Express Rail Link" was discussed at the House Committee meeting on 3 August 2017 and the joint meeting of the Panel on Transport, Panel on Security and Panel on Administration of Justice and Legal Services ("AJLS") on 8 August 2017.

At the meeting on 12 October 2017, Hon Charles MOK suggested that the subject be further followed up by the relevant Panels.

*(Note 1: The subject was discussed at the House Committee meeting on 3 August 2017 and a joint meeting of the Panel on AJLS, Panel on Transport and Panel on Security on 8 August 2017. The Chief Executive has announced that the Administration will move a non-binding government motion on the subject for members' debate at the Council meeting of 25 October 2017.)*

**2. Security measures at the Central Government Offices and the impact on public meetings and public processions**

Hon Alan LEONG raised a question on access control measures at the East Wing Forecourt of the Central Government Offices at Tamar at the Council meeting of 22 October 2014.

At the work plan meeting of the Chairman and the Deputy Chairman with the Secretary for Security on 8 November 2016, the Administration was requested to provide information on the latest development regarding access control measures at the East Wing Forecourt of the Central Government Offices.

(*Note 2: The Administration has subsequently advised that the Chief Executive has announced in her 2017 Policy Address that the East Wing Forecourt (the Forecourt) of the Central Government Offices ("CGO") will be reopened as soon as possible before the end of 2017. The Forecourt will resume its functions as a vehicular access to CGO, a passenger pick-up/drop-off point for CGO and a passageway for visitors and staff of CGO and the Legislative Council Complex. The relevant departments are making preparation for the reopening and announcement would be made later.*)

A joint letter dated 13 June 2017 from Dr Hon Fernando CHEUNG and Hon SHIU Ka-chun regarding allegations of torture and assault of inmates in penal institutions and the Administration's response were circulated to members vide LC Paper Nos. CB(2)1309/16-17 and CB(2)2114/16-17 on 19 June and 25 September 2017 respectively. At the meeting on 12 October 2017, Dr Hon Fernando CHEUNG suggested that the issues concerned be discussed by the Panel.

The Administration intends to consult the Panel on its proposal to turn a supernumerary post of Administrative Officer Staff Grade C into a permanent post to sustain the enhanced anti-drug work.

- 22. Amendments to the First Schedule to the Dangerous Drugs Ordinance (Cap. 134) and Schedule 2 to the Control of Chemicals Ordinance (Cap. 145)** 1<sup>st</sup> Quarter of 2018

The Administration intends to consult the Panel on the inclusion of new types of drugs and chemical precursors under Part I of the First Schedule to the Dangerous Drugs Ordinance (Cap. 134) and Schedule 2 to the Control of Chemicals Ordinance (Cap. 145).

- 23. New Hong Kong Smart Identity Card** December 2017

The Administration intends to brief the Panel on the new smart identity card design and the territory-wide card replacement exercise. (Funding for implementing the "Next Generation Smart Identity Card System" had been approved by the Finance Committee on 15 May 2015.)
