Forecast of submissions for the 2018-19 Legislative Council session

This note gives an overview of the potential capital works items to be submitted to the Public Works Subcommittee (PWSC) in the 2018-19 Legislative Council session.

- 2. On the basis of the latest advice of bureaux and departments, a total of 84¹ projects, as listed in Enclosure 1, may be ready for submission to the PWSC before the 2019 summer recess. To enable Members to have a better understanding of the projects, we have provided supplementary information on each project at Enclosure 2 following the same order presented in Enclosure 1. The list is our best projection at this stage and is subject to refinements.
- 3. The Government will try to adhere to the target dates as set out in Enclosures 1 and 2 as much as possible. However, there may be programme changes arising from the design, statutory gazettal and objections, and consultation stages, etc. for individual projects. We will account for deviations from the current forecast in a year-end report for Members' reference.
- 4. We apply price adjustment factors for deriving the cost estimate of capital works projects funded by the Capital Works Reserve Fund in money-of-the-day prices. The updated prices of public sector building and construction output are assumed to increase by 4% for 2018, 5% per annum from 2019 to 2023, 4.5% per annum from 2024 to 2026 and 4% for 2027 and 2028. Price adjustment factors used in funding applications regarding capital works projects are updated annually.

Project Code and Title: 9357WF—Design and construction for first stage of desalination plant at Tseung Kwan O—main works

Policy Bureau and Branch: Development Bureau (Works Branch)

Works Department: Water Supplies Department

Project Description:

The proposed project is for the design and construction of the first stage of the proposed Tseung Kwan O desalination plant, which will have a water production capacity at 135 000 cubic metres (m³) per day with provision for future expansion to the ultimate water production capacity up to 270 000 m³ per day. The proposed scope of the project comprises (a) design and construction of the first stage of the proposed desalination and associated facilities; (b) formation of the earmarked site; (c) construction of the seawater intake and outfall facilities; and (d) associated works including environmental impact mitigation measures, natural slope hazard mitigation measures and landscaping works.

Parts of the 9357WF were upgraded to Category A in June 2015 as 9359WF entitled "Design and construction for first stage of desalination plant at TKO—investigation study review, design and site investigation" and in October 2017 as 9364WF entitled "Design and construction for first stage of desalination plant at Tseung Kwan O—Mainlaying". We plan to upgrade the remainder of 9357WF to Category A in 2019–Q1. We are proceeding with the tendering exercise for the design-build-operate contract for the first stage of the Tseung Kwan O desalination plant. Construction is tentatively scheduled to commence in 2019–Q2 for completion in 2022–Q4. Testing and commissioning of the proposed desalination plant will subsequently be completed by 2022–Q4.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Above \$500 million

Target Contract Start Date: 2019–Q2

Previous or planned panel consultation: We consulted the Panel on Development on the proposed project on 24 April 2018. Members generally supported the proposal.

Project Code and Title: 6188TB—Footbridge near MTR Kowloon Bay Station

Exit B

Policy Bureau and Branch: Development Bureau (Works Branch)

Works Department: Highways Department

Project Description:

The proposed project is for the construction of a footbridge to connect the existing elevated walkway near MTR Kowloon Bay Station Exit B, existing footbridge no. KF(LNTKE) and the future East Kowloon Cultural Centre. The proposed scope of the project comprises (a) construction of a footbridge; (b) modification of the existing elevated walkway; (c) modification of the elevated platform at the eastern end of the existing Footbridge No. KF(LNTKE); (d) provision of staircase connecting to item (b) above; (e) provision of barrier-free access ramp connecting to the existing elevated walkway; and (f) associated road works, drainage works, diversions of water mains, stormwater drains, sewerage and utilities, landscape works, tree felling and transplanting, street lighting works, environmental mitigation measures and temporary traffic arrangement during construction of the project. The construction is tentatively scheduled to commence in 2019–Q2 for completion in 2022–Q1.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): \$200 million - \$500 million

Target Contract Start Date: 2019–Q2

Previous or planned panel consultation: We plan to consult the Panel on Development on the proposed works in December 2018.

Project Code and Title: 3468RO—Improvement of Lam Wah Street Playground and adjacent area

Policy Bureau and Branch: Development Bureau (Works Branch)

Works Department: Architectural Services Department, Highways Department and Civil Engineering and Development Department

Project Description:

The proposed project is for the improvement of Lam Wah Street Playground and its adjacent area. The proposed scope of the project comprises (a) improvement to Lam Wah Street Playground; (b) construction of a new sitting-out area between Sheung Yuet Road and Wang Yuen Street; (c) face-lifting of a section of the pedestrian walkway between Wang Chiu Road and Wang Kwun Road; and (d) enhancement of streetscape in the vicinity of Lam Wah Street Playground. The improvement works are tentatively scheduled to commence in 2019–Q4 for completion in 2021–Q4.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Below \$200 million

Target Contract Start Date: 2019–Q4

Project Code and Title: 4388DS—Shek Wu Hui Effluent Polishing Plant

Policy Bureau and Branch: Environment Bureau

Works Agent: Drainage Services Department

Project Description:

The proposed project is for increasing treatment capacity and upgrading treatment level of the Shek Wu Hui Sewage Treatment Works (SWHSTW) to cope with the sewage generated by existing and future increased population in Fanling, Sheung Shui, and neighbouring areas including the Kwu Tung North (KTN) and Fanling North (FLN) New Development Areas (NDAs). The proposed scope of the project comprises (a) the construction of new sewage and sludge treatment facilities in order to upgrade SWHSTW to tertiary treatment level as an effluent polishing plant; (b) the provision of community friendly and betterment measures associated with the project; and (c) the ancillary works. The construction is tentatively scheduled to commence in 2019–Q3 for completion in 2034–Q3.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Above \$500 million

Target Contract Start Date: 2019–Q3

Previous or planned panel consultation: We plan to consult the Panel on Development on the proposed project together with the KTN and FLN NDAs projects in January 2019.

Project Code and Title: 7747CL—Advance site formation and engineering infrastructure works at Kwu Tung North new development area and Fanling North new development area

Policy Bureau and Branch: Development Bureau (Planning and Lands Branch)

Works Department: Civil Engineering and Development Department

Project Description:

The proposed project is for carrying out site formation and engineering infrastructure works, including the construction of the eastern section of Fanling Bypass, for selected areas in Kwu Tung North and Fanling North new development areas (the Advance Works). The Advance Works are proposed to support the development of housing and community facilities for the first population intake in the new development areas.

The scope of the works comprises:

- (a) site formation of land for the two new development areas;
- (b) engineering infrastructure works including roads, drainage, sewerage, waterworks, pumping stations, fresh water and flushing water service reservoirs;
- (c) part expansion and upgrading of Shek Wu Hui Sewage Treatment Works;
- (d) reprovisioning works;
- (e) soil remediation;
- (f) landscaping works;
- (g) implementing the environmental mitigation measures for the works mentioned in (a) to (f) above; and
- (h) supervision of construction works.

The construction is tentatively scheduled to commence progressively from 2019–Q3 for completion in 2026–Q4.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Above \$500 million

Project Code and Title: 7759CL—First stage of site formation and engineering infrastructure at Kwu Tung North new development area and Fanling North new development area

Policy Bureau and Branch: Development Bureau (Planning and Lands Branch)

Project Description:

The proposed project is for carrying out the first stage of site formation and engineering infrastructure works to tie in with the development of Kwu Tung North and Fanling North new development areas and to enable the implementation of essential environmental mitigation measures required for the new development area project.

The scope of the works comprises:

- (a) site formation for village resite area in Kwu Tung North new development area:
- (b) site formation for Hong Kong Police Force's facilities in Kwu Tung North new development area;
- (c) development of a nature park at Long Valley;
- (d) construction of engineering infrastructure works including roads, drainage, sewerage, waterworks, utility services and landscaping works; and
- (e) environmental mitigation works and supervision of construction works.

The construction is tentatively scheduled to commence progressively from 2019–Q3 for completion in 2026–Q4

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Above \$500 million

Project Code and Title: 7793CL—Site formation and infrastructure works for Police Facilities in Kong Nga Po

The proposed project is for carrying out site formation and engineering infrastructure works, including off-site road/junction improvement works at a section of Kong Nga Po Road, for the co-location of various police facilities and a helipad in Kong Nga Po. The construction is tentatively scheduled to commence in 2019–Q2 for completion in 2022–Q4.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Above \$500 million

Project Code and Title: 7828CL—Remaining phase of site formation and engineering infrastructure works at Kwu Tung North new development area and Fanling North new development area

Policy Bureau and Branch: Development Bureau (Planning and Lands Branch)

Project Description:

The part of the project proposed for upgrading to Category A is for the detailed design and site investigation for the site formation and engineering infrastructure works required for the remaining phase of the Kwu Tung North and Fanling North new development areas. The scope of the proposed work comprises –

- (a) design of site formation for identified areas and related studies;
- (b) design of engineering infrastructure works including roads, drainage, waterworks, pumping stations, utility services, sewerage, service reservoirs, environmental mitigation measures, etc.; and
- (c) site investigation works and supervision.

The detailed design and site investigation works are tentatively scheduled to commence in second half of 2019 for substantial completion in second half of 2024.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Above \$500 million

Target Contract Start Date: Second half of 2019

Since the commencement of the construction of the HZMB Main Bridge project in 2009, there has been escalation in the construction costs arising from the complicated conditions for construction in the open sea, the difficulty in construction, the increase in labour and material costs as well as the refinement of the design and construction schemes. As a result, the contractors of the HZMB Main Bridge submitted applications to the HZMB Authority for adjustment of the project estimate.

The HZMB Authority has reviewed the applications submitted by the contractors and prepared a report on the adjustment of the project estimate. The relevant Mainland Authorities have reviewed and submitted the report on the adjustment of the project estimate to the State Council. According to the approval of the Ministry of Transport, the cost overrun of the Main Bridge is around Renminbi (RMB)9.95 billion. In accordance with this latest project estimate approved by the Ministry of Transport, the three sides would have to contribute a capital cost of about RMB4.6 billion, with the balance of RMB5.35 billion to be financed by bank loan. As for the contribution from Hong Kong, it is expected to be about RMB2.0 billion.

We will seek the approval of the Finance Committee for increasing the APE in due course.
