# **Supplementary Information requested by Members** at the Meeting on 20 February 2019

At the meeting of the Public Works Subcommittee (PWSC) held on 20 February 2019, Members requested the Government to provide the following information:

- (a) At the request of the Hon Alvin YEUNG, the Government should provide supplementary information in tabular form on the construction costs, number of storeys, site area, net operational floor area (NOFA) and facilities of the proposed Immigration Headquarters (HQ) in Tseung Kwan O and the headquarters of other disciplined services constructed in recent years for comparison.
- (b) At the request of the Hon Tony TSE Wai-chuen, the Government should provide supplementary information on the comparison of the construction unit cost (represented by the building costs and building services costs) between the new HQ and other government office building projects which are also delivered through design-and-build contracts (including projects underway and recently completed, such as the West Kowloon Government Offices and the West Kowloon Law Courts Building) in terms of construction floor area (CFA).
- (c) At the request of the Hon Jeremy TAM Man-ho, the Government should provide supplementary information on whether requests for the provision of motorcycle parking spaces at the new HQ have been received in consultation with the staff of the Immigration Department (ImmD).
- (d) At the request of the Hon Tanya CHAN, the Hon Eddie CHU Hoi-dick and Dr Hon Fernando CHEUNG Chiu-hung, the Government should provide supplementary information on in-house fire ranges of the disciplined services under the Security Bureau and their current usage.

- (e) At the request of Dr Hon KWOK Ka-ki, the Government should provide supplementary information and data to compare the major materials to be used for the building facade of the new HQ and other alternative materials in terms of energy efficiency.
- (f) Regarding the proposed Joint-user Government Office Building adjacent to the new HQ,
  - i. at the request of Dr Hon Fernando CHEUNG Chiu-hung, the Government should provide supplementary information on the number of child care places to be provided in the proposed child care centre in the proposed Joint-user Government Office Building; and
  - ii. at the request of the Hon WU Chi-wai, the Government should provide supplementary information on the services to be provided in the proposed Joint-user Government Office Building and the estimated number of their users.
- (g) At the request of the Hon AU Nok-hin, the Government should provide supplementary information on the floor area and construction costs of the detention facilities in the new HQ.
- (h) At the request of the Hon WU Chi-wai and Dr Hon LO Wai-kwok, the Government should provide supplementary information on
  - i. the facilities in the new HQ, their respective floor areas and whether these floor areas are counted as part of the NOFA; and
  - ii. the principles adopted by the Government in allocating floor areas to various facilities.

# (a) & (b) Project costs, areas and facilities of other disciplined services' headquarters and government office buildings

2. The project costs, construction unit cost, construction floor area (CFA) and major facilities and other related information of the proposed HQ and that of the headquarters of other disciplined services and government office buildings delivered through design-and-build contracts in the past decade are as follows:

### (c) Motorcycle parking spaces

- 3. Car parking spaces will be provided at the proposed HQ to meet ImmD's operational needs. At present, ImmD does not have departmental motorcycles. During the planning of the proposed HQ, ImmD have maintained close communication and held regular meetings with staff to collect their views on various aspects of the proposed HQ. ImmD has not yet received any suggestions from staff on the provision of motorcycle parking spaces at the proposed HQ so far.
- 4. According to the original plan, no motorcycle parking spaces will be provided at the proposed HQ. Taking into account Members' views and the feasibility, we plan to provide five motorcycle parking spaces at the proposed HQ.

### (d) In-house fire ranges of disciplined services

5. The information and current usuage of the in-house fire ranges of the disciplined services under the Security Bureau are as follows:

6. The fire ranges of the disciplined services are tailor-made to meet their respective operational and training needs. They are unable to satisfy ImmD's training needs in the long run. ImmD is responsible for the management of detention facilities designated for persons who are detained and pending removal under the Immigration Ordinance. Managing detention facilities is one of the duties of each disciplined staff To ensure that ImmD's staff can effectively member of ImmD. discharge their duties, and to safeguard the safety of ImmD's staff and detainees, ImmD plans to provide relevant firearms and ammunition training for newly recruited disciplined staff and relevant serving staff in phases in the future. Therefore, ImmD needs to have its own fire range to meet the Department's operational and training needs effectively and enhance its training efficiency.

### (e) Facade design

7. For the building's overall energy efficiency, we suggest making reference to the Overall Thermal Transfer Value (OTTV) of the building envelope. The lower the OTTV, the better the thermal insulation performance, which can increase the energy efficiency of the building. As shown in the table below, the contractual requirement on energy efficiency of the proposed HQ is more stringent than that of the Buildings Department (BD) or government buildings.

- 8. The curtain wall system of the proposed HQ's facade will adopt low reflectivity and high transmittance glass, non-reflective cladding panel design, greening on external walls and other solar shading devices (such as shading fins), etc. to minimise thermal radiation, light reflection and possible impacts to buildings and residents in the vicinity.
- 9. With the use of thermal insulating base materials, the non-reflective cladding panels adopted for the external walls apart from the windows in this project can achieve better thermal insulation performance than other common types of design (e.g. traditional concrete walls with stone and tile finish). The overall rate of thermal transfer from the external walls into the interior space will be lower, thereby achieving higher energy efficiency for the building as a whole. In terms of the performance on diffusion of external heat, the cladding panel design is more or less the same as other materials of the external walls in similar colour.

### (f) Proposed Joint-user Government Office Building in Area 67, Tseung Kwan O

- 10. The proposed child care centre in the Joint-user Government Office Building in Tseung Kwan O (TKO JUB) is expected to provide 100 child care places.
- 11. The services to be provided in the TKO JUB include a general out-patient clinic; a families clinic, a dental clinic and a child care centre for civil servants and eligible persons; a job centre and other labour services of the Labour Department; a post office and a delivery office; a Social Security Field Unit; a Regional Office (Kowloon East/Sai Kung) of the Independent Commission Against Corruption; customer service counters of the Environmental Protection Department; and the Education Bureau's training services for teachers.
- 12. It is estimated that the above services will have an average daily total patronage of more than 4 000.

### (g) Floor area and construction costs of the detention facilities

13. The NOFA of the detention cells in the proposed HQ is about 400 m<sup>2</sup>. As the building and building services of the detention facilities do not involve high-cost materials or systems, their construction unit cost are broadly commensurate with the overall construction unit cost of \$37,697 per m<sup>2</sup> in MOD prices.

#### (h) Accommodation

- 14. The total CFA of the proposed HQ is about 139 000 m<sup>2</sup>, which includes an NOFA of about 57 400 m<sup>2</sup> for ImmD's use. The allocation is, as approved by the Property Vetting Committee, made in compliance with the established space standards and on the principles of meeting the Department's daily operational needs effectively and ensuring the optimal use of government resources. The NOFA of the facilities is as follows:
  - (a) public-oriented offices for providing immigration-related services such as the issuance of identity cards and travel documents and the handling of applications for visas and extension of stay about 13 600 m<sup>2</sup> in total;

- (b) general office accommodation for internal use by various branches/divisions of ImmD about 32 300 m<sup>2</sup> in total;
- (c) telephone hotline centres for the public to make enquiries, contact the Assistance to Hong Kong Residents Unit and report immigration offences –about 400 m<sup>2</sup> in total;
- (d) operational facilities including an identity card personalisation centre, a travel document personalisation centre, a data centre, video recording interview rooms, an identification parade room and detention cells about 4 000 m<sup>2</sup> in total;
- (e) command and control centres including an emergency co-ordination centre, information systems monitoring centre and command control room about 500 m<sup>2</sup> in total; and
- (f) ancillary facilities including conference rooms, interview rooms, an auditorium, an indoor fire range and staff facilities about 6 600 m<sup>2</sup> in total.
- 15. The above NOFA does not include areas for basic facilities (if any) such as mechanical plant rooms, pipe or services ducts, escalators and lift shafts, lift lobbies, stair halls, stairwells, public or shared corridors, barrier-free access facilities, gender mainstreaming facilities, parking spaces, loading and unloading areas, refuse chutes and refuse rooms, toilets, bathrooms, balconies, verandas, open decks and flat roofs, etc.
- 16. Unlike general government office buildings, the proposed HQ will accommodate various public-oriented offices and specialised operational facilities, etc. Sufficient CFA is required for the provision of necessary facilities such as public corridors, escalators and lift shafts, mechanical plant rooms, barrier-free access facilities and toilets.
