Proposed extension of period of work of subcommittees on policy issues and the timeline for activation of subcommittees on the waiting list

# **Purpose**

This paper invites Members to consider the proposals of two subcommittees on policy issues ("policy subcommittees") for extension of period of work, namely the Subcommittee on Matters Relating to Railways ("the Railways Subcommittee") and the Joint Subcommittee to Monitor the Implementation of the West Kowloon Cultural District Project ("the WKCD Subcommittee"), and note the timeline for activation of policy subcommittees on the waiting list.

# Background

2. Under rules 26(a) and (b) of the House Rules ("HR"), the maximum number of policy subcommittees appointed by the House Committee ("HC") and Panels that may be in operation at any one time is 10 ("the quota"). Where the number of policy subcommittees has reached the quota, a queuing system will automatically be activated with a waiting list formed. The order of policy subcommittees on the waiting list is in the order of their appointment.<sup>1</sup>

According to the broad principles for the activation, operation and extension of period of work of policy subcommittees agreed at the HC meeting on 15 November 2013, the number of subcommittees under each Panel operating at the same time should not exceed two. For this purpose, a joint subcommittee will be counted as one subcommittee for each of the Panels concerned. The broad principles also provide that HC can decide the order of activation/re-activation of policy subcommittees on the waiting list.

- 3. Under HR 26(c), a policy subcommittee should complete its work within 12 months of its commencement and report to HC or the relevant Panel(s). Should such a subcommittee consider it necessary for it to work beyond that 12 months, the subcommittee should, after obtaining the endorsement of the relevant Panel(s) if it is appointed by a Panel(s), report to HC and give justifications for an extension of the 12-month period.<sup>2</sup>
- 4. At the HC meeting on 7 July 2017, Members agreed to adopt the following arrangements for extension of period of work of policy subcommittees in the Sixth Legislative Council: upon completion of the 12-month period, a policy subcommittee in operation will vacate its slot for activation of a subcommittee on the waiting list. If the subcommittee considers it necessary for it to work beyond the 12-month period, upon obtaining endorsement of HC, it will be put on the waiting list for re-activation. It was also agreed that five policy subcommittees (including the Railways Subcommittee and the WKCD Subcommittee) were permitted to continue to work for a specified period of time as agreed by HC.<sup>3</sup> Details of the policy subcommittees in operation (including the expiry date of the 12-month work period) and policy subcommittees on the waiting list are in **Appendices I** and **II** respectively.

# Proposals of two policy subcommittees for extension of period of work

5. The proposal of the Railways Subcommittee and the WKCD Subcommittee for further continuation of work in the 2018-2019 session was endorsed by HC at its meeting on 6 July 2018. The Railways Subcommittee and the WKCD Subcommittee have reviewed their work progress and consider it necessary for them to continue to work in the 2019-2020 session. Details of their work progress and their proposals for extension of period of work are set out in Appendices III and IV respectively.

At this HC meeting, the Railways Subcommittee and the WKCD Subcommittee which have been given priority for activation in the 2016-2017 session were given permission for continuation of work in the 2017-2018 session.

# Timeline for activation of policy subcommittees on the waiting list

6. Should the Railways Subcommittee and the WKCD Subcommittee be given permission to continue to work in the 2019-2020 session, two vacant slots will arise in mid-December 2019 for activation of the first two policy subcommittees currently on the waiting list (i.e. Subcommittee on Issues Relating to Policy on Industrial Buildings and Subcommittee on Issues Relating to the Development of Chinese Medicine). The third policy subcommittee currently on the waiting list (i.e. Subcommittee to Study Issues Relating to the Development of Electric Vehicles) can be activated once any one of the two investigation committees ("ICs")<sup>4</sup> can wrap up its work.

# **Advice sought**

- 7. Members are invited to:
  - (a) consider and endorse the proposals of the Railways Subcommittee and the WKCD Subcommittee for continuation of work in the 2019-2020 session; and
  - (b) note the timeline for activation of policy subcommittees on the waiting list.

# Continuation of work of the Subcommittee on Matters Relating to Railways

# **Purpose**

This paper reports on the progress of work of the Subcommittee on Matters Relating to Railways ("the Subcommittee") formed under the Panel on Transport and the need for the Subcommittee to continue its work in the 2019-2020 legislative session.

# **Background**

- 2. Since the Second Term of the Legislative Council, a subcommittee was set up under the Panel on Transport to monitor issues relating to the planning and implementation of new railway projects, and the operation of existing railways.
- 3. Following previous practices, the Panel on Transport agreed at its meeting on 28 October 2016 to appoint a subcommittee to follow up relevant matters. The Subcommittee held its first meeting on 18 November 2016. At the House Committee meeting on 6 July 2018, Members agreed that permission be given for the Subcommittee to continue to work in the 2018-2019 session, i.e. up to the end of September 2019. The terms of reference and membership list of the Subcommittee are set out in **Annexes I and II** respectively.

#### Work of the Subcommittee

Under the chairmanship of Hon Frankie YICK Chi-ming, the Subcommittee has held four meetings since October 2018<sup>1</sup> and studied the following major issues:

#### Operation of existing railways (a)

- (i) Operation of the Hong Kong Section ("HKS") of the Guangzhou-Shenzhen-Hong Kong Express Rail Link ("XRL");
- upgrading of signalling system for railway lines; and (ii)
- causes of major railway incidents, and contingency (iii) arrangements;

#### Implementation of new railway project (b)

progress update and financial situation of the implementation of the Shatin to Central Link ("SCL"), key information of which is set out in **Annex III**: and

#### Need for continuation of work in the 2019-2020 session

# Implementation of the Shatin to Central Link

The Subcommittee has examined regularly the progress of construction of the SCL and received updates on the subject by the Administration at its meetings held on 7 December 2018 and 1 February Additionally, the Subcommittee was briefed on the interim report of the Commission of Inquiry into the construction works at and near the Hung Hom Station Extension under the SCL project at its meeting on 29 March 2019. Members of the Subcommittee also noted that on 19 February 2019, the Chief Executive in Council approved the expansion of the Commission's Terms of Reference to investigate the steel reinforcement fixing or concreting works at three locations under contract

quality of construction works of the Shatin to Central Link project.

The Subcommittee also held three special meetings in July and August 2018 under the chairmanship of Hon Michael TIEN Puk-sun, Chairman of the Subcommittee for the 2017-2018 session, to discuss incidents relating to the

No. 1112 of SCL, as well as an extension of time for the Commission to submit its report to the Chief Executive by 30 August 2019.<sup>2</sup> Having regard to the missing Request for Inspection and Survey Checks Forms (i.e. RISC Forms) for the steelworks at North Approach Tunnels ("NAT"), the South Approach Tunnels and the Hung Home Stabling Sidings, as well as the insufficient documentation for NAT regarding a design change of some connections between reinforcement bars during construction, members expressed strong disappointment at the monitoring system of MTR Corporation Limited ("MTRCL") in implementing the SCL project. Some members also queried the role of the Monitoring and Verification Consultant appointed by the Highways Department and considered that the Consultant had failed to perform its duties.

6. In view of the fact that the target commissioning date of the Tai Wai to Hung Hom section of SCL (scheduled to be commissioned in mid-2019) would need to be further reviewed due to the series of incidents relating to works at the Hung Hom Station Extension and the associated investigation works, members urged the Administration and MTRCL to complete as soon as practicable the feasibility study on the partial opening of some stations and sections of the Tai Wai to Hung Hom Section. Members were also concerned about the settlement issues of the construction of SCL and the cost overrun of the main works of the SCL project. In view of the above concerns, the Subcommittee may need to continue to oversee the mechanism of both the Administration and MTRCL in monitoring the implementation of construction works and the financial situation of SCL.

# Planning of new railway projects

In October 2014, the Subcommittee members were briefed by the 7. Administration on the Railway Development Strategy ("RDS-2014"), which recommended that seven railway projects be completed in the planning horizon up to the year 2031 having regard to transport demand, cost-effectiveness and the development needs of New Development Areas and other new developments. The proposed indicative implementation window for planning purpose (i.e. between 2018 and 2026) of the seven projects and the preliminary cost estimates for the individual railway projects are given in **Annex IV**.

The Chief Executive in Council approved on 10 September 2019 an extension of time for the Commission to submit its final report to the Chief Executive to 31 March 2020.

8. Members noted that the Administration had evaluated the proposals and requested MTRCL to supplement details for five railway lines recommended in RDS-2014, i.e. Tuen Mun South Extension, Northern Link (and Kwu Tung Station), East Kowloon Line, Tung Chung West Extension (and Tung Chung East Station) and North Island Line. It is therefore envisaged that the Subcommittee may need to provide views and inputs concerning the implementation of the abovementioned five railway projects, and to continue to monitor the planning progress of the remaining two railway projects recommended in RDS-2014.

# Operation of existing railways

Hong Kong Section of the Guangzhou-Shenzhen-Hong Kong Express Rail Link

9. The HKS of the XRL formally commenced operation on 23 September 2018. The Subcommittee was briefed on the operation of the HKS of the XRL at its meeting on 7 December 2018. concern on the patronage of the HKS of the XRL, some members called on the Administration and MTRCL to offer fare discount to Hong Kong residents and to provide interchange discounts for XRL passengers, so as to boost the patronage of the XRL. Some members opined that the details of the financial situation of the HKS of the XRL project, including information on the situation of claims, should continue to be submitted regularly to the Subcommittee for members' reference after the commissioning of the HKS of XRL. Members were advised that the Administration had been pressing ahead the enhancement of the Mainland ticketing system with the China Railway Corporation and would work in tandem with MTRCL to roll out more facilitation arrangements such as introducing e-tickets to cater for the needs of different passenger groups. Given that the HKS of XRL is an important cross-boundary transport infrastructure, it is proposed that the Subcommittee should continue to monitor the operation of the HKS of the XRL.

### Upgrading signalling system for railway lines

10. Noting that signalling system is the heart of railway operation, members in general were concerned about the progress of the upgrading of signalling system for railway lines. At the meeting on 1 February 2019, members noted with serious concern that the expected completion of the upgrading of the new signalling systems for Tsuen Wan Line and Island Line would be delayed for one year and two years respectively. They worried that the retrofitting of Automatic Platform Gates along the East Rail Line would be further postponed and the congestion situation of railway lines would be aggravated as a result of the delay in the upgrading programme. The progress of the upgrading of signalling system for railway lines would continue to be the key focus of the Subcommittee in the coming session.

# Major railway incidents

In the 2018-2019 session, the Subcommittee had followed up on two major railway incidents pertinent to signalling fault, namely service disruption of four MTR lines on 16 October 2018 and the incident of the new signalling system testing on Tsuen Wan Line on 18 March 2019. Expressing dissatisfaction with the deteriorating service performance of MTRCL, some members urged the Administration to conduct a comprehensive review on the Service Performance Arrangement, which was considered not effective to achieve its intended effect. Apart from seeking explanation from MTRCL on the causes of individual incidents, members also urged the Administration to step up monitoring of MTRCL, and requested MTRCL to take measures to ascertain the safety of the existing signalling system and affirm that incident of similar nature would not occur again in future. Members further noted that MTRCL had been reviewing its existing contingency plan, including the provision of free shuttle buses serving the affected MTR stations.

#### Proposed extension of period of work

12. Rule 26(c) of the House Rules provides that a subcommittee should complete its work within 12 months of its commencement and report to the relevant Panel(s). If it is necessary for a subcommittee to work beyond that 12 months, the subcommittee should, after obtaining the endorsement of the relevant Panel(s), report to the House Committee and give justifications for an extension of the 12-month period.

13. The Subcommittee has played a significant role in monitoring the Administration and MTRCL in the implementation of new railway projects under construction or planning and the various issues arising from railway operations like service disruption or safety operation. Having regard to the matters which require more focused discussion and follow-up by the Subcommittee as set out in paragraphs 5 to 11 above, the Panel on Transport has endorsed the proposal for the Subcommittee to continue its work in the 2019-2020 session.

- (f) co-ordination of public transport services arising from the commissioning of new railway lines.

# Railway operation

- (a) performance of existing railway lines including train service performance and safety management;
- (b) maintenance programme; and
- (c) train service disruptions and breakdowns, and arrangements for handling emergency situations.

Matters relating to corporate governance of the post-merger corporation and fares, including review of the fare adjustment mechanism, should be dealt with by the Panel on Transport.

Proposed extension of period of work of the Joint Subcommittee to Monitor the Implementation of the West Kowloon Cultural District Project under the Panel on Development and the Panel on Home Affairs

# **Purpose**

This paper reports on the progress of work of the Joint Subcommittee to Monitor the Implementation of the West Kowloon Cultural District Project ("the Joint Subcommittee") and seeks Members' approval of the proposal of the Joint Subcommittee to extend the period of its work and continue to operate in the 2019-2020 session.

# **Background**

- 2. The Joint Subcommittee was appointed by the Panel on Development ("DEV Panel") and the Panel on Home Affairs ("HA Panel") in November 2016 to monitor issues relating to the implementation of the West Kowloon Cultural District ("WKCD") project, including the work of the West Kowloon Cultural District Authority ("WKCDA"), the project's interface with arts and cultural development, and other related matters. The terms of reference and membership list of the Joint Subcommittee are set out in Annexes I and II respectively. According to its work plan, the Joint Subcommittee will follow up the recommendations of the former Joint Subcommittee formed in the Fifth Legislative Council ("LegCo") and focus its work on the following areas:
  - (a) the taking forward of the Development Plan for WKCD;
  - (b) planning and development of the core arts and cultural facilities and other associated facilities;

- (c) strategy for the development of cultural software, such as the artistic positioning and mode of governance of and management strategy for the performing arts facilities;
- (d) financial management and procurement procedures; and
- (e) governance and work of WKCDA.
- 3. The Joint Subcommittee was given permission by the House Committee ("HC") for continuation of its work in the 2017-2018 session and in the 2018-2019 session at the HC meetings on 7 July 2017 and 6 July 2018 respectively.

#### Work of the Joint Subcommittee in the 2018-2019 session

- 4. The Joint Subcommittee has held five meetings since November 2018. Major issues studied by the Joint Subcommittee in this session include:
  - (a) update on the progress of the WKCD development;
  - (b) update on the development of Xiqu Centre (which was opened in January 2019), Art Park, Freespace, Lyric Theatre Complex ("LTC"), M+, as well as the Art, Commerce and Exhibitions ("ACE") development package;
  - (c) cultural software development for WKCD;
  - (d) update on the development of Zone 2 of WKCD, and the funding proposal for the construction of Zone 2 of the Integrated Basement ("IB");
  - (e) integration and connectivity of WKCD with its neighbouring districts; and
  - (f) update on the financial situation of WKCD.

# Issues that may be followed up by the Joint Subcommittee if continuation of work is approved

Hardware and software development for the West Kowloon Cultural District

Implementation of core arts and cultural facilities

- 5. Pursuant to the pragmatic approach adopted by the Government and WKCDA since June 2013 to implement the WKCD project in the face of financial challenges, the development of WKCD facilities have been taken forward in three batches (a table showing the batching, status and target completion dates of major WKCD facilities, and a schematic plan of these facilities are in **Annexes III** and **IV** respectively).
- 6. Of the major facilities in WKCD, Xiqu Centre is the first one opened (in January 2019). Meanwhile, a number of construction projects for other facilities are still ongoing. According to WKCDA, the Art Park has been opening in phases with the final Phase 3 to be opened by the end of 2019, the Freespace will be in use in June 2019, the M+ Building is expected to secure the occupation permit ("OP") in the first quarter of 2020 for the opening of the Museum about a year later, the main works of LTC commenced in November 2018 and is expected to secure OP in 2023, and the construction of the superstructure of the Hong Kong Palace Museum commenced in April 2019 and is expected to secure OP in mid-2021 for opening a year later.
- 7. Having regard to the above development progress, the Joint Subcommittee may wish to continue to monitor the implementation progress of the facilities of WKCD, and WKCDA's work on the cultural software development to dovetail with the gradual commissioning of the various arts and cultural facilities in WKCD. In parallel, the Joint Subcommittee may also wish to continue to examine the mode of governance and management, as well as the hiring policy and arrangements of the WKCD facilities.

Implementation of the Integrated Basement

8. IB is an integral component of the "City Park" conceptual plan forming the basis for the Development Plan for WKCD. The design enables traffic to be put underground thereby freeing up the site for cultural use and public enjoyment. Since IB had not been envisaged when the upfront endowment was granted to WKCDA in 2008, the Government announced in July 2013 that it would fully fund the capital works of the main IB as general

enabling works to facilitate the development of the WKCD project subject to the Finance Committee ("FC")'s funding approval, and would implement IB in phases to tie in with the phased development of WKCD. IB is divided into Zones 2A and 2BC (collectively referred to as "IBZ2"), and Zones 3A and 3B. The latest IB zoning plan cum topside development plan is in **Annex V**.

- 9. The Joint Subcommittee (in the former and current terms of LegCo) has scrutinized proposals for implementing the works of the development of IB. At its meeting on 14 January 2019, the Joint Subcommittee considered the funding proposal for carrying out the remaining works of IB in IBZ2, being the largest basement section in between Xiqu Centre to the east and LTC to the west. On top of the basement are the remaining arts and cultural facilities including the Music Centre, Musical Theatre, Great Theatre and Medium Theatre I and the hotel, office and residential ("HOR") developments.
- 10. According to WKCDA, subject to the funding approval of FC,<sup>2</sup> the construction of Zone 2A including an underground road will commence in phases from mid-2019 for completion to dovetail with the implementation of the topside development in around 2025. The detailed design and site investigation for Zone 2BC will commence in the second half of 2019, and the construction of which will commence in phases from 2020 to dovetail with the implementation of the topside development from 2027 and beyond.
- 11. Given that the timely implementation of the topside development will be contingent upon the on-time completion of IB, the Joint Subcommittee may wish to continue to monitor the progress of the IB construction works.

# Implementation of public infrastructure projects

12. The Joint Subcommittee has all along been concerned about issues relating to the integration and connectivity of WKCD with its neighbouring districts, including the implementation progress of the public infrastructure works projects for WKCD. With the gradual commissioning of more WKCD facilities that will bring an increasing number of visitors to the district, the Joint Subcommittee may wish to keep on monitoring the implementation progress of the network of at-grade walkways, footbridges and subways connecting WKCD to the adjoining areas, including the Artist Square Bridge and the Austin Road Pedestrian Linkage System; the provision of public transport services including possible marine transport service; the provision of car and coach parking spaces; and the means for enhancing pedestrian accessibility within the district, such as SmartBike and the trial of an electric autonomous vehicle, etc.

### Financial situation of the West Kowloon Cultural District Project

- 13. Since 2013, WKCDA has reported to the Joint Subcommittee from time to time that it has been facing financial challenges. The Joint Subcommittee has noted with grave concerns that the one-off upfront endowment of \$21.6 billion approved by FC in 2008 for WKCDA to implement the WKCD project and its investment income would only be sufficient to cover the costs of the design and construction costs of Batch 1 and most of Batch 2 facilities, while the implementation of Batch 3 facilities According to WKCDA, upon the would have to be reviewed. commissioning of more arts and cultural facilities in WKCD, the Authority is facing a prolonged and increasing structural operating deficit primarily attributable to the associated running cost. Based on the latest estimates of WKCDA reported to the Joint Subcommittee in April 2019, after the opening of Xiqu Centre and phased opening of Art Park including Freespace, WKCDA's overall operating deficit before depreciation will be around \$847 million in 2019-2020.
- 14. The arrangements decided to be adopted by the Government/WKCDA to meet the financial challenges of WKCDA included the followings:
  - (a) Enhanced Financial Arrangement ("EFA")—the Government will grant the development rights of the entire HOR portion of WKCD to WKCDA at nominal premium for development under the Build-Operate-Transfer ("BOT") model; and
  - (b) external borrowing WKCDA will engage a financial consultant to draw up an external borrowing plan, with the options of issuing bonds and/or raising loans in several tranches in the coming years.
- 15. Members of the Joint Subcommittee expressed various concerns over EFA, including the details of the BOT arrangements for the HOR development, duration of BOT and the income sharing between WKCDA and private developers, etc. As regards the external borrowing plan of WKCDA, members were keenly concerned about the cost of engaging the financial consultant, the timetable of implementing the plan, the total amount of funding that WKCDA sought to raise, and how the loans would be repaid, etc.
- 16. According to WKCDA in April 2019, it would soon take forward the first BOT project, i.e. the ACE development package. WKCDA was finalizing the invitation for expression of interest for the ACE project for issue in the second quarter of 2019, to be followed with issuing the tendering document to the shortlisted tenderers in the third/fourth quarter of 2019. WKCDA also advised that it would soon commence consultancy to provide

financial advisory services in the second quarter of 2019 to review its budget and to draw up an external borrowing plan. It was estimated that the external borrowing plan would be completed in the third/fourth quarter of 2019. WKCDA would update the Joint Subcommittee on the progress in due course.

17. In the above connection, the Joint Subcommittee may find it necessary to continue to follow up with the Government/WKCDA on the implementation of EFA and the external borrowing plan.

# Procedure for extension of period of work

- 18. Rule 26(c) of the House Rules provides that a subcommittee should complete its work within 12 months of its commencement and report to the relevant Panel(s). If it is necessary for a subcommittee to work beyond 12 months, it should, after obtaining the endorsement of the relevant Panel(s), report to HC and give justifications for an extension of the period of work.
- 19. At the meeting of the Joint Subcommittee on 10 June 2019, members agreed to seek the endorsement of DEV Panel and HA Panel on the proposal to extend its work period in the 2019-2020 session. The Joint Subcommittee's proposal has been endorsed by DEV Panel and HA Panel by circulation of papers.

# **Advice sought**

20. Members are invited to note the progress of work of the Joint Subcommittee and endorse the Joint Subcommittee's proposal to extend the period of its work and continue to operate in the 2019-2020 session.




