I. Election of Chairman

<u>Mr Paul TSE</u>, the member who had the highest precedence among members of the Subcommittee present at the meeting, presided over the election of the Chairman of the Subcommittee. He invited nominations for the chairmanship of the Subcommittee.

2. Mr Dennis KWOK was nominated by <u>Mr Paul TSE</u>, and the nomination was seconded by <u>Dr Junius HO</u>. <u>Mr Dennis KWOK</u> accepted the nomination.

3. There being no other nominations, <u>Mr Dennis KWOK</u> was elected the Chairman of the Subcommittee.

4. <u>Members</u> agreed that there was no need to elect a Deputy Chairman.

II. Meeting with The Law Society of Hong Kong

Discussion

5. <u>The Chairman</u> informed members that The Law Society of Hong Kong ("the Law Society") had, in response to the Subcommittee's invitation to attend the meeting, written to the Clerk to Subcommittee on 9 November 2018 [LC Paper No. CB(4)211/18-19(01)] requesting the Subcommittee to set out the questions that it would raise at the meeting to enable the Law Society to identify the appropriate persons to attend the first meeting. The Clerk to Subcommittee had informed the Law Society that as the Subcommittee's membership had yet to be finalized at that time, its request could not be acceded to. The Law Society did not send any representative to attend the present meeting.

6. <u>The Subcommittee</u> deliberated (index of proceedings in **Appendix**). <u>Members</u> raised no objection to the Foreign Lawyers Practice (Amendment) Rules 2018 (Commencement) Notice, Solicitors' Practice (Amendment) Rules 2018 (Commencement) Notice and Summary Disposal of Complaints (Solicitors) (Amendment) Rules 2018 (Commencement) Notice (hereinafter collectively referred to as "the three Commencement Notices") and would not propose any amendment.

<u>Action</u>

Issues raised by members

the 7. <u>Members</u> raised a number of issues relating to the Foreign Lawyers Law Practice Rules (Cap. 159R) at the meeting. They agreed that to facilitate Society members' discussion of these issues in other forum of the Legislative Council, the Chairman would, on behalf of the Subcommittee, write to the Law Society requesting it to provide the following information:

- (a) the number of cases in the past five years in which registered foreign lawyers were found in breach of Cap. 159R for practising Hong Kong law (if any);
- (b) the number and nature of enforcement actions which were taken against the cases mentioned in paragraph 7(a), and the difficulties encountered by the Law Society in enforcing the rules and prohibitions under Cap. 159R;
- (c) possible challenges that the Law Society envisaged in enforcing Cap. 159R going forward;
- (d) the possible challenges that the Law Society might face in ensuring that Hong Kong law firms and foreign law firms in Hong Kong would strictly comply with Cap. 159R in general, and the enforcement details of the same; and whether the Law Society would consider including these questions into its current consultation; and
- (e) whether the roles and duties for foreign lawyers should be clearly and better set out under the relevant legislation including Cap. 159R so as to distinguish them from Hong Kong qualified solicitors and other unqualified persons, such as paralegals and legal managers.

8. <u>Members</u> also wished to know the views of members of the Law Society regarding the issues raised in paragraph 7. In this connection, the Law Society was requested to extend the Subcommittee's invitation to its members for their views.

(*Post-meeting note*: The letter from the Chairman [LC Paper No. CB(4)243/18-19(01)] was issued to the Law Society on 21 November 2018.)

The way forward

9. <u>Members</u> noted that the Chairman would move a motion at the Council meeting of 21 November 2018 to extend the scrutiny period of the three Commencement Notices.

10. <u>Members</u> agreed that subject to any views members might have on the Law Society's response to the requested information as mentioned in paragraphs 7 and 8, the Chairman would consider the need to hold a further meeting. If no further meeting was considered necessary, the Subcommittee would deem to have completed scrutiny of the three Commencement Notices.

(Post-meeting note: The Law Society's interim reply to the follow-up actions arising from the meeting on 16 November 2018 [LC Paper No. CB(4)275/18-19(01)] was issued to members via LC Paper No. CB(4)275/18-19 on 3 December 2018. The Law Society advised that it would provide the response to the Subcommittee by 14 December 2018. Members were informed via LC Paper No. CB(4)300/18-19 on 7 December 2018 that all members had considered it not necessary to conduct a further meeting and therefore, the Subcommittee had completed scrutiny of the three Commencement Notices. The deliberations of the Subcommittee were reported to the House Committee on 14 December 2018. The Law Society's further reply to follow-up actions the abovementioned [LC Paper No. CB(4)336/18-19(01)] was issued to members via LC Paper No. CB(4)336/18-19 on 18 December 2018. The final reply from the Law Society was still pending as at the date of issuance of these minutes.)

11. There being no other business, the meeting ended at 9:18 am.
