Follow-up matters arising from the meeting of
the Legislative Council Subcommittee on Registration of Persons
(Application for New Identity Cards) Order 2018 and Registration of Persons

on 5 November 2018

In response to the request made by Members of the Subcommittee at the above meeting, the Government provides the supplementary information as follows:



The numbers of Hong Kong permanent identity ("ID") cards and Hong Kong ID cards issued by the Immigration Department ("ImmD") between June 2003 and December 2013

2. The ImmD issued 11 200 113 smart ID cards ¹ between June 2003 and December 2013, among which 9 172 936 were Hong Kong permanent ID cards and 2 027 177 were Hong Kong ID cards.

<u>Information on Privacy Impact Assessment (PIA) and Information Technology (IT)</u> Security Risk Assessment

3. The ImmD has engaged independent consultants to conduct assessments on privacy impacts and IT security at different stages of the development of the Next Generation Smart Identity Card System with a view to ensuring that the system design and the work flow comply with the Personal Data (Privacy) Ordinance (Cap. 486) and the requirements on IT security. The information of the consultants and the expenditure involved are listed in the tables below -
