Question 1

According to paragraph 15 of the paper, the work of Administrative Assistant to Chief Justice (AA/CJ) is currently assisted by one Senior Executive Officer (SEO). Did the government examine the option of increasing the manpower at non-directorate level instead of creating the proposed permanent post of Deputy Administrative Assistant (Deputy AA)?

Reply to Question 1

To cater for operational needs, the proposed post of Deputy Administrative Assistant to Chief Justice (Deputy AA/CJ) is to liaise with the senior judges and senior personnel of the judiciaries in Hong Kong and other jurisdictions, assist in the planning of the CJ's exchange activities, and provide strategic advice to the CJ. For these reasons, it is not appropriate for the post to be held by a non-directorate officer.

Question 2(a) to (c)

Paragraph 2 of Enclosure 4 stated that the duties and responsibilities of the proposed post of Deputy AA include assisting the Chief Justice's Private Office (CJ's Private Office) in handling the exchange activities between the Chief Justice (CJ) and other jurisdictions, organising major events and conferences, and planning the CJ's official functions within and outside Hong Kong. In this regard,

- (a) What are the numbers of various exchange activities, major events and conferences between the CJ and other jurisdictions in each of the past five years? In the form of a table, please provide details of each activity, such as the date on which each activity was held, the names of other jurisdictions as well as the nature and contents of the exchange activities;
- (b) What are the numbers of the CJ's official activities, within and outside Hong Kong respectively, in each of the past five years? In the form of a table, please provide details of each official activity, such as the date, place, nature and contents of each activity;
- (c) Is the work in the above two areas, in the Government's anticipation, likely to increase in the coming five years? If so, what will be the extent? What are the details and reasons?

Reply to Question 2(a)-(b)

The exchange activities within and outside Hong Kong between the CJ and other jurisdictions mainly include substantial speaking engagements, courtesy meetings with judicial officers, and exchanges with other attending judicial officers during his attendance at conferences/seminars on judicial-related topics. The figures for the CJ's exchange activities with other jurisdiction within and outside Hong Kong in the past five years are as follows:

Apart from the exchange activities with other jurisdictions, the CJ also attended other official activities including speaking engagements about 40 to 50 times each year in connection with various sectors of the community (mainly the legal sector and the education sector). Reply to Question 2(c)

Over the past few years, the Judiciary has maintained regular exchanges with other jurisdictions. The scale and the depth of the exchange activities between the Judiciary and other jurisdictions have also increased. For example, there have been more thematic seminars, international conferences and so on.

Deputy AA/CJ is required to provide strategic input on the development of such exchange activities, and to provide strategic support to the CJ and other Judges and Judicial Officers.

Question 3

Paragraph 3 of Enclosure 4 stated that the proposed post is to assist the AA in overseeing the strategic development of public communication activities within the Judiciary. What are the details of the relevant communication activities and the workload? Is it necessary for the Judiciary to formulate or to significantly alter the strategic development of its communication activities on a yearly basis?

Reply to Question 3

The Judiciary continuously reviews its work relating to public communication, and promotes public understanding of the Judiciary's role and work through webpages and visits. New measures implemented over the past few years include revamping the website of the Court of Final Appeal (CFA) in 2015 to give a detailed account of the work of the CFA, the history, as well as architectural characteristics of the current and the former CFA Buildings. In the same year, the scope of school visit activities was expanded to include the CFA Building in addition to the High Court (HC) Building. In 2018, new panels were added to the Exhibition Gallery of the CFA to cover wider topics.

Currently, the Judiciary is contemplating the production of more informative materials in the form of text or multimedia for distribution through printed matters or webpages, and the expansion of the scope of school visit activities to include Magistrates' Courts (Mag Cts), etc. We are also collecting information on the public communication activities of the judicial organs in other places to facilitate the formulation of long-term development strategies.

Deputy AA/CJ will assist in planning and overseeing the above related tasks.

Question 4

Please provide figures in a table, with breakdown by levels of court, on the establishment and number of vacancies of (i) Judges and (ii) Judicial Officers and the relevant information (number of substantive, acting and deputy Judges and Judicial Officers).

Question 5

Please set out information as at 24 April 2020 about respective projects that the Judiciary has planned to implement in the next five years, including the nature of the plans, the implementation timetables, the ranks of the responsible officers, the Key Performance Indicators, and the current performance of the Judiciary under those Indicators for comparison purpose.

Reply to Question 5

Having regard to the proposed creation of posts in the paper FCR(2019-20)25, there are a number of projects in the next five years to be overseen by the permanent post of Deputy Judiciary Administrator (Planning and Quality) (DJA(PQ)) at Administrative Officer Staff Grade B1 (D4).

2. DJA(PQ) will oversee the long-term strategic planning of the Judiciary's use of information technology (IT) having regard to the rapid development in the area and the unique operating environment of the Judiciary. The post will also steer quality enhancement in the Judiciary Administration (Jud Adm) to maintain quality support services to courts and tribunal. DJA(PQ) will also be responsible for the on-going pursuit of the Judiciary's long-term accommodation strategy and formulation of a comprehensive strategic plan to meet future demands, including the two new mega accommodation projects, namely, the reprovisioning of the HC, and the reprovisioning of the District Court (DC) and the Family Court (which will be co-located with the Lands Tribunal (LandsT)).

IT Projects

- 3. Assistant Judiciary Administrator (Quality and Information Technology) (AJA(Q&IT)) at Principal Executive Officer (PEO) (D1) level and Chief Systems Manager (Information Technology) at Chief Systems Manager (D1) level assist DJA(PQ) in the long-term strategic planning of the Judiciary's use of IT. These include the following:
 - (a) planning, development and implementation of Information Technology Strategy Plan ("ITSP") Phase I Stage 2 and ITSP Phase II; and
 - (b) wider use of IT in the operation of the Judiciary.

ITSP

- 4. The ITSP of the Judiciary is a long-term IT project seeking to enable the Judiciary to meet its operational requirements. Among others, the ITSP covers the development of an integrated court case management system (iCMS) across all court levels and tribunals of the Judiciary, and non-court systems such as human resources management system and electronic information management system. The implementation of the ITSP is divided into two phases. Phase I of the ITSP is further divided into two stages:
 - (a) Stage 1 mainly covers the IT infrastructure foundation and the development of iCMS of the DC, the Summons Courts of the Mag Cts and the related court offices; and
 - (b) Stage 2 mainly covers the iCMS for the CFA, the HC, the remaining part of the Mag Cts and the Small Claims Tribunal.
- 5. The implementation of Phase I Stage 1 has reached an advanced stage. All activities relating to the building and set-up of IT infrastructure foundation have been completed. Components under Phase I Stage 1 that do not require legislative backing are being progressively rolled out to the Stage 1 courts. Subject to the enactment of the legislative amendments, namely the Court Proceedings (Electronic Technology) Bill which seeks to enable the use of an electronic mode for court documents, electronic services would be launched as an additional option for court users to interface with the Judiciary.
- 6. In parallel, with the experience of the Phase I Stage 1 implementation, the Judiciary is planning for the Phase I Stage 2 implementation.
- 7. Phase II of ITSP covers the Family Court, Labour Tribunal, LandsT, Obscene Article Tribunal and the Coroner's Court. While implementation of ITSP Phase I is in progress, we aim to start the preliminary planning work for the development and implementation of ITSP Phase II in the coming five years. After formulating the strategy and a more concrete scoping, we will prepare the financial requirements for the development and implementation of ITSP Phase II.

Wider Use of IT in Courts

- 8. The Judiciary has been actively using audiovisual and information technology (AV/IT) facilities to support and facilitate the court operations. Having regard to the rapid developments in the AV/IT, it is essential to have continual reviews, and upgrades as appropriate, of the AV/IT facilities deployed in courtrooms and court buildings. In view of the public health considerations, hearings of the courts and tribunals have been generally adjourned and court/tribunal registries and offices were also closed between 29 January 2020 and 3 May 2020 ("General Adjourned Period (GAP)"). There was an upsurge in the demand for alternative modes of handling court business. On 2 April 2020, the Judiciary promulgated the arrangements for using video-conferencing facilities (VCF) for hearing suitable civil cases in the HC. A number of VCF hearings have been held since then. The response has so far been positive.
- 9. Notwithstanding the end of GAP from 3 May 2020, it remains of paramount importance that justice is duly administered continuously and effectively without compromising public health and safety. As the public health situation remains fluid and may change rapidly, the courts will exercise flexibility to cater for any exigency. It is also recognised that the public health situation in places other than Hong Kong may impact the ability of witnesses to travel to and appear in Hong Kong courts. Under these considerations, the Judiciary has issued Guidance Notes on Remote Hearings for Civil Business in the HC and the Civil Courts on 2 April 2020 and 8 June 2020 respectively. Remote hearings cover civil cases in all of the following civil courts: (1) the Court of First Instance of the HC (Masters and Judges); (2) the Court of Appeal of the HC; (3) the DC; including (4) the Family Court. Some trials or parts of trials may also be considered for remote hearings.
- 10. To meet the rising expectations of the community and court users for greater use of AV/IT in court proceedings, the Judiciary plans to continue to proactively explore all possible alternative means and measures, including implementation of more user-friendly solution to facilitate remote hearings.

Quality Management

- 11. AJA(Q&IT) at PEO (D1) level assists DJA(PQ) in overseeing the quality management of the Judiciary. The Jud Adm has been conducting management reviews and process re-engineering as and when required to meet latest operational requirements. Performance pledges for various services have been set and quality management tools have been introduced to monitor the compliance. In pursuit of continual improvements in the delivery of service, the Jud Adm will continue to maintain quality support services to courts and tribunals through adoption of quality management tools and conducting of management reviews to achieve service enhancement.
- 12. The Jud Adm will be implementing various organization-wide projects, including those initiatives under the ITSP and the mega reprovisioning projects. The new DJA(PQ) will steer the overall project implementation to ensure that a holistic approach be adopted amongst the various initiatives. Corresponding process re-engineering and service improvements will be considered and introduced to tie-in with those upcoming projects.

Mega Re-provisioning Projects

- 13. Assistant Judiciary Administrator (Accommodation) at PEO (D1) level assists DJA(PQ) in formulating the long-term accommodation strategy of various mega accommodation projects. The Judiciary intends to implement the following major projects in the next five years:
 - (a) Construction of additional courtrooms and associated facilities at lower ground fourth floor in the HC Building

Over the years, there is a shortage of courtrooms in the HC. The project is to construct six additional courtrooms and associated facilities at lower ground fourth floor in the HC Building to address the medium-term accommodation requirements of the Judiciary.

Under the current project timetable and subject to Finance Committee's approval, the construction works are expected to commence in late 2020 for completion by phases in the third quarter of 2023.

(b) Construction of the DC at Caroline Hill Road

The project is to construct a new standalone law courts building (LCB) with sufficient courtrooms, chambers and supporting facilities at the DC level to address the long-term accommodation requirements of the Judiciary in the next few decades or so. It is to reprovision the existing DC and the Family Court now accommodated in the Wanchai LCB, as well as to co-locate the LandsT now located in Yau Ma Tei.

Under the current project timetable, it is expected that construction works will be completed by mid-2027. Subject to works completion and handing over of the new building to the Judiciary, full commissioning of facilities will be completed in 12 months.

(c) Construction of the HC at New Central Harbourfront

The project is to construct a new LCB to address the long-term accommodation requirements of the HC now situated in Queensway. The project is at a preliminary planning stage.
