#### Notes:

- Total CFA takes into account all areas within the external walls of building structure. This measurement unit is usually used for calculation of construction cost of a project.
- NOFA is the net usable floor area allocated to the users of a building for carrying out the intended activities, which does not include areas of the following basic facilities: lift lobbies and lift shafts, stair halls, corridors, wall thickness, pipes and services ducts, barrier-free access facilities, toilets, refuse rooms, open space and flat roofs, parking spaces, loading and unloading areas, plant rooms, etc.
- NOFAs of the indoor firing range and tactics training centre of the proposed Airport District OB are set according to the requirements of the approved schedule of accommodation. The CFAs of the indoor firing range and tactics training centre (i.e. 1 740 m² and 1 200 m²) as mentioned in the supplementary information (LC Paper No. PWSC160/19-20(01)) submitted by the Government to the PWSC on 5 June 2020 are worked out from the preliminary design based on the respective NOFA requirements and only served as a reference. The actual areas would be confirmed at the detailed design stage.
- The assault course is an open-air facility. The areas of the assault courses in the proposed Airport District OB and the existing APS are about 480 m<sup>2</sup> and 455 m<sup>2</sup> respectively.
- 5 This figure is the initial staff establishment when the existing APS commissioned in 1998.
