#### I Election of Chairman

## Election of Chairman

<u>Ir Dr LO Wai-kwok</u>, the member with the highest precedence among those present at the meeting, presided over the election of the Chairman of the Subcommittee. He invited nominations for the chairmanship of the Subcommittee.

2. Mr Tony TSE was nominated by Mr LUK Chung-hung and the nomination was seconded by Ir Dr LO Wai-kwok. Mr Tony TSE accepted the nomination. There being no other nomination, Mr Tony TSE was declared Chairman of the Subcommittee. Members agreed that there was no need to elect a Deputy Chairman.

#### Legislative timetable

3. The Subcommittee noted that the scrutiny period of the Building (Minor Works) (Amendment) Regulation 2020 and the Building (Planning) (Amendment) Regulation 2020 ("the two Regulations") would expire at the Council meeting of 10 June 2020. The Subcommittee agreed that the Chairman would move a motion at the Council meeting of 10 June 2020 to extend the scrutiny period to the Council meeting of 8 July 2020. Members noted that, upon extension of the scrutiny period, the deadline for giving notice of motion to amend the two Regulations would be 30 June 2020. The Chairman would report the deliberations of the Subcommittee to the House Committee at its meeting on 26 June 2020.

(*Post-meeting note:* The proposed resolution to extend the scrutiny period of the two Regulations was not dealt with at the Council meeting of 10 June 2020; hence, the scrutiny period of the two Regulations had expired at the said Council meeting.)
