#### I. Election of Chairman

Mr Frankie YICK, the member of the highest precedence among members of the Subcommittee present at the meeting, presided over the election of Chairman of the Subcommittee. He called for nominations for the chairmanship of the Subcommittee.

- 2. <u>Mr LUK Chung-hung</u> nominated Mr Frankie YICK and the nomination was seconded by <u>Ms Elizabeth QUAT</u>. <u>Mr YICK</u> accepted the nomination. As Mr YICK was nominated for the chairmanship, <u>Mr CHAN Han-pan</u>, the member of the second highest precedence among members present at the meeting, presided over the election of Chairman.
- 3. As there was no other nomination, <u>Mr CHAN Han-pan</u> declared Mr Frankie YICK elected as the Chairman of the Subcommittee. <u>Mr YICK</u> then took the chair.
- 4. <u>Members</u> considered it not necessary for the Subcommittee to elect a Deputy Chairman.

#### **II.** Meeting with the Administration

- 5. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).
- 6. <u>Members</u> agreed that written views on the Road Traffic (Driving Licences) (Amendment) Regulation 2021 ("the Amendment Regulation") would be invited from the public by posting a notice on the website of the Legislative Council.

(*Post-meeting note:* A total of 25 submissions were received from the public, and circulated to members vide LC Paper Nos. CB(4)1508/20-21 and CB(4)1511/20-21 on 7 and 8 September 2021 respectively. The Administration's consolidated response to the submissions was issued to members vide LC Paper No. CB(4)1543/20-21 on 16 September 2021.)

7. The Administration was requested to provide supplementary information on the respective numbers of fixed penalty tickets and traffic summons issued in the past three years in respect of illegal driving training activities, and the relevant penalties for those convicted.

(*Post-meeting note:* The supplementary information provided by the Administration was circulated to members vide LC Paper No. CB(4)1512/20-21 on 8 September 2021.)

- 8. <u>The Subcommittee</u> had completed consideration of the policy aspect of and examination of the provisions of the Amendment Regulation. <u>Members</u> raised no objection to the Amendment Regulation and would not propose any amendments.
- 9. <u>Assistant Legal Adviser 9</u> confirmed that no difficulties were identified in relation to the legal and drafting aspects of the Amendment Regulation.

#### III. Any other business

10. <u>Members</u> agreed that the Chairman would move a motion at the Council meeting of 8 September 2021 to extend the scrutiny period of the Amendment Regulation to the Council meeting of 6 October 2021. <u>Members</u> noted that if the scrutiny period was extended, the deadline for giving notice of motion for amendment, if any, was 28 September 2021.

(*Post-meeting note:* The scrutiny period of the Amendment Regulation was extended to the Council meeting of 6 October 2021. Members were informed that the Chairman would report the deliberations of the Subcommittee at the meeting of the House Committee on 24 September 2021 vide LC Paper No. CB(4)1555/20-21 on 17 September 2021.)
