
Letter from Hon Elizabeth QUAT

司法及法律事務委員會主席

張國鈞議員, JP 台鑒：

要求司法機構跟進沙田法院出現政治標語和圖案

沙田法院「當值律師服務」辦事處早前有職員在告示版張貼「香港人加油」等政治標語和圖案。儘管事件經調查後，該辦事處已嚴厲譴責涉事職員，惟張貼支持違法抗爭及煽動性標語的行為已損害司法機構的聲譽，更令大眾市民質疑司法機構能否堅守公平公正的獨立原則。鑒於此事影響深遠，本人希望司法及法律事務委員會要求司法機構能於會議中回答以下問題：

- (一.) 「當值律師服務」辦事處表示按照規定，當值律師履行公共職責時，任何政治言論或討論都不能在辦公室內展示或討論，是次告示版仍出現政治標語或印刷品的原因為何；
- (二.) 是否知悉，除了嚴厲譴責外，對該名肇事的職員，有何跟進機制；針對違反規定、專業失德的職員，司法機構有何具體懲處機制；
- (三.) 法院中誰有權批准與拒絕宣傳品張貼於告示版上？上述政治標語或印刷品張貼於告示版多久；除了上述事件，本港法院是否發生過同類事情；若有，當中涉及多少宗數；及
- (四.) 鑒於事發地點位處法院大樓內，被公眾質疑機構範圍內為何能展示帶有煽動性的標語和圖案。司法機構有何具體措施 i)防止同類事情再度發生；及 ii)提升管理工作的質素？
