I. Election of Chairman and Deputy Chairman

Election of Chairman

Mr Jimmy NG, the incumbent Chairman of the Panel on Commerce and Industry ("the Panel"), presided over the election of the Chairman of the Panel for the 2020-2021 session and invited nominations for the chairmanship. He drew Members' attention to the letters sent to the Secretariat by 24 Members indicating that they would not accept nominations of chairmanship of the Panel. Members had been informed of the letters via email on 15 October 2020 and the relevant information was also tabled at the meeting.

- 2. Mr CHUNG Kwok-pan was nominated by Mr SHIU Ka-fai and the nomination was seconded by Mr CHAN Chun-ying. Mr CHUNG accepted the nomination.
- 3. Mr Kenneth LEUNG was nominated by Ms Claudia MO and the nomination was seconded by Mr Alvin YEUNG. Mr LEUNG accepted the nomination.

- 4. Mr Charles Peter MOK was nominated by <u>Dr Helena WONG</u> and the nomination was seconded by <u>Mr Alvin YEUNG</u>. <u>Mr MOK</u> accepted the nomination.
- 5. Mr James TO was nominated by Mr HUI Chi-fung and the nomination was seconded by Mr Alvin YEUNG. Mr TO accepted the nomination.
- 6. Mr LAM Cheuk-ting was nominated by <u>Dr KWOK Ka-ki</u> and the nomination was seconded by <u>Mr Alvin YEUNG</u>. <u>Mr LAM</u> accepted the nomination.
- 7. Mr HUI Chi-fung was nominated by Ms Claudia MO and the nomination was seconded by Mr Alvin YEUNG. Mr HUI accepted the nomination.
- 8. Mr IP Kin-yuen was nominated by <u>Dr KWOK Ka-ki</u> and the nomination was seconded by <u>Mr Alvin YEUNG</u>. <u>Mr IP</u> accepted the nomination.
- 9. Mr WU Chi-wai was nominated by Mr James TO and the nomination was seconded by Mr Alvin YEUNG. Mr WU accepted the nomination.
- 10. Dr KWOK Ka-ki was nominated by Mr Andrew WAN and the nomination was seconded by Mr Alvin YEUNG. Dr KWOK accepted the nomination.
- 11. Prof Joseph LEE was nominated by Mr HUI Chi-fung and the nomination was seconded by Mr Alvin YEUNG. Prof LEE accepted the nomination.
- 12. Mr SHIU Ka-chun was nominated by <u>Dr KWOK Ka-ki</u> and the nomination was seconded by <u>Mr Alvin YEUNG</u>. As Mr SHIU was not present when the nomination was made, <u>Dr KWOK</u> stated that he had secured Mr SHIU's acceptance of the nomination beforehand.
- 13. Mr Alvin YEUNG was nominated by Mr LAM Cheuk-ting and the nomination was seconded by Ms Claudia MO. Mr YEUNG accepted the nomination.
- 14. Dr Fernando CHEUNG was nominated by Mr HUI Chi-fung and the nomination was seconded by Ms Claudia MO. As Dr CHEUNG was not present when the nomination was made, Mr HUI stated that he had secured Dr CHEUNG's acceptance of the nomination beforehand.

- 15. Dr Helena WONG was nominated by Mr Andrew WAN and the nomination was seconded by Ms Claudia MO. Dr WONG accepted the nomination.
- 16. There being no other nominations, <u>Mr Jimmy NG</u> announced a vote by secret ballot.
- 17. After members present had cast their votes, <u>Mr Jimmy NG</u> invited members who had made the nominations to monitor the counting of votes, and <u>Mr SHIU Ka-fai</u> and <u>Ms Claudia MO</u> came to the front of the Chairman's podium for the purpose. Of the members present, 24 members voted for Mr CHUNG Kwok-pan, 15 members voted for Mr Alvin YEUNG, and the remaining 12 nominees did not receive any votes. <u>Mr NG</u> declared that Mr CHUNG was elected as the Chairman of the Panel for the 2020-2021 session. <u>Mr CHUNG</u> then took the chair.
- 18. <u>The Chairman</u> said that owing to time constraint, the election of the Deputy Chairman would be held at the next regular meeting scheduled for 17 November 2020.

II. Schedule of meetings for the 2020-2021 session

19. <u>Members</u> noted the proposed schedule of regular meetings of the Panel for the 2020-2021 session, which was tabled at the meeting, and agreed that future regular meetings of the Panel for the 2020-2021 session would be held on the third Tuesday of each month at 2:30 pm. <u>Members</u> noted that the Chairman might adjust or change the start/end time of those meetings having regard to the number of discussion items on the agenda of respective meetings.

(*Post-meeting note*: The schedule of Panel meetings for the 2020-2021 session was issued to members vide LC Paper No. CB(1)17/20-21 on 16 October 2020.)

20. <u>The Chairman</u> informed members that as the Chief Executive had announced to postpone the delivery of the 2020 Policy Address, the policy briefing-cum-meeting originally scheduled for 20 October 2020 would be rescheduled to a later meeting to be arranged. Members would be informed of the updated meeting arrangements in due course.

24. <u>Ir Dr LO Wai-kwok</u> said that he and Mr Jeffrey LAM had written to the Panel proposing to set up a subcommittee under the Panel to study issues relating to the stimulation of Hong Kong's economy. <u>The Chairman</u> said that the joint letter from Ir Dr LO and Mr LAM would be circulated to members for information and the proposal would be considered at the next Panel meeting on 17 November
