Legislative Council Panel on Welfare Services Follow-up to Meeting on 8 March 2021

At the meeting of the Panel on Welfare Services on 8 March 2021, the Government was requested to provide information on:

- (a) the enforcement actions taken in 2019 and 2020 against domestic violence and sexual violence cases, including the numbers of prosecution instituted and successful prosecution made; and
- (b) the feedback received from service users on the preventive, supportive and specialised services to combat domestic violence.
- 2. We provide the requested information as follows-
 - (a) The Security Bureau and the Hong Kong Police Force set out the numbers of prosecutions and convictions related to domestic violence (crime) cases with sentences in 2019 and 2020 in <u>Annex A</u>, and the numbers of prosecutions and convictions related to rape, indecent assault and unlawful sexual intercourse with sentences during the same period in <u>Annex B</u>.
 - (b) The preventive, supportive and specialised services provided by the

Social Welfare Department (SWD) and non-governmental organisations for victims of domestic violence and their families achieved the Outcome Standards under the Service Performance Monitoring System of SWD in 2019-20. The Outcome Standards include the service users' satisfaction with the service units in improving support network, capability in managing family problems, etc. SWD will continue to monitor the service performance of the service units concerned and collect feedback from service users to measure service effectiveness and improve the quality of services.

Similarly, for indecent assault cases received by the Police, the eventual charges laid depend on the case circumstances and the evidence obtained.

Besides "indecent assault" under section 122 of the Crimes Ordinance (Cap 200), other possible charges include "indecent conduct towards child under 16" under section 146 of the Crimes Ordinance and "common assault" under common law. The number of convictions is updated up to March 2021.
