I. Discussion on the draft Committee Stage amendments

(LC Paper No. CB(1)483/99-00(01) — Committee Stage amendments to be moved by the Administration (Third draft))

At the Chairman's invitation, <u>Deputy Secretary for Information Technology</u> and <u>Broadcasting (DSITB)</u> briefed members on the third draft of the Committee Stage

amendments (CSAs) tabled at the meeting.

(*Post-meeting note*: The third draft of CSAs was circulated to members after the meeting.)

2. At members' suggestion, <u>DSITB</u> undertook to make some minor drafting changes to the CSAs to clauses 23(4), 27 and 27A(1)(a).

II. Matters arising from the eighth meeting

Setting up of advisory committee

3. <u>DSITB</u> advised that having regard to members' views expressed at the last meeting, the Administration agreed to set up an advisory committee to oversee the implementation of the Code of Practice and to consider appropriate amendments to be made in the light of operational experience. The Administration would also review the consultative mechanism for the Code 18 months after the enactment of the Electronic Transactions Ordinance.

Revised draft Code of Practice

4. <u>DSITB</u> advised that the Administration was discussing with the parties concerned on the proposed amendments to the draft Code of Practice and would forward the revised draft to the Bills Committee before the next meeting.

(*Post-meeting note*: The revised draft Code of Practice (LC Paper No. CB(1)559/99-00(07) was circulated to members on 9 December 1999.)

Date of resumption of Second Reading debate

- 5. <u>DSITB</u> advised that the Administration appreciated members' concern about the need for the Bills Committee to have more time to scrutinize the draft CSAs. In the circumstances, the Administration proposed that the date of resumption of the Second Reading debate on the Bill be postponed from 15 December 1999 to 5 January 2000. <u>Members</u> supported this arrangement.
- 6. <u>The Chairman</u> advised that the Bills Committee would report its deliberations to the House Committee on 17 December 1999 and the deadline for giving notice of CSAs was 22 December 1999.
