## **Safety requirements of Holiday Flats**

At the meeting of the Legislative Council Panel on Home Affairs on 27 July 1998, a member enquired about the safety requirements of holiday flats. My reply is as follows-

- (1) The Hotel and Guesthouse Accommodation Ordinance was enacted in 1991 to implement a statutory licensing scheme to regulate the safety of hotels and guesthouses. Since holiday flats are within the scope of the definition of hotel and guesthouse, they need to comply with the safety requirements under the Ordinance and apply for licences for operation.
- (2) Holiday flats are normally converted from the small village houses in the New Territories and are usually in one of the following types-

- (i) the premises is let out for family vacation; or
- (ii) the premises is sub-divided into rooms (similar to guesthouses) for rent.
- (3) The Office of the Licensing Authority of Home Affairs Department has drawn up certain building safety and fire safety requirements for these two types of holiday flats based on their circumstances and needs. I attach a sample list of these safety requirements, as well as that of the guesthouses, for information by the Hon Members. The detailed safety requirements for individual holiday flat or guesthouse will be specified by the Licensing Authority after taking into account its actual condition.

- 10. Toilet shall not open directly into a kitchen
- 11. All unauthorised building works shall be demolished
- 12. The metal entrance gate shall be acceptable to the Licensing Authority
- 13. Clear height in the escape route shall be at least 2m
- 14. Depending on the circumstances of the premises, the Licensing Authority may specify the maximum number of occupants (including staff)
- (2) <u>Fire safety requirements</u>
  - 1. All exit doors shall be readily openable from the inside without the use of a key
  - 2. All fire service installations shall be provided with primary and secondary power supply

- 8. Adequate natural lighting and ventilation shall be provided
- 9. Effluent shall be suitably discharged
- 10. No storage of fuel

- (2) <u>Fire safety requirements</u>
  - 1. Exit signs
  - 2. Manual fire alarm system

- 4. Exit signs and directional signs

The building safety and fire safety requirements will be same as that for the guesthouses (please refer to the left hand column)

- 12. Liquefied petroleum gas cylinder may be allowed when a central gas supply is not available upon first application
- 13. If the premises is more than 126m<sup>2</sup> in area, additional fire service installations (e.g. sprinkler) may be required.
