

**Bills Committee on  
Firearms and Ammunition (Amendment) Bill 1999**

**Administration's Response to Issues/Proposals  
Raised at Previous Bills Committee Meetings**

**I Nature of modified firearms**

Some members suggested that the Administration should relax the control over modified firearms used for TV/film shooting by removing it from the definition of "arms" under the Firearms and Ammunition Ordinance (Cap.238).

2. Section 2(4) of Cap.238 stipulates that an article which would otherwise be within the definition of "arms" shall not be excluded therefrom by reason only of the fact that it is defective or out of repair. Irrespective of whether a firearm is modified for TV/film shooting purpose or deactivated for decoration purpose, it is still within the definition of "arms" under the Ordinance. Removing modified firearms used for TV/film shooting from the definition of "arms" under Cap.238 would weaken the existing control over the possession and use of firearms in Hong Kong.

3. Mr. B J Heard, the head of the Police's Forensic Firearms Examination Bureau (FFEB), demonstrated at the Bills Committee meetings on 19 April 1999 and 4 May 1999 how these modified firearms could be reverted to function like genuine firearms. He clearly pointed out that it was technically feasible for a modified firearm capable of creating the required effect in a TV/film production to be reverted to discharge live ammunition. For the sake of public safety, we therefore have to regulate the possession and use of modified firearms as other types of arms. We will, however, streamline the application procedures to facilitate the use of modified firearms for TV/film shooting as far as practicable. Details are set out in the ensuing paragraphs.

## **II Exemption Permits for possession of modified firearms**

4. Some Members suggested that the Administration should consider allowing a TV/film producer or any specified person to apply and hold exemption permit on behalf of all actors for using modified firearms in a TV/film production. Some kinds of contractual agreements would be made between the exemption permit holder and the actors to set out the responsibilities of both parties to comply with the conditions of the exemption permit.

5. We have consulted the Department of Justice and been advised that under the proposed arrangements, there will be considerable difficulties in taking enforcement action against the exemption permit holder or actors who actually possess and use the modified firearms where there is a breach of the permit condition. The existing control over the possession and use of modified firearms will also be weakened as the Police, being the Licensing Authority, do not know who would actually use the firearms and whether they are fit and proper persons to do so. In addition, we have reservation on the feasibility of the proposal to ask the exemption holder to sign contracts with the actors on the use of modified firearms and whether the idea would be welcomed by the film industry.

6. We believe that the more practical way to facilitate TV/film production in this aspect is to improve the licensing regime to make it more user-friendly. In this connection, the Police have reviewed the existing system and introduced various improvement measures -

- (a) to provide more flexibility to a TV/film producer, the Police have extended the validity period of an exemption permit from two months to four months;
- (b) special arrangements have been made under which the Police Licensing Office will not require applicants for exemption permits to list down the proposed shooting location(s) at the time of their applications. Instead, the location(s) can be approved about three days in advance with the Police Public Relations Branch prior to the actual filming taking place. Shorter notice will also be accepted on

reasonable grounds;

- (c) no restriction would be imposed on the use of modified firearms for TV/filming shooting in the hours between 11 p.m. to 6 a.m. provided that permit holders can comply with the provisions of other legislation such as the Noise Control Ordinance; and
- (d) no restriction would be imposed on the maximum number of modified firearms to be used in TV/film production.

7. We have also examined the feasibility of charging only one actor while waiving the charges for the others for the exemption permits issued for using modified firearms in a single TV/film production with the Finance Bureau. The proposal is not supported because it is the established policy of the Government that recurrent financial assistance provided to private organizations should be by way of subvention/grant instead of fee waiver. At present, fee waiver for the issue of exemption permits is few which concern assistance provided to charitable and nonprofit making organizations.

### **III Inspection of modified firearms**

8. Members are concerned that the proposed regular inspection of modified firearms may interrupt the normal business of the arms dealers.

9. Under the existing system, all modified firearms are required to be inspected by the FFEB before they are firstly used. No subsequent inspection is required. However, experience shows that the modification of a firearm may become ineffective due to the normal wear and tear, improper use or lack of maintenance of the firearm. In addition, as the use of modified firearms for TV/film shooting is not confined to approved ranges, it is more prone to accidents. We therefore believe that there is a genuine need to inspect modified firearms regularly to ensure the safety of the users as well as other people in the vicinity. Our proposal is to inspect each modified firearm at an interval of two years. The inspection will be conducted by the FFEB of the Police.

10. As regards the estimated time that the FFEB would take to inspect a modified firearms, the FFEB expects that they can complete one inspection within several days. The Police would therefore set a performance pledge to complete an inspection of a modified firearm within a week.

#### **IV Power to specify application forms**

11. Members are concerned about the proposal to empower the Commissioner of Police to specify forms under Cap.238. Some members suggested that the Administration should consider setting out the application forms in the Schedule to the Ordinance or stipulating in the Ordinance that substantial changes to the content of the forms are subject to scrutiny by the LegCo.

12. All application forms in the First Schedule to the Firearms and Ammunition Regulations were repealed in 1994 as a consequential amendment introduced by the Security and Guarding Services Ordinance. The amendment was proposed by the Law Draftsman in view of their policy of removing as many prescribed forms as possible from the statute book of Hong Kong.

13. The Department of Justice has confirmed that forms are increasingly being specified administratively instead of being prescribed as subsidiary legislation. Even the Companies Ordinance (Cap.32) was amended in 1997 to empower the Registrar of Companies to specify forms used under that Ordinance. Other examples include applications for liquor licences under the Dutiable Commodities Ordinance (Cap.109), registration or exemption of registration of a local society under the Societies Ordinance (Cap.151), and registration of a design under Registered Designs Ordinance (Cap.522). The replacement of “prescribed forms” by “specified forms” can provide the Administration with the flexibility required to meet the operational requirements in the changing world e.g. the need to adapt to an electronic regime. It is also not a normal practice to stipulate in a legislation that any substantial changes to a “prescribed form” are subject to scrutiny by LegCo as it is very difficult, if not impossible, to define such kinds of changes.

14. To alleviate the possible concerns about the uncertainty arising from the proposed “specified forms”, we suggest requiring the Commissioner of Police to specify forms by publication in the Gazette. that means the Commissioner has to inform the public whenever he makes any changes to an application form used under Cap.238. Such arrangement is more flexible because the forms so specified are not subsidiary legislation.

15. As reported in the previous Bill Committee meetings, the Police are reviewing all application forms used under Cap.238 with a view to enabling applicants to submit all required information at one go. The review has been completed and a set of the revised forms is enclosed at Annex A for Members’ reference. The general licensing criteria are also set out in the information note for each type of licence/exemption permit for reference.

16. In response to Members’ suggestion, we propose to stipulate in Cap. 238 that when processing applications for licence (including the possession licence and dealers’ licence), the Commissioner of Police will consider whether the applicant is a fit and proper person, whether he has a legitimate need to hold the licence and whether there are any objections in terms of public safety and security. Such considerations will also be stipulated in the provisions concerning the renewal and cancellation of licences.

#### **V Limited licence issued under section 30 of Cap.238**

17. Under the existing legislation, a licensed arms dealer is allowed to deal in arms and ammunition by way of trade or business only at the premises specified in the licence (usually refer to the dealer’s shop and armoury). A dealer has to apply for a limited licence under section 30 of Cap. 238 if he/she is required by the Commissioner of Police to transport the arms and/or ammunition to the FFEB for inspection. In the same way, a licensee or a permit holder is required to apply for such limited licence if he/she is required by the Commissioner to submit the arms or ammunition, to which the licence or permit relates, to a designated place (the armoury of the Police Headquarters or FFEB) for

testing. To waive these unnecessary licensing requirements, we propose to make an additional amendment to Cap.238 to allow such transport without obtaining a limited licence.

## **VI Surrender of licences under section 34 of Cap.238**

18. Some Members pointed out that a licensee may not be able to make an appeal under section 35 of Cap.238 once his/her existing licence expires even if he/she intends to do so. It may take some time for the licensee to seek legal advice or to collate information and documents to support the appeal. Under the Amendment Bill, if an appeal is not yet brought (even if the appeal is made later), the licensee is still required to surrender the licence under section 34 of Cap.238.

19. We have re-examined sections 34 and 35 of Cap.238. To cover the scenario mentioned in paragraph 18 above, we propose to amend section 35(2) of the Ordinance to the effect that the obligation to surrender the licence under section 34(2) arises on the expiry of 28 days from the revocation (i.e. the time limit for the submission of an appeal to the Administrative Appeals Board) or after the appeal is disposed of, if an appeal is brought within the 28 days.

## **VIII Required information about shooting clubs**

20. At present, there are 20 licensed shooting clubs. Ten of them have armouries located in the clubs and five of them are clubs for air gun shooting.

21. A copy of the existing licensing conditions for shooting clubs is enclosed at Annex B for Members' reference.

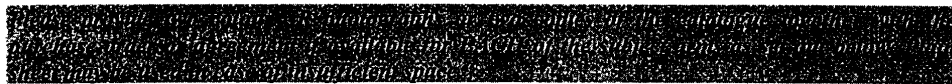

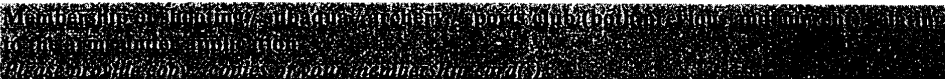

**Existing licence conditions applicable to shooting clubs**

1. The arms and ammunition herein licensed may only be used by a member of the Club. The member must be entered in the Club's register of members in accordance with the constitution of the Club/the member must be entered in the Club's register in accordance with the Companies Ordinance, Cap. 32, Laws of Hong Kong, and have been enrolled as members for not less than 7 days.
2. The licensee may only store arms herein licensed in the armoury of <name of the storage location>
3. The licensee shall notify the Commissioner of Police in writing of any intention to leave Hong Kong for any period exceeding 72 hours prior to his departure (Notification to be made to the Duty Officer, <Name of the Police Station>).
4. When any of the arms and ammunition herein licensed are being used, a qualified Range Officer approved by the Commissioner of Police will be present at all times and firing will be conducted in accordance with range orders on approved ranges.
5. A register shall be maintained to record all movements of club arms. The name Identity Card number of persons with arms are to be recorded. The register is to be kept at the specified premises and shall be available for inspection on request by any police officer/
6. A quarterly return on membership including name, HK I/D Card Number, Chinese Character Code, if applicable, must be forwarded to the Commissioner of Police (Licensing Office) for inspection.
7. Persons other than a member of the Club may carry arms to the <Name of shooting ranges controlled by the Club> for shooting activities only with the prior approval from the licensee who will maintain a written record and he will produce it for inspection by any police officer on demand.
8. The operational hours of the range are restricted between \_\_\_hours to \_\_\_hours.
9. A maximum of \_\_\_\_\_persons may be authorised to hold the keys to the
