Dear Mrs Ma:

Thank you for your letter of 29 February.

- (a) (i) In September 1995 CityU increased its intake on the PCLL from 75 to 90. The target intake figure was reduced from 90 to 45 in 1998 with the goal of raising overall admissions standards. The target intake for September 2000 is 45-60 students.
- (ii) The student body consists of local and overseas LLB graduates and others with equivalent qualifications (for example, the Common Professional Examination). CityU admits students who are graduates from LLB and CPE programmes that are offered locally, the Manchester Metropolitan CPE programme run by SPACE, the London University external LLB programme run by SPACE and the Wolverhampton distance learning LLB programme. CityU also admits graduates from overseas LLB and CPE programmes.

I enclose information (Table 1) about the composition of the PCLL student body over the last 4 years. The information includes details of the number of students admitted and the number of suspensions and withdrawals.

City U does not admit part-time students, although recently the School of Law has informally considered running a part-time PCLL on a full fee-paying basis.

- (iii) CityU has no admission quota for any category of students and does not guarantee places to any group of students. CityU's current policy is to admit to the PCLL the best applicants wherever they come from. The School of Law welcomes applicants from overseas institutions.

- (iv) The School of Law does not have this data in an easily readable form, but we have prepared details of applications for the past 3 years from 1997/8 to 1999/2000 (Table 2). You will see from Table 1 that out of 95 PCLL students admitted in 1997, 50 were CityU LLB graduates. In 1998, 56 out of 61 students were CityU LLB graduates and in 1999 44 out of 56 students admitted were CityU LLB graduates.

The target intake for September 1998 was reduced in April 1998. At that time third year LLB students had legitimate expectations that they would be given PCLL places and some preference was given to their applications.

- (b) Entrants to the PCLL must have good written and spoken English language skills and a first class, upper second class or high second class lower LLB degree or an equivalent qualification and grade. CityU does not accept onto the PCLL all of its own LLB graduates with lower second class degrees.

CityU reserves the right to require entrants to sit an English language test. Until 1998, all entrants took an English language test. No such test was run in 1998 or 1999.

- (c) The above requirements apply to all applicants. As I have said, CityU is looking for the best students wherever they come from.
- (d) The target intake for the next three years is 45-60 students per year.
- (e) Currently all of CityU's PCLL places are UGC-funded. The School of Law has the capacity, however, to admit 100 students in September 2000 and to continue to teach through lectures and regular weekly tutorials in small groups of 9 or 10 students. CityU could increase its intake only by offering full-fee-paying PCLL places. The School of Law is prepared to consider doing this from September 2000 but we would need approval of the University Administration.

To summarise CityU's position:


1. CityU will admit to its PCLL the best applicants wherever they come from.
2. CityU can offer 45-60 places in the next academic year, but could consider offering additional full-fee paying places, subject to the approval of the University Administration.
