## NLCDP service for rural areas

### #(1) 李華明議員（口頭答覆）

新界北區村落每年都受嚴重水浸影響，村民在求助無門的情況下唯有報警求救，就此，政府可否告知本會：

- (a) 村民被困於水浸及心口的屋中，而沒有任何社會服務主動提供支援，原因何在；
- (b) 由於以上地區位處偏僻，嚴重缺乏支援，政府來年會否針對這些鄉效地區的特別需要，增加區內服務；及
- (c) 政府將於短期內削減四隊鄰舍層面社區服務隊，政府會否考慮運用節下來的資源在這些地區設立新的服務隊；若否，原因何在？

## Illegal non-Chinese workers in Hong Kong

### #(2) 蔡素玉議員（口頭答覆）

有人估計，逾期留港的非法外藉（非中國籍）傭工為數達數萬人，政府可否告知本會：

- (a) 當局是否有估計逾期留港的外籍傭工數目；若有，數字為何；
- (b) 政府目前採取了甚麼措施去打擊這些非法傭工；效果如何；
- (c) 過去三年，當局透過街頭截查方式，每年揭發多少宗外籍傭工逾期留港個案；
- (d) 政府會否考慮加重對逾期留港外籍傭工的刑罰，以收阻嚇之效？

## Shortening the waiting time for elderly residential places

- (c) 如需滿足上述輪候數字的住院需要，則當局每年額外增加的財政及人力資源為何；當局會否考慮增加資源以短期滿足所有長者輪候住院需要，以增加就業機會？

## 擬在南丫島興建的氣體發電廠

### #(7) Hon Christine LOH(Written Reply)

Regarding the new gas-fired power plant proposed to be built by Hong Kong Electric Company (HEC) on Lamma Island, will the Government inform this Council:

- (a) What is the Government Economist's forecast of growth in maximum demand in HEC's service area and will these figures be adjusted in light of the recent economic slow-down given that they were based on prevailing economic conditions at the time;
- (b) What Demand Side Management (DSM) programmes are proposed by HEC and how do HEC's estimated savings in demand of 0.1% compare to best international practice;
- (c) What is the precise projected average net tariff increase for electricity following the construction of HEC's new power station;
- (d) Whether the grid interconnection of one of CLP's 312 MW Black Point gas turbine unit, at a cost of HK\$468 million, could be expanded to other CLP units, thus precluding the need for a new power station at Lamma Island;
- (e) Would the Government grant approval to a new coal-powered plant should HEC be unable to reach an agreement on the purchase of gas, or if there is any delay in the construction of a Liquefied Natural Gas terminal in Shenzhen; and
- (f) Whether the government has considered the costs of building a new power plant on the mainland next to a LNG terminal and making this power available to HEC through full interconnection with CLP?
