# **Timetable for Adaptation of Laws Programme**

# **BACKGROUND**

The Adaptation of Laws Programme is essentially a programme to amend all the references in our laws which are inconsistent with the Basic Law or with the status of Hong Kong as a Special Administrative Region of the People's Republic of China.

2. Even though the Hong Kong Reunification Ordinance (110 of 1997) set out how the most important references were to be construed after 1 July 1997, that Ordinance did not actually change the words themselves.

3. Accordingly, we need to introduce further legislation to effect the necessary textual amendments.

### **PROGRESS**

4. The Adaptation of Laws Programme is divided into 2 phases. 6 Bills dealing with essential items were passed by the Provisional Legislative Council. They are -

- (i) the Adaptation of Laws (References to Foreign Country, etc.) Ordinance (23 of 1998);
- (ii) the Adaptation of Laws (Crown Land) Ordinance (29 of 1998);
- (iii) the Adaptation of Laws (Courts and Tribunals) Ordinance (25 of 1998);
- (iv) the Adaptation of Laws (Interpretative Provisions) Ordinance (26 of 1998);
- (v) the Adaptation of Laws (Nationality Related Matters) Ordinance (28 of 1998); and
- (vi) the Merchant Shipping (Registration) (Amendment) Ordinance 1998 (11 of 1998).

5. The second phase of the programme which deals with the adaptation of nonessential items on an Ordinance by Ordinance basis will soon commence.

### **TIMETABLE**

6. The present intention is to introduce around 3 Adaptation Bills at each LegCo sitting starting on 14 October 1998 and ending on 10 March 1999.

7. The Adaptation Bills will have a standard format as shown at Annex A. There will be Schedules attached to each Bill. Each Schedule will deal with one Ordinance. At present, a total of 638 Ordinances which require adaptation are divided into 54 Adaptation of Laws Bills but the number could vary. The proposed format of the Bills would make it easy to add or delete Schedules if necessary.

8. The Legislative Programme as at 16 September 1998 is attached at Annex B.

#### A BILL

То

Adapt certain Ordinance to bring them into conformity with the Basic Law and with the status of Hong Kong as a Special Administrative Region of the People's Republic of China.

Enacted by the Legislative Council.

#### 1. Short title

This Ordinance may be cited as the Adaptation of Laws (No. [ ]) Ordinance 1998.

### 2. Commencement

(1) This Ordinance shall be deemed to have come into operation on 1 July 1997.

(2) Subsection (1) shall be subject to Article 12 of the Hong Kong Bill of Rights set out in Part II of the Hong Kong Bill of Rights Ordinance (Cap. 383).

# 3. Amendment of Ordinances

The Ordinances specified in the Schedules are amended in the manner indicated in those Schedules.

### SCHEDULE 1
