

**Paper for the LegCo Panel on Constitutional Affairs  
for the Meeting on 17 May 1999**

**Provisions containing the reference to “by notice in the Gazette”  
in the Laws of Hong Kong**

**Introduction**

This is an information paper which sets out the nature of “notice in the Gazette” issued under different ordinances in order to assist members of the Panel in their discussion of item No. III on the agenda of the Panel meeting on 17 May 1999. We have set out below a general analysis to enable members to have a general view of the problems involved and to decide the way forward.

**Nature of “notice in the Gazette”**

2. According to our research, there are at least 330 provisions in the Laws of Hong Kong which contain the references to “by notice in the Gazette”. Notices issued under those provisions can be broadly categorized as follows:

- (a) amending a part of the ordinance, e.g. a Schedule or a subsection;
- (b) specifying the day on which an ordinance or a regulation or a provision is to come into operation;
- (c) prescribing or varying fees;
- (d) publishing guidelines for the guidance of the public or a section of the public on how a statutory power or duty is performed;
- (e) where a code or practice is approved, identifying the Code and specifying the day on which the approval is to take effect;
- (f) appointing members of statutory bodies or public officers;
- (g) regulating traffic in the air, on land and in the waters of Hong Kong;
- (h) regulating the banking and securities business;
- (i) granting exemptions from the requirements of the ordinances; and
- (j) specifying forms to be used for the purposes of ordinances.

3. It has been accepted that notices which amend a part of an ordinance and specify commencement dates for legislation are notices with legislative effect and are therefore subject to the scrutiny of the Legislative Council. On the other hand, notices which deal with appointment and the publication of guidelines and codes of practice have not been treated and published as subsidiary legislation. However, some ordinances may provide expressly that a code of practice issued is subsidiary legislation. For example, it is expressly provided in the Road Traffic Ordinance (Cap. 374) that the Road Users' Code issued by the Secretary for Transport under section 109 is deemed to be subsidiary legislation. Notices which specify forms to be used for the purposes of ordinances have not been treated and published as subsidiary legislation.

4. In some ordinances, there are express provisions on whether or not a notice is subsidiary legislation. In the absence of such express provision, the way in which notices in the Gazette have been treated varies from ordinance to ordinance even though those notices may be issued for similar purposes. Most of the notices that are regulatory in nature have been published as legal notices. Examples of these notices are those issued by the Monetary Authority under the Banking Ordinance (Cap. 155) which aim at regulating the banking business. Likewise, most of the notices that prescribe or vary fees have been treated as subsidiary legislation.

5. However, there has not been uniformity in treatment of notices relating to regulating traffic and granting exemptions. The way notices of these types have been treated in various Ordinances is set out in the table at Annex A.

### **Recommendation**

6. The inconsistency in the treatment of "notice in the Gazette" has raised a fundamental issue of whether the existing legislative mechanism for the Legislative Council to monitor the exercise of power to make subsidiary legislation should be examined in order to provide a clear means of identifying which of the instruments (including those which bear different titles such as rules, orders etc.) with legal effect made by persons under delegated authority provided by statute should be subject to the Council's scrutiny. Members may consider whether it is necessary to invite the Administration to participate in the discussion of the issue.
