An Open Letter to the Honourable Members of the Legco Health Panel, Health and Welfare Branch and Chiropractors Council

Dear Sir/Madam:

Re: The Registration of Chiropractors and the HKCA

I am writing in support of the Hong Kong Chiropractors' Association (HKCA) as the representative of the majority of Chiropractors in the proceedings for the Registration of our profession.

Presently, the HKCA represents 43 out of the 48 Chiropractors practising in the HKSAR. I recognise the HKCA as the voice of the majority of Chiropractors practising in HKSAR and I fully support the rule of the majority. The democratic principle as adhered to by the HKCA is exemplified by the one-member-one-vote system of voting of all HKCA members on issues including our Code of Practice, the registration guidelines, membership admission requirements and for the elections of our officers.

I fully support the HKCA for upholding and improving the Chiropractic standard and ethical practice as our professional responsibility to the general public. I fully support and abide by the current implementation of the HKCA Code of Practice, which is an exact copy of the Draft of the Code of Practice of the Chiropractors Council, as a measure to ensure that Hong Kong will have an internationally recognized Chiropractic profession.

I fully support the immediate registration of all qualified Chiropractors practising in the HKSAR which has been pending for five years now.

I urge the Honourable Members of the Legco Health Panel, the Health and Welfare Branch, and the Chiropractors Council to facilitate the implementation of our professional registration without any further delay - in the best interest of the general public and based on the fair and democratic representation of the views of the Chiropractors practising in Hong Kong.
