and Broadcasting Panel****Progress of Year 2000 Compliance Work within Government****Purpose**

At the last meeting of the Legislative Council Information Technology and Broadcasting Panel held on 8 March 1999, Members asked for a breakdown of the Y2K compliance positions of individual Government bureaux/departments. The requested information is set out in this paper.

Overall progress

2. As reported in the paper entitled "Year 2000 Compliance within Government and in Non-Government Organisations Funded on Regulated by Government" (LC Paper No. CB(1)942/98-99(01)), as at 15 January 1999, 90% of Government's mission-critical¹ computer and embedded systems were confirmed to be compliant or had been rectified. A breakdown of the remaining 10% is as follows -

- non-compliant systems the rectification for which is under way (8%);
- non-compliant systems which can be rectified by resetting the clock on or after 1 January 2000 (1%);
- systems with compliance status being verified (1%).

3. Of the non-compliant systems which are being rectified, 97% of them will be rectified by June 1999. The remaining 3% will be rectified by the end of 1999 at the latest. For those systems which cannot be rectified by June 1999, the concerned Government departments have already formulated contingency plans to ensure that services provided to the public will not be

¹ Mission-critical systems are those computer and embedded systems whose proper functioning is related to public health and safety, the provision of critical services to the public, or payment and revenue collection.

disrupted.

4. For those systems whose Y2K compliance status is being verified (mainly building services systems and line communications systems), the Electrical and Mechanical Services Department (EMSD) and the Office of the Telecommunications Authority (OFTA) target to complete the verification work as soon as possible so that rectification work, if required, could proceed right away. For those systems which cannot be rectified by end June 1999, contingency plan will be drawn up.

5. A breakdown of the Y2K compliance positions of individual Government bureaux/departments are set out at the Annex.
