- (b) service under the East Africa High Commission, the East African Common Services Organization, the East African Posts and Telecommunications Administration, the East African Railways and Harbours Administration, the East African Community, the East African Harbours Corporation, the East African Posts and Telecommunications Corporation, the East African Railways Corporation or any of their successor authorities; (Replaced 34 of 1970 s. 2. Amended 36 of 1987 s. 36)
- (c) service which is pensionable—
  - (i) under the Oversea Superannuation Scheme;
  - (ii) under any Acts relating to the superannuation of teachers in the United Kingdom;
  - (iii) under a local authority in the United Kingdom; or
- (iv) under the National Health Service of the United Kingdom;
- (d) any other service that the Governor has determined to be public service for the purposes of this Ordinance; (Amended 36 of 1987 s. 36)
- (e) except for the purposes of computation of a pension or gratuity and of section 9, service in respect of which a pension may be granted under the Governor's Pensions Act 1957 (1957 c. 62 U.K.) or the Governors' Pension Scheme 1979 or any Act or Scheme amending or replacing that Act or Scheme; (Amended 36 of 1987 s. 36)
- (f) service as the holder of the office of President, Vice-President, Justice of Appeal, Registrar, officer or servant of the Court of Appeal for Eastern Africa or the Court of Appeal for East Africa; (Replaced 34 of 1970 s. 2)
- (g) service in the service of the Interim Commission for the West Indies; (Added 13 of 1966 Schedule)
- (h) pensionable service with the British Telecommunication and the Post Office, United Kingdom of Great Britain and Northern Ireland; (Added 34 of 1970 s. 2. Amended 36 of 1987 s. 36)
