SPECIAL FINANCE SCHEME FOR SMALL AND MEDIUM ENTERPRISES

INTRODUCTION

This paper informs Members of the progress of the Special Finance Scheme for small and medium enterprises (SMEs).

BACKGROUND

The Scheme is part of the package of special relief measures announced by the Government on 22 June 1998. The purpose of the Scheme is to help SMEs to cope with the liquidity crunch problem and to secure bank loans to meet genuine commercially viable business needs. We briefed the Panel on the Scheme at its meeting on 22 July 1998.

LATEST POSITION

- On 31 July 1998, the Finance Committee of the Legislative Council approved the financial commitment of \$2.5 billion for the establishment of the Scheme. We invited all authorised institutions under the Banking Ordinance to participate in the Scheme in early August. The Scheme was launched on 24 August.
- 4. Participating authorised institutions (PAIs) are requested to sign a deed with the Government which set out the rights and obligations of both parties under the Scheme. As of 3 September 1998, a total of 62 lending institutions

have signed the deed to take part in the Scheme. Another 2 lending institutions have also confirmed their interest in participation. A list of the PAIs is at Annex.

Publicity

- 5 In order to widely publicise the Scheme, the Government has launched a series of promotional activities. These include:
 - newspaper supplements at Hong Kong Economic Times, Hong Kong Economic Journal and Ming Pao on 24 August 1998;
 - newspaper and magazine advertisements;
 - 50,000 leaflets for distribution to SMEs through Government departments, district offices, major industrial and trade organisations and PAIs;
 - 1,00 posters for display at PAIs, major industrial and trade organisations and Government's poster boxes;
 - announcement of public interest on TV and radio stations;
 - panel advertisements at the MTR platforms; and
 - briefing sessions and talks for industrial and trade organisations and PAIs.

Besides, hot lines have been set up in both Industry Department and the Treasury to answer public enquires on the Scheme. Information about the Scheme and relevant contacts of PAIs have also been put on the Industry Department's homepage on the Internet.

Responses to the Scheme

6 The Scheme has attracted considerable interest from SMEs and the public. The Industry Department and the Treasury received hundreds of

enquiries on the Scheme in August. As of 3 September 1998, the Scheme has received and approved 3 applications.
