TOYS AND CHILDREN'S PRODUCTS SAFETY ORDINANCE (AMENDMENT OF SCHEDULE) NOTICE 1998

(Made under section 6 of the Toys and Children's

Products Safety Ordinance (Cap. 424))

1. Commencement

(1) This Notice, other than section 2(f) and (g), shall come into operation on 28 November 1998.

(2) Section 2(f) and (g) shall come into operation on 1 January 1999.

2. Schedule amended

(B) in column 3, by adding "AMD 9270:1996" opposite to "BS 7409:1996" in column 2;

(ii) in relation to the entry for "兒童手推車" in column 1, in columns 1 and 2, by repealing "兒童手推車" and substituting "兒童推車".
