#(5) 李華明議員 (口頭答覆)

政府正調查將軍澳填海區出現不正常土地沉降現象是否與正在施工的策略性污水排放計劃(“排污計劃”)首期工程有關。就此，政府可否告知本會：

- (一) 有否評估排污計劃工程對全港有關地區可能造成的影響；若有，該等影響為何；若沒有評估，原因為何；
- (二) 當局何時得知將軍澳填海區出現不正常沉降；其後曾採取甚麼應變措施以防止沉降的現象惡化；有否向公眾交代該事件；及
- (三) 將軍澳有哪些樓宇及建築物受到是次不正常沉降現象所影響；當局會否為這些樓宇進行詳細勘察，以確定該等樓宇結構安全，以及會否負責解決該等樓宇因土地不正常沉降而引起的維修及保養問題？

(5) Hon Fred LI (Oral Reply)

The Government is examining whether or not the unusual site settlement occurring on the reclaimed land in Tseung Kwan O is related to the construction works of the Strategic Sewage Disposal Scheme (“SSDS”) Stage I currently in progress. In this connection, will the Government inform this Council:

- (a) whether it has evaluated the possible impacts of the SSDS construction works on the relevant districts throughout the territory; if it has, of the details of the impacts; if it has not, of the reasons for that; and
- (b) of the time when the authorities became aware of the unusual settlement occurring on the reclaimed land in Tseung Kwan O, the contingency measures they have subsequently taken to prevent the settlement from deteriorating, and whether they have given an account of this incident to the public; and
- (c) of the buildings and structures in Tseung Kwan O which have been affected by the unusual settlement; whether the authorities will conduct detailed inspections of these buildings to confirm that they are structurally safe; and whether they will take up the responsibility for solving the repair and maintenance problems caused to these buildings that have been affected by the unusual site settlement?
