Bills

First Reading

Industrial Training (Clothing Industry) (Amendment) Bill 1999

The Bill was read the first time and ordered to be set down for Second Reading pursuant to Rule 53(3) of the Rules of Procedure.

Second Reading

Industrial Training (Clothing Industry) (Amendment) Bill 1999

The Secretary for Trade and Industry moved the Second Reading and addressed the Council.

Question on the Second Reading proposed. The President stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Customs and Excise Service Children's Education Trust Fund Bill

Resumption of Second Reading debate

The debate on the Second Reading which had been moved on 23 June 1999 resumed.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a Committee of the whole Council.

Committee Stage

The Council went into Committee and considered the **Customs and Excise Service Children's Education Trust Fund Bill**.

Question that clauses 1, 2 and 7 to 12 stand part of the Bill proposed, put and agreed to.

Question that clauses 3 to 6 stand part of the Bill proposed.

The Secretary for Trade and Industry moved amendments to clauses 3 to 6 and addressed the Committee.

Question on the amendments put and agreed to.

Question that clauses 3 to 6, as amended, stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

had passed through Committee with amendments. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Protection of the Harbour (Amendment) Bill 1999

Resumption of Second Reading debate

The debate on the Second Reading which had been moved on 3 November 1999 resumed.

Five Members spoke on the Bill.

The Secretary for Planning, Environment and Lands replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a Committee of the whole Council.

Committee Stage

The Council went into Committee and considered the **Protection of the Harbour (Amendment) Bill 1999**.

Question that clauses 1 to 6 stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Planning, Environment and Lands reported that

the **Protection of the Harbour (Amendment) Bill 1999**

had passed through Committee without amendment. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Adaptation of Laws (No.29) Bill 1999

Resumption of Second Reading debate

The debate on the Second Reading which had been moved on 14 July 1999 resumed.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a Committee of the whole Council.

Committee Stage

The Council went into Committee and considered the **Adaptation of Laws (No.29) Bill 1999**.

Question that clauses 1, 2 and 3 stand part of the Bill proposed, put and agreed to.

Question that schedules 1 to 9 stand part of the Bill proposed, put and agreed to.

Question that schedules 10 and 11 stand part of the Bill proposed.

The Secretary for Security moved amendments to schedules 10 and 11 and addressed the Committee.

Question on the amendments put and agreed to.

Question that schedules 10 and 11, as amended, stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Security reported that

the **Adaptation of Laws (No.29) Bill 1999**

had passed through Committee with amendments. She moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Motions

Proposed resolution under the Factories and Industrial Undertakings Ordinance

The Secretary for Education and Manpower moved the following motion and addressed the Council:

Resolved that the Factories and Industrial Undertakings (Safety Management) Regulation, made by the Commissioner for Labour on 8 November 1999, be approved.

Question on the motion proposed.

Three Members spoke on the motion.

The Secretary for Education and Manpower replied.

Question on the motion put and agreed to.

Members' Motions

Freezing and reducing fees and charges

Hon LEE Wing-tat moved the following motion and addressed the Council:

That, in view of the uncertain economic prospects and the persistently high unemployment rate in Hong Kong, this Council asks the Government to continue to freeze the various government fees and charges relating to people's livelihood in the year 2000 and urges the various public utility corporations to reduce their charges in the coming year, in order not to increase the burden on the public and slow down Hong Kong's economic recovery.

Question on Hon LEE Wing-tat's motion proposed.

The President stated that Hon HO Sai-chu would move an amendment to the motion. In accordance with the Rules of Procedure, the motion and the amendment would be debated together in a joint debate.

Hon HO Sai-chu moved the following amendment to Hon LEE Wing-tat's motion and addressed the Council:

To delete "in view of the uncertain economic prospects" and substitute with "as the local economy has not fully recovered"; to delete "persistently high"; to delete "in Hong Kong" and substitute with "remains persistently high"; to add "trades and industries as well as" after "the various government fees and charges relating to"; to delete "reduce" from "urges the various public utility corporations to reduce their charges" and substitute with "freeze"; and to add "the commercial and industrial sectors as well as" after "in order not to increase the burden on".

Question on Hon HO Sai-chu's amendment to Hon LEE Wing-tat's motion proposed.

A Member spoke on the motion and the amendment.

At 5:42 pm, the President's Deputy took the chair during the temporary absence of the President.

Another 11 Members spoke on the motion and the amendment.

Hon LEE Wing-tat spoke on the amendment.

The Secretary for the Treasury spoke on the motion and the amendment.

At 6:52 pm, the President resumed the chair.

Question on Hon HO Sai-chu's amendment to Hon LEE Wing-tat's motion put.

Hon LEE Wing-tat and Hon HO Sai-chu claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 25 were present, 13 were in favour of the amendment, eight against it and four abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 22 were present, five were in favour of the amendment, six against it and 10 abstained. (Voting record in Appendix I.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon LEE Wing-tat replied.

Question on Hon LEE Wing-tat's motion put.

Hon LEE Wing-tat claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 25 were present, eight were in favour of the motion and 17 against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 22 were present, 13 were in favour of the motion and eight against it. (Voting record in Appendix II.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the motion was negatived.

Allocation of secondary school places to boys and girls

Hon Christine LOH moved the following motion and addressed the Council:

That this Council urges the Administration to fulfill its responsibility under the law and remove the discriminatory elements in the Secondary School Places Allocation System, and to ensure that, from the year 2000, boys and girls are placed

into secondary schools in a manner that does not unlawfully discriminate against either sex.

Question on the motion proposed.

Eight Members and the Secretary for Education and Manpower spoke on the motion.

Hon Christine LOH replied.

Question on the motion put and agreed to.

Next Meeting

The President declared that the next meeting of the Council would be held on 1 December 1999 at 2:30 pm.

The Council was adjourned at 8:24 pm.
