**Members' Motion**

**Resumption of debate on the "Motion of Thanks"**

The debate on the Motion of Thanks moved by Dr Hon LEONG Che-hung and the amendment to the motion moved by Hon Martin LEE on 20 October 1999 resumed.

Dr Hon LEONG Che-hung spoke on Hon Martin LEE's amendment.

The Financial Secretary, the Secretary for Trade and Industry, the Secretary for Economic Services, the Secretary for Planning, Environment and Lands, the Secretary for Housing, the Secretary for Transport, the Secretary for Information Technology and Broadcasting, the Secretary for Education and Manpower, the Secretary for Home Affairs, the Secretary for Health and Welfare, the Secretary for Constitutional Affairs, and the Chief Secretary for Administration spoke on the motion and the amendment.

Question on Hon Martin LEE's amendment put.

Hon Martin LEE claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, three were in favour of the amendment and 24 against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 30 were present, 13 were in favour of the amendment and 16 against it. (Voting record in Appendix I.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Dr Hon LEONG Che-hung replied.

Hon Martin LEE requested the President to suspend the meeting for 5 minutes to enable the Members of the Democratic Party to discuss how they would vote on the motion.

The President approved the request and suspended the meeting at 5:40 pm.

At 5:45 pm, the Council resumed.

Question on Dr Hon LEONG Che-hung's motion put.

Dr Hon LEONG Che-hung claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, 24 were in favour of the motion and three against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 30 were present, 16 were in favour of the motion and 13 against it. (Voting record in Appendix II.) Since the question was agreed by a majority of each of the two groups of Members present, she declared that the motion was carried.

#### **Next Meeting**

The President declared that the next meeting of the Council would be held on 3 November 1999 at 2:30 pm.

The Council was adjourned at 5:52 pm.
