Reply :

- (a) There will not be any increase or decrease in the number of posts. The increase in provision is for expenses for youth development programmes.
- (b) The main increases arise from the transfer of the administration of subventions to uniformed groups and miscellaneous group and community work services provided by the Hong Kong Award for Young People and the Agency for Volunteer Service from the Social Welfare Department to the Home Affairs Bureau. These uniformed groups and youth organisations will continue to operate the youth development programmes previously funded by the Social Welfare Department. No significant changes in the implementation and vetting procedures are envisaged.

Question : Under the key performance measures in respect of district and community relations, the Bureau estimated that there would be a decrease in the "statutory and charitable funds income" in 2000. What are the reasons for this?

Asked by : The Hon. Cheng Kar-foo

Reply :

\$66 million represents the total incomes of eleven trust funds. The incomes of these trust funds consist of dividends from shares, interest from bonds and bank deposits and donations. The amounts which can be generated each year are influenced by factors beyond the control of Home Affairs Bureau or the relevant boards and committees.

2. The estimate for 2000 was prepared at a time when the actual figure for 1999 was not yet available. Our forecast then was that it should be slightly better than the original estimate of \$65 million for 1999. Given the 1999 actual figure, the estimate of \$66 million for 2000 is conservative. We shall do our best to generate a total income higher than the figure.

Question : (a) The Culture Section of the Home Affairs Bureau has taken up the funding responsibility for the Hong Kong Arts Festival Society and the Hong Kong Philharmonic Society. How much funding will the Culture Section provide to each society for 2000/01? How do these subventions compare with those provided by the Provisional Urban Council for 1998/99 and 1999/2000?

(b) What are the estimated staffing level and expenditure required to provide secretariat and administrative support to the Culture and Heritage Commission?

Reply :

(a) Government provision to the Hong Kong Arts Festival Society (HKAFS) and the Hong Kong Philharmonic Society (HKPS) for 2000/01 will be \$16.12 million and \$64.6 million respectively.

For the HKAFS, the provision of \$16.12 million for 2000/01 is similar to that for 1999/2000 provided both by the then Provisional Urban Council (PUC) (\$7.8 million) and the Hong Kong Arts Development Council (HKADC) (\$8.32 million). The total provision for 1998/99 provided by the then PUC (\$8.617 million) and the HKADC (\$8.32 million) is \$16.937 million.

As regards the HKPS, the provision of \$64.6 million for 2000/01 will be generally in line with the amount of \$64.566 million for 1999/2000 provided by the then PUC. The provision for 1998/99 is \$68.714 million.

As in the case of other subvented bodies, funding for both HKAFS and HKPS is subject to the Government's Enhanced Productivity Programme.

- (b) Within the Culture Section of the Home Affairs Bureau, one Administrative Officer Staff Grade 'C' and one Senior Administrative Officer will be deployed to provide secretariat support to the Culture and Heritage Commission (CHC). Apart from secretariat support to the CHC, this team is also responsible for arts and culture policy as well as matters relating to the Hong Kong Arts Development Council, the Hong Kong Academy for Performing Arts and Hong Kong Arts Centre. The Bureau has earmarked \$2 million in the 2000/01 budget to cover the general administrative expenses (researches, publication of reports, etc) of the CHC.

The approved provision for District and Community Relations is \$41.6 million for 1999-2000 and the revised provision is \$62.1 million.

Please explain why the revised provision has increased by almost 50% over the approved estimate; and why the estimate for 2000-01 drops significantly by 38.2% to 38.4 million.

Asked by : The Hon Bernard Chan

Reply :

The 1999-2000 approved provision for District and Community Relations is \$41.6 million, which has not included the capital expenses of the commitments for the National Day Celebration in 1999 and the Millennium Celebration. These items were subsequently approved by Secretary for the Treasury under delegated authority during the course of 1999-2000 when the programme details had been worked out. As such, there is a significant increase in provision for 1999-2000 Revised Estimates in respect of Programme 3.

As regards a decrease in the provision in 2000-01 for Programme 3, it is partly due to the reduced cashflow for the Millennium Celebration from \$8.6 million in 1999-2000 to \$1.4 million in 2000-01. In addition, as programme details for the Celebration of the third anniversary of HKSAR establishment and the National Day Celebration in 2000 have yet to be finalised when the 2000-01 Estimates are prepared, commitments for these two projects have not been included in 2000-01 Estimates. This also accounts for a drop in the provision for 2000-01 Estimates when compared with the 1999-2000 Revised Estimates for this Programme. We will seek funding approval for these two activities in the usual manner when details have been finalised.

Please explain in detail the plan of the Home Affairs Bureau to review the Personal Data (Privacy) Ordinance in 2000-01 and its resource implications.

Asked by : The Hon CHOY So-yuk

Reply :

The current review of the Personal Data (Privacy) Ordinance seeks to address the operational difficulties encountered since its commencement in December 1996 and put beyond doubt the meanings of particular provisions. The proposed amendments to the Ordinance arising from the review will mainly be of a technical nature and will not involve major policy changes.

The matters under consideration include, for example, whether the guidelines issued by the Privacy Commissioner for Personal Data (“PC”) should have legal effect on not only data users but also data subjects, whether the term “direct marketing” used in the Ordinance should include the offering of social services to persons in need of such services and whether personal data transferred to the Public Records Office should be exempted from the provision in the Ordinance which prevents such transfer. One proposal which has policy implications relates to the question whether parents should have the right to access the personal data of their children. On this proposal, we have been consulting organisations representing social workers, doctors, teachers, parents and children.

We intend to consult the relevant panel of the Legislative Council before introducing any legislative amendments. We hope to be able to finalise the proposals within the year 2000.

The review itself does not entail any additional resources. We shall examine the resource implications of the amendment proposals after the proposals have been finalised. In the meantime, no additional resources have been proposed in the draft Estimates.

The provision to be transferred from Social Welfare Department to Home Affairs Bureau arises from the transfer of the administration of subventions to uniformed groups from the former to the latter. The amount in 2000-2001 comprises –

- (a) \$43,181,000, being subventions to uniformed groups, Hong Kong Award for Young People and Agency for Volunteer Service for organising youth development activities; and
- (b) \$930,000, being expenses related to the subventions to these groups.

The transfer is cost neutral and does not involve significant changes in the planning, operation or nature of the youth development programmes that have been and will continue to be provided by these groups.

Please provide an analysis of the financial provisions to the Hong Kong Sports Development Board (SDB) for the past 3 years (1998-2001). How will the Bureau Secretary assess the effectiveness of the Hong Kong Sports Development Board (SDB) in the promotion of sports? What is the percentage of staff remuneration in the total expenditure of the Board? Does the Board have any plans to reduce its staff?

Reply :

The recurrent subventions to the SDB over the past three years have been as follows –

1998-99	\$192.781 million
1999-2000	\$200 million
2000-01	\$195.19 million

We assess the effectiveness of the Board's work in promoting sport by considering the number of programmes organised and the participation therein, the percentage of expenditure made available to National Sports Associations, and the number of events

supported locally. As well as promoting sport, the Board also plays a key role in training Hong Kong's top athletes for major international competitions, and we monitor the achievements of local athletes in the international sports arena.

For 2000-2001 we estimate the SDB's payroll and related expenses as follows –

- administration and public relations: \$15.4 million (5.3% of expenditure budget)
- commercial activities: \$14.6 million (5.0 % of budget)
- sports development and promotion: \$25.6 million (8.8% of budget)
- elite training programme: \$68.4 million (23% of budget)

In the past two years the Board has adopted a policy of zero growth in permanent staff headcount. In 2000-01 savings of \$0.62 million on staff expenditure will contribute to an overall EPP saving of \$3.48 million. With the implementation of the new sports administration structure, the Board is looking at the potential for reducing its permanent staff.

The subventions to the Hong Kong Philharmonic Society (HKPS) for the past 3 years (1998-2001) are as follows: -

1999/2000	: 64.56
2000/2001	: 64.6

We are in the process of discussing a service agreement with the HKPS with performance targets and indicators. The future performance of the HKPS will be assessed according to its achievement of the targets and indicators, and this will form the basis of evaluation for future subventions. The "Guidelines on the Management and Control of Government Subventions" which are applicable to all Government subvented bodies will be adopted in the vetting of HKPS' budgets and monitoring of its

use of subventions. As in the case of other subvented bodies, funding for HKPS would also be subject to Government's Enhanced Productivity Programme.

With the dissolution of the former Provisional Urban Council, which used to appoint six members to the General Committee responsible for the day to day operation of the HKPS, there is a need to reconsider the composition of the Committee. HKPS is in discussion with the Administration on this matter.

Will the Council's resources for its research programmes be re-allocated to the Culture and Heritage Commission after it is established? How much are the existing resources of the Council?

Reply :

Recurrent subvention provided by Government to the Hong Kong Arts Development Council (ADC) in the past three years increased from \$82.3 m in 1997-98 by 33% to \$109.7 m in 1998-99 and by a further 3.4% to \$113.4 m in 1999-2000. The provision for 1999-2000 has taken account of the EPP (Enhanced Productivity Programme) requirement which applies across the board to all subvented bodies. In addition, disbursements of \$29.9 m in 1997-98, \$24.2 m in 1998-99 and \$12.9 million (up to February 2000) from the Arts and Sport Development Fund were allocated to the ADC to support eligible arts projects.

The ADC is an independent body with its own Secretariat. The Home Affairs Bureau has been working closely with the ADC to ensure that it carries out its work smoothly and effectively.

Apart from providing secretariat support, the Home Affairs Bureau has earmarked \$2m in the 2000-01 budget to cover the general administrative expenses, including research projects, of the Culture and Heritage Commission (CHC). In 1999-2000, the ADC spent some \$0.7 m on research projects. ADC is not required to reallocate its resources for research programmes to the CHC after CHC's establishment.

The Scheme aims at providing opportunities for young people to visit the Mainland with a view to enhancing their understanding of the history, culture and the political, economic and social systems of China, and to cultivate a sense of belonging among themselves.

It was first introduced in 1998 when we provided subsidies of about \$6 million to enable non-governmental organisations to organise 82 study tours involving 4,000 young people. In 1999, \$8 million have been approved to subsidize 165 applications under the Scheme, enabling 5,400 young people to participate in these sponsored tours.

Reply : a) Out of the 42 temporary posts, 27 will be created for organising activities to celebrate the Third Anniversary of the Establishment of the Hong Kong Special Administrative Region (HKSAR) and the National Day in 2000, and the remaining 15 for organising projects and activities to celebrate the new Millennium.

The 42 posts include the following:

- (i) 1 Administrative Officer of Staff Grade C rank;
- (ii) 4 Chief Executive Officers;
- (iii) 6 Senior Executive Officers;
- (iv) 4 Executive Officers I;
- (v) 2 Executive Officers II;
- (vi) 2 Personal Secretaries I;
- (vii) 6 Personal Secretaries II;
- (viii) 1 Clerical Officer;
- (ix) 10 Assistant Clerical Officers;
- (x) 5 Clerical Assistants; and

(xi) 1 Workman II.

The activities to be organised in 2000-01 to celebrate the Millennium include:

- (i) the Coming of Age Ceremony on 4 May 2000;
- (ii) the French Riding Performance from 12 to 14 May 2000;
- (iii) the Opening of the Chi Lin Nunnery on 18 May 2000;
- (iv) the Children's Reading Pledge from June to late 2000;
- (v) the International Harmony/Asian Extravaganza in August 2000;
- (vi) the 100 Years of Hong Kong Fashion Exhibition from August to September 2000;
- (vii) the International Basketball Cup from 2 to 6 September 2000; and
- (viii) the European Christmas Carnival from December 2000 to early 2001.

Other than the above activities, a number of capital projects have been launched in order to make the new Millennium more memorable. The projects, which will be completed in 2000-2001 include:

- (i) the establishment of the Chinese Cuisine Training Institute;

In the estimate for 2000-01, it has set aside a provision of \$3.1m under Subhead 270 "Activities to promote equal opportunities" for organising promotional activities on equal opportunities. - b. Will provisions be reserved under Subhead 270 for organising promotional activities on the ICCPR and publishing the text of the said Covenant and the Government's report on the Covenant? Will there be an increase or a decrease in the number of copies to be

- c. Will provisions be reserved under Subhead 270 for allocation to non-governmental organisations' (NGOs') upon applications for organising promotional activities on the ICCPR? If so, what is the quota available for application by the NGOs? How much each NGO may apply for?
- d. Will provisions be reserved under Subhead 270 for implementing the recommendations made by the UN Human Rights Committee in relation to the ICCPR? If so, what is the amount of provision available for each recommendation? In what ways each recommendation be implemented?

Reply :

- a. Ten Government officials attended the hearing. The total expenses incurred were \$466,000.
- b. Subhead 270 is created for organising activities for the promotion of equal opportunities. This is ancillary to – and in accordance with – the provisions of the ICCPR and other human rights treaties. We have not reserved funds under this subhead specifically for the promotion of the ICCPR. But a promotional leaflet and booklet designed for that purpose will be published later this year. The costs will be met from the Information Services Department's General Publicity Vote. The initial cost of publishing the Covenant itself and our reports under the Covenant and other treaties is met in the year of publication from "General Departmental Expenses" (Subhead 149). Thus, the ICCPR report was paid for in 1998-99 when we issued 3,500 copies. Our practice is to make subsequent reprints on a demand basis. However, we still have stocks of the

Covenant and the report. All are readily accessible on our homepage. So we do not envisage a need to re-print them in the near future. Should we do so, the costs will be absorbed under "General Departmental Expenses".

- c. As stated in (b) above, Subhead 270 does not cover the promotion of the ICCPR. The Funding Scheme under this Subhead is for community-based, NGO-run, projects for the promotion of equal opportunities in the areas of race and sexual orientation.

- d. The recommendations of the Human Rights Committee cover several different policy areas. The relevant bureaux are examining the recommendations under their purview. It will be for them to determine what, if any, follow-up action may be appropriate and the resources, if any, that may be necessary for that purpose. Any such resources would need to be met under the appropriate subhead. As far as the Home Affairs Bureau is concerned, any follow-up work will be absorbed within existing resources.

- (c) Of the provision under Subhead 270, will there be any allocation for conducting reviews and studies on legislation in the areas of discrimination on the grounds of race, age and

sexual orientation? If so, how much will be reserved for each area?

- (d) Of the provision under Subhead 270, will there be any allocation for organising activities to eliminate discrimination on the grounds of age, sex, disability and family status, and for organising activities to promote the International Covenant on Economic, Social and Cultural Rights (ICESCR), the Convention Against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment (CAT), the Convention on the Rights of the Child (CRC) and the International Convention on the Elimination of All Forms of Racial Discrimination (ICERD)? If so, how much will be allocated for each type of promotional activity? How many projects can be organised for each type of activity and what are their contents?
- (e) Of the provision under Subhead 270, will there be any allocation for application by NGOs to organize activities to eliminate discrimination on the grounds of age, sex, disability and family status, and to promote the ICESCR, the CAT, the CRC and the ICERD? If so, what is the quota available to NGOs for application in respect of each type of activity? How much may each NGO apply for?

Reply :

- (a) We plan to spend \$2.5 million under Subhead 270 on the promotion of equal opportunities in the areas of race and sexual orientation. The programmes will include the Equal Opportunities (Race and Sexual Orientation) Funding Scheme; Announcements of Public Interest on television; advertisements on public transport; promotional leaflets, posters and booklets; exhibitions; and production of "Guide to Services in Hong Kong" for migrant workers. The Funding Scheme is among the administrative measures through which we are addressing the issues. Past examples include the Codes of Practice Against Discrimination in Employment on the grounds of Race and Sexual Orientation which we published in 1998. This year we have reserved \$1.5 million for the Funding Scheme.

- (b) The Funding Scheme referred to in (a) above is specifically designed to encourage NGOs to initiate community-based projects for the promotion of equal opportunities in the areas of race and sexual orientation. We do not set a quota on the number of such projects or on the amount of each application (though, to encourage wider participation, we ask NGOs not to pitch their bids much over \$100,000). Nor are the amounts allocated to the two areas of discrimination distributed on the basis of a pre-determined ratio. The amount granted for each project will depend on the number of applications and the merits of the individual proposals. By way of illustration, a total of 20 projects were funded under the 1999-2000 Scheme. Of those, 14 (costing a total of \$725,710) related to race; six (costing a total of \$360,000) related to sexual orientation.
- (c) The ambit of this subhead covers activities for the promotion of the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW) and of equal opportunities in the areas of race and sexual orientation; age discrimination falls under the Education and Manpower Bureau. Therefore we have not reserved any amount under this subhead for the review and study of anti-discrimination legislation. Any such activities could be carried out within other existing resources.
- (d) The ambit of this subhead is explained in (c) above. It does not cover the promotion of the ICESCR, the CAT, or the CRC. Discrimination on the grounds of disability and age is under the respective purview of the Health and Welfare Bureau and the Education and Manpower Bureau. The promotion of the ICESCR, the CAT and the CRC will be met from other existing resources.
- (e) The ambit of this subhead is explained in (c) above. As explained in

(a) above, we have set aside \$1.5 million under this subhead for a Funding Scheme for NGOs to apply for funds to organise activities in the areas of race and sexual orientation which could include promotion of the ICERD. In view of the ambit of this subhead, no resources have been allocated under it for NGOs to organise activities related to the other subjects mentioned in this part of the question.

(a) Under Subhead 270, \$600,000 has been earmarked for the promotion of the United Nations Convention on the Elimination of All Forms of Discrimination against Women (CEDAW). For this purpose, a number of publicity and educational programmes are being planned for 2000-01, including production and distribution of promotional materials, such as booklet, chess set and CD-ROM, and staging of exhibitions and seminars.

(b) In the past two years, 10,000 and 3,500 copies of CEDAW and HKSARG's Initial Report on CEDAW were printed respectively for distribution to members of the Executive Council, the Legislative Council, the then Municipal Councils and District Boards, as well as women's groups, public libraries, universities, social organisations and interested individuals. In addition, we have also put them on HAB's homepage for wider access by the public. The two documents are still in stock, but we would keep in view the need for reprinting them in 2000-01. The cost will be absorbed within the provision mentioned in Part (a).

(c) – (g) Various Bureaux are responsible for considering the subject matters in the recommendations made by the UN Committee on the Elimination of Discrimination against Women that fall under their purview. As the review is still on-going and any follow up action deemed necessary thereafter would be carried out by the relevant Bureaux, it is up to them to consider whether resources need to be allocated to follow up those recommendations. As far as the Home Affairs Bureau is concerned, we have not included provision in the Estimates specifically for following up the recommendations. If the review should result in Home Affairs Bureau introducing new measures, we shall examine the resources implications of those measures and consider the best way forward. Within the Home Affairs Bureau, the work of conducting the review is carried out, among other duties, by one Principal Assistant Secretary, two Administrative Officers, one Assistant Clerical Officer and two secretarial staff. Together they entail an annual recurrent cost of \$3.4 million.

(h) No provision is reserved under this Head to provide financial assistance to NGOs. However, promotional materials referred to in Part (a) above can be made available to NGOs for the promotion of CEDAW.

- (xii) the Children's Reading Pledge from June to late 2000;

- (xiv) the 100 Years of Hong Kong Fashion Exhibition from August to September 2000;
- (xv) the International Basketball Cup from 2 to 6 September 2000;
and

The measures have included an Equal Opportunities (Race and Sexual Orientation) Funding Scheme; Announcement of Public Interests on TV; advertisements on public transport; promotional leaflets, posters and booklets; exhibitions; and production of "Guide to Services in Hong Kong" for migrant workers. We have also produced discrete Codes of Practice Against Discrimination in Employment on the grounds of Race and Sexual Orientation.
2. We plan to spend \$2.5 million under Subhead 270 on the promotion of equal opportunities in respect of race and sexual orientation. We treat this as a single item and do not have a pre-determined apportionment between the amounts allocated to race and to sexual orientation.
3. The measures listed in paragraph 1 will continue.
4. It is difficult, if not impossible, to measure the result of our efforts in quantifiable terms, as discrimination is ultimately a matter of attitude and perception. Our programme is for the long-term and is designed gradually to foster a culture of mutual respect and tolerance among all our people. As experience elsewhere clearly

demonstrates, it would be unrealistic to expect to see quick and measurable results in the short-term.

There is no need to increase the budget in this area because Home Affairs Bureau has been undertaking the work in question for several years and any increase in workload in the year 2000/01 (e.g. the plan to advise departments and co-ordinate their efforts on making their homepages more accessible to the visually-impaired) can

be absorbed by existing resources. It should be noted that the costs involved in maintaining and improving the homepages are borne from individual departments' allocations and not HAB's.

Question 2

The revised Guidelines on Dissemination of Information Through Government Homepages issued in July 1999 to all departments draws attention to the need to enhance accessibility by the visually impaired. In order to study how this can best be done, Home Affairs Bureau, Health and Welfare Bureau, Information Technology and Broadcasting Bureau, Information Services Department and Information Technology Services Department have joined a pilot scheme to revamp their homepages to facilitate access by the visually impaired. The revamping will be completed by the end of March 2000. The Hong Kong Blind Union has been giving advice and feedback on the revamped homepages. A seminar for webmasters of Government homepages will be held in May 2000 with a view to drawing departments' attention to the need to enhance the accessibility of their homepages and advising them how they can improve in this aspect. The speakers will include representatives of the Hong Kong Blind Union and Equal Opportunities Commission.

In the light of the pilot scheme and the seminar, we shall decide how best to bring the matter forward and consider the resource implications. In the meantime, no additional resources have been proposed in the draft Estimates.

Will there be any public consultation? When will the review be expected to complete? And how much resources will be needed?

Reply :

The current review of the Personal Data (Privacy) Ordinance (“PDPO”) seeks to address the operational difficulties encountered since its commencement in December 1996 and put beyond doubt the meanings of particular provisions. The proposed amendments to the Ordinance arising from the review will mainly be of a technical nature and will not involve major policy changes. The matters under consideration include, for example, whether the guidelines issued by the Privacy Commissioner for Personal Data (“PC”) should have legal effect on not only data users but also data subjects, whether the term “direct marketing” used in the

Ordinance should include the offering of social services to persons in need of such services and whether personal data transferred to the Public Records Office should be exempted from the provision in the Ordinance which prevents such transfer.

As the vast majority of the amendment proposals under consideration are of a technical nature, there is no plan to conduct public consultation. One of the proposals, concerning the right of parents to access the personal data of their children, has policy implications. We have been consulting organisations representing social workers, teachers, doctors, parents and children on the proposal. We intend to consult the relevant panel of the Legislative Council on all the proposals before introducing any legislative amendments. We hope to be able to finalise the proposals within the year 2000.

The review itself does not entail any additional resources. We shall examine the resource implications of the amendment proposals after the proposals have been finalised. In the meantime, no additional resources have been proposed in the draft Estimates.

- (b) The Home Affairs Department has introduced a Rural Public Works (RPW) programme in 1999-2000 for which \$100 million is available, to replace the Local Public Works (New Works) and the Rural Planning and Improvement Strategy (Minor Works) programmes. The 77 items in 2000-01 are the remaining projects currently under construction and have to be paid out under the Local Public Works (New Works) programme in the financial year 2000-01.

Reply : The average utilization rates of individual centres vary depending on the location of the venue and availability of similar facilities in the vicinity. Generally speaking, utilization is heavier during evenings and weekends. This is because most people are at work or in school during the daytime. In this connection, it may be noted that the average utilization rate of all community halls and community centres has been consistently over 80% during the evening hours of 7:00 p.m. to 10:00 p.m. during weekdays. Similarly, the facilities are heavily used during Saturday afternoons and evenings, with 70-85% utilization. These utilization rates cannot be regarded as low.

Over the years, government has endeavoured to improve the utilization of community centres and community halls by encouraging local organizations, and especially NGOs which are accommodated in the community centres, to make more and better use of the facilities available. Management committees established under District Councils also play an important role in promoting better utilization through the local community network. As a result, average utilization has steadily improved from 51% in 1995 to 62% in 1999. Our efforts will continue.

- (c) We have obtained FC's approval for a total of \$33.2 million additional funding to increase DC Members' accountable allowance and to provide a special allowance for DC Vice-Chairmen;
- (d) We have invited DC Chairmen and Vice-Chairmen to join the District Management Committees (DMCs) to enhance communication between DCs and Government departments;

- (e) We will involve DCs in the monitoring of environmental hygiene services and facilities at the district level. To this end, DCs will either set up an additional committee or expand the scope of the Environmental Improvement Committee; and
- (f) We will continue to advise bureaux and departments of the importance of consultation with DCs on both territory-wide and district issues, and to take into account DCs' advice in the policy formulation and implementation process.

Reply :

The average utilization rates of community centres and community halls over the past two years have been consistently estimated at 60%. The slight marginal increase in actual utilization during this period does not, at this stage, justify an adjustment of the estimated figure.

Community halls and community centres provide a focal point for community building activities undertaken by Government and local community organizations, such as voluntary agencies, mutual aid committees and owners' corporations. Activities held in these venues include social groups and civic education activities, training courses, meetings, celebration events, recreation and sports activities. They also provide temporary shelter for people in need during natural disasters, emergency situations and inclement weather.

Over the year, government has endeavoured to improve the utilization of community centres and community halls by encouraging local organizations, and especially NGOs which are accommodated in the community centres, to make more and better use of the facilities available. Management committees established under District Councils also play an important role in promoting better utilization through the local community network. As a result, the average utilization of community halls and community centres has improved from 51% in 1995 to 62% in 1999. Our efforts will continue.

Reply : The average utilization rates of individual centres vary depending on the location of the venue and availability of similar facilities in the vicinity. Generally speaking, utilization is heavier during evenings and weekends. This is because most people are at work or in school during the daytime. In this connection, it may be noted that the average utilization rate of all community halls and community centres has been consistently over 80% during the evening hours of 7:00 p.m. to 10:00 p.m. during weekdays. Similarly, the facilities are most heavily used during Saturday afternoons and evenings, with 70-85% utilization. These utilization rates cannot be regarded as low.

The utilization of community centres and community halls is monitored on a continuing basis by District Offices and District Councils. Efforts have been and will continue to be made to improve the utilization rates where necessary.

Reply : a) Out of the 42 temporary posts, 27 will be created for organising activities to celebrate the Third Anniversary of the Establishment of the Hong Kong Special Administrative Region (HKSAR) and the National Day in 2000, and the remaining 15 for organising projects and activities to celebrate the new Millennium.

The 42 posts include the following:

- (xii) 1 Administrative Officer of Staff Grade C rank;
- (xiii) 4 Chief Executive Officers;
- (xiv) 6 Senior Executive Officers;
- (xv) 4 Executive Officers I;
- (xvi) 2 Executive Officers II;
- (xvii) 2 Personal Secretaries I;
- (xviii) 6 Personal Secretaries II;
- (xix) 1 Clerical Officer;
- (xx) 10 Assistant Clerical Officers;
- (xxi) 5 Clerical Assistants; and
- (xxii) 1 Workman II.

The total expenditure incurred for the creation of these 42 posts is around \$7.1 million.

- b) The activities to be organised in 2000-01 to celebrate the Millennium include:

- (xvii) the Coming of Age Ceremony on 4 May 2000;
- (xviii) the French Riding Performance from 12 to 14 May 2000;
- (xix) the Opening of the Chi Lin Nunnery on 18 May 2000;
- (xx) the Children's Reading Pledge from June to late 2000;
- (xxi) the International Harmony/Asian Extravaganza in August 2000;
- (xxii) the 100 Years of Hong Kong Fashion Exhibition from August to September 2000;
- (xxiii) the International Basketball Cup from 2 to 6 September 2000; and
- (xxiv) the European Christmas Carnival from December 2000 to early 2001.

Other than the above activities, a number of capital projects have been launched in order to make the new Millennium more memorable. The projects, which will be completed in 2000-2001 include:

- (xxv) the establishment of the Chinese Cuisine Training Institute;
- (xxvi) the building of the International Wetland Park;
- (xxvii) the construction of the Hong Kong Heritage Museum; and
- (xxviii) the construction of the Hong Kong Museum of History.

Activities (i) to (viii) above will be funded through a combination of sponsorships mainly from the community and partly from the remaining amount of about \$1 million in our millennium project vote. Funding for capital projects (ix) to (xii) above will be provided under the capital works programmes within the purview of the respective policy bureaux.

As regards the manpower arrangement for these Millennium celebrations, activities (i) to (viii) will be co-ordinated by the Millennium Celebrations Office staffed by the 15 temporary posts mentioned in part (a) of the reply. The staff cost involved is around \$1.7 million. The manpower requirements for capital projects (ix) to (xii) will fall under the purview of the respective policy bureaux.

As regards the activities to celebrate the Third Anniversary of the Establishment of the HKSAR, we have initially planned to organise a flag-raising ceremony in the morning, a community participation activity in the daytime and a banquet/dinner in the evening on 1 July 2000. The estimated expenditure is roughly \$5 million. The detailed programme of these celebration activities has yet to be firmed up. Approval for funding will be sought when the programme details are available.

As regards the celebration of the National Day in 2000, the activities under planning include: a flag-raising ceremony in the morning and a celebration show in the evening on 1 October 2000. It is estimated that the expenditure involved will be around \$9 million. The details of these activities have yet to be worked out. Once we have a firmer proposal, the necessary funding approval will be sought.

Regarding the manpower arrangements for the celebration of the Third Anniversary of the Establishment of the HKSAR and the National Day Celebration in 2000, the celebration activities for both occasions will be organised and coordinated by the Celebration Co-ordination Office to be set up upon creation of the 27 temporary posts mentioned in part (a) of the reply. The SSS is established to finance local sports associations for organising sports training schemes, local sports competitions and international sports competitions held locally. The DFSS is established to give financial assistance to district bodies for organising district festivals and other large-scale festive events in celebration of traditional festivals such as Dragon Boat Festival, Mid-Autumn Festival. The allocations for SSS and DFSS in 2000-01 are \$40.4 million and \$18.7 million respectively.

Reply :

As the PMCs were financially autonomous, their estimates are not directly comparable to those of a Government department. The provision for 2000-01 reflects the requirements of the new Leisure and Cultural Services Department (LCSD) to maintain a broadly similar level of service to that of the PMCs, plus earmarked growth in 2000-01. It has also taken into account savings arising from reorganisation of municipal services. It does not however include services provided by other Government departments, for example, building services provided by Architectural Services Department. The provisions for computerisation, plant and equipment, and capital works projects are funded under the Capital Works Reserve Fund. Moreover, since the re-organisation on 1.1.2000, the new department has taken up the responsibilities for the Antiquities and Monuments Office and Books Registration Office. Reply :

A total of 754 new posts have been budgeted in 2000-01. Of these:

- 583 are for new facilities (e.g. the Hong Kong Central Library, Hong Kong Museum of History, Hong Kong Heritage Museum, Tsung Kwan O Public Library, Film Archive and Leisure Centre on Sai Wan Ho Reclamation, Homantin Leisure Centre, Tseung Kwan O Indoor Recreation Centre and Swimming Pool) and improvement of existing services (e.g. enhancement of safety at swimming pools); and
- the remaining 171 are required to accommodate surplus general grades staff in the civil service in place of LCSD's contract staff whose contracts are due to expire in the coming financial year.

The 754 budgeted posts will be partly offset by the deletion of 204 posts which became surplus as a result of the reorganization but were retained temporarily to accommodate the surplus staff pending redeployment. The net number of additional posts budgeted for creation is 550.

The actual creation of the budgeted posts will be subject to the strictest scrutiny of the Departmental Establishment Committee machinery. In addition, the department will make every effort to contain overall establishment growth by:

- meeting additional staffing requirements through redeployment of existing staffing resources as far as possible;
- identifying scope for procedure streamlining and efficiency gain; and
- contracting-out or corporatisation of services and other initiatives for productivity gain.

Detailed recommendations for merger of the Recreation and Sport Officer and Amenities Officer grades have been drawn up and staff consultation is now underway. When finalised, the recommendations will be forwarded to the Civil Service Bureau, the Standing Commission on Civil Service Salaries and Conditions of Service, and the Finance Committee for consideration. We hope that the package will be approved for implementation within the new financial year.

Reply : The Executive Council decided in 1995 that existing Neighbourhood Level Community Development Projects (NLCDPs) will be terminated upon clearance of their serving areas and in the absence of new priority areas. A new priority area must fulfil the following criteria. First, the area must have a population between 3000 and 15000. Second, the area must not be due for clearance within 3 years. Third, the area is classified as a low income area.

The North Point Estate has a population of 6100 as at March 2000 but its final evacuation date for clearance falls in February 2002, which is less than 3 years away. The eligibility of the North Point Estate for the provision of the NLCDP will be examined by the Committee on NLCDPs chaired by the Home Affairs Bureau with representatives from the Housing Department, Hong Kong Council of Social Service and Social Welfare Department.

Reply : Under the current policy, new Integrated Neighbourhood Projects (INPs) will be set up as required only when resources from existing Neighbourhood Level Community Development Projects (NLCDPs) are released upon redevelopment clearance of their serving housing areas.

Owing to clearance slippages, only 8 INPs were set up in 1999-2000 with the remaining 4 teams deferred to be set up in 2000-01. Taking into account the overall clearance plans in 2000-01, a total of 12 teams will be formed including the 4 teams slipped from 1999-2000.

Reply : The Executive Council decided in 1995 that existing Neighbourhood Level Community Development Projects (NLCDPs) will be terminated upon clearance of their serving areas and in the absence of new priority areas. On the basis of this policy, 6 NLCDPs are planned to be terminated in 2000-01.

The Audit Commission Report No. 29 published in October 1997 pointed out that those existing NLCDPs serving a population below 3000 needed to be critically examined. It was subsequently agreed with the operating non-governmental organizations concerned that those NLCDPs serving a population below 1800 should be terminated. As a result, another 3 NLCDPs are expected to be terminated in 2000-01.
