#(1) 譚耀宗議員 (口頭答覆)

關於推行樓宇逆按揭(簡稱“逆按”)計劃作為一項退休保障選擇，政府可否告知本會：

- (一) 是否知悉現時有哪些國家推行逆按計劃，以及該等計劃的運作方式、65歲或以上人士的參與率，以及參與者的年齡、家庭和財政狀況，以及彼此的共通點；及
- (二) 會否研究在本港推行逆按計劃的可行性及所需的配套措施，包括該等計劃對銀行的資產及負債結構的影響；若會，詳情為何；若不會，原因為何？

# (7) Hon Howard YOUNG (Written reply)

Bangladesh has granted visa-free access to both Hong Kong Special Administrative Region ("HKSAR") and British National (Overseas) ("BNO") passport holders. I have, however, received complaints from a few travel agents that their clients who travelled separately to Bangladesh with the above mentioned passports had been requested to pay USD30 and USD60 respectively because they did not have a visa on entry to the country. Neither was a receipt issued nor a visa stamped on their passports after payment. In this connection, will the Government inform this Council of:

- (a) the measures it has taken to ensure that the immigration controls of those countries who offer visa-free access to holders of HKSAR and BNO passports are aware of such policy; and
- (b) the advice it offers to such passport holders of the action they should take when they are asked to pay the above-mentioned fees upon arrival at the immigration control in Bangladesh?

# (8) Dr Hon David LI (Written reply)

While the Customs' special anti-piracy taskforce has decimated the number of outlets of pirated products, the criminals are more violent when they are under arrest, as witnessed by the increased number of injuries on the part of Customs officers whilst undertaking such duties last year. In this connection, will the Government inform this Council whether:

- (a) it will consider providing additional training to Customs officers to ensure their personal safety while performing law-enforcement duties; and
- (b) it will deploy extra manpower or weapons in such law-enforcement actions; if not, of the reasons for that?

- (a) whether the People's Liberation Army Military Force stationed in Hong Kong, which took over a set of FM radio frequencies from the former British Forces Broadcasting Service, has any plans to broadcast; if so, of the details; and if not, whether the frequency band will be transferred back to the HKSAR Government for allocation to other uses; if so, whether the Administration will consider
  - (i) switching Radio 3, Radio 5 and the Putonghua channels of Radio Television Hong Kong ("RTHK") to FM broadcasting for better reception;
  - (ii) introducing more commercial broadcasters to enable a more lively and diverse radio service provision; and
  - (iii) setting aside frequency bands for broadcasting by non-commercial or community based organisations to provide a richer civic environment; and
- (b) of the results of RTHK's field tests on Digital Audio Broadcasting ("DAB") completed last year; and how DAB will assist in overcoming the shortcomings of FM and AM analogue broadcasting?

# (12) Hon Emily LAU (Written reply)

Recently a construction company was fined \$250,000 by a magistrate for failing to comply with building regulations. Faults were found in piling works of a 27-story residential tower in Happy Valley in August 1998 where six piles were shorter than specified. The magistrate imposed the maximum fine and said the case had fundamental impact on public perception of the company and other construction companies in Hong Kong. He said fines of up to \$5 million would not be excessive as tenants could be endangered by faulty works. Will the Executive Authorities inform this Council:

- (a) the number of cases involving defective piling in the past three years;
- (b) whether there are plans to substantially increase the fines and to introduce prison sentence for such offences; and
- (c) actions that have been taken to strengthen monitoring of these building works?
