#(3) 羅致光議員 (口頭答覆)

政府可否告知本會：

- (一) 有否評估在各條行車隧道管道內，以石油氣為燃料的車輛(簡稱“石油氣車輛”)自行起火然後爆炸，或因其他車輛的火勢蔓延引致該等車輛爆炸的機會分別為何；
- (二) 有否評估本港各行車隧道的逃生設施是否足以應付石油氣車輛在隧道管道內起火的情況；若評估為足以應付，詳情為何；若否，有關當局有何改善計劃；及
- (三) 消防署和機電工程署有否計劃就隧道管道內發生涉及石油氣車輛的事故，向所有隧道公司工作人員和石油氣車輛司機提供特別訓練；若有計劃，詳情為何？

(3) Hon LAW Chi-kwong (Oral Reply)

Will the Government inform this Council whether:

- (a) it has assessed the respective chances of explosion of vehicles fuelled by liquefied petroleum gas ("LPG vehicles") on fire themselves or caused by the spreading of fire from other vehicles inside various vehicle tunnel tubes;
- (b) it has assessed if the means of escape inside various vehicle tunnels in Hong Kong are sufficient to cope with situations in which LPG vehicles are on fire inside the tunnel tubes; if they are assessed as sufficient, of the relevant details; if not, whether the relevant authorities have improvement plans; and
- (c) the Fire Services Department and the Electrical and Mechanical Services Department have planned to provide special training for all tunnel company staff and drivers of LPG vehicles to deal with incidents involving LPG vehicles inside the tunnel tubes; if they have, of the details?
