**Building Management (Amendment) Bill 2000  
Notice of Resumption of Committee Stage**

When the Secretary for Home Affairs (SHA) moved for adjournment of the Committee Stage discussion of the Building Management (Amendment) Bill 2000 under Rule 40(4) at the Legislative Council sitting on 22 June, he indicated that he intended to resume the discussion of the Bill at the next Council sitting commencing on 26 June 2000. In accordance with Rule 40(7), I enclose a notice of resumption to the Clerk of the Legislative Council signed by Mr. Lan.

In view of the special circumstances leading to SHA's motion for adjournment, I would be very grateful if you could exercise your discretionary authority under Rule 40(7) and agree to dispense with the five clear days notice requirement.

Furthermore, as Members have not been availed of the opportunity to vote on the remaining part of the Committee Stage amendments to clause 3, SHA intends to move these amendments when the Council resumes the discussion of the Bill next week. I attach a notice of these remaining CSAs to clause 3 signed by Mr. Lan and a clean copy of the amendments (i.e. without the parts already disapproved by Members) for the Clerk's further action. I would be grateful for your kind agreement to dispense with the 7 clear days notice required under Rule 57(2) because of the extenuating circumstances.
