Subsidiary Legislation Gazetted on 28 April 2000**

Date of Tabling in LegCo : 3 May 2000

Amendment to be made by : 31 May 2000 (or 7 June 2000 if extended by resolution)

**Shipping and Port Control Ordinance (Cap. 313)
Shipping and Port Control (Amendment) Regulation 2000 (L.N. 107)**

This Regulation, in consolidating all the speed restriction provisions made under the principal ordinance, seeks to re-define the boundaries of speed restriction area and revise the maximum permitted speed for vessels in the waters of Hong Kong in response to the rapid development in local waters over the years.

The Regulation shall come into operation on a day to be appointed by the Secretary for Economic Services.

LegCo Brief MA60/1(99) Pt.2 issued by the Economic Services Bureau in April 2000 is relevant.

These 2 sets of subsidiary legislation remove speed restriction

provisions in relation to typhoon shelters and pleasure vessels contained in their respective principal subsidiary legislation as those provisions are now re-enacted centrally under the Shipping and Port Control Regulations.

They will come into operation in step with the foregoing amending regulation (L.N. 107).

This Regulation makes changes to the titles of some positions currently held by Senior Officer (Auxiliary) and Officer (Auxiliary/Flying) of the Government Flying Service and adds a new position to each of these 2 divisions.

The Regulation will come into effect on 1 June 2000.

This Notice updates the rank and pay classification of the auxiliary section of the Government Flying Service.

It will come into operation on 1 June 2000.

Hong Kong Airport (Control of Obstructions) Ordinance (Cap. 301)
Hong Kong Airport (Control of Obstructions) (Exemption) Order (L.N. 112)

This Order exempts 2 specified areas from the operation of the Hong Kong Airport (Control of Obstructions) (No. 2) Order 1997, which imposes height restrictions on buildings within areas covered by the Order. It also specifies the new height restrictions of the buildings which may be erected on the 2 exempted areas.

According to the LegCo Brief (PLB(L)98/98/04(98) issued by the Planning and Lands Bureau in April 2000), the exemption is granted to allow the construction of a building extension in the television transposer station at Kowloon Peak and reconstruction of a multi-purpose hall of the Hong Kong Youth Hostels Association's facilities at Sze Lok Yuen, Tai Mo Shan.

The Order will come into operation on 8 June 2000.
