**Legal Service Division Further Report on
Adaptation of Laws (No. 2) Bill 1999**

At the House Committee meeting on 26 February 1999, Members agreed to defer consideration on the Bill until certain issues common to other adaptation bills have been resolved by the Bills Committees on those adaptation bills.

2. In the light of the resolution of these issues by the other Bills Committees, the Administration has now proposed in similar terms the following Committee Stage amendments (CSA) to the Bill :-

- (a) to re-word the clauses on the saving of the rights of the Crown, upon adaptation, as "... the rights of the Central Authorities or the Government of the Hong Kong Special Administrative Region under the Basic Law and other laws" (instead of "... the rights of the Central People's Government or the Government of the Hong Kong Special Administrative Region under the Basic Law or other laws" as originally proposed in the Bill); and
- (b) to withhold the adaptation of "Crown" where the Hong Kong Examinations Authority is expressed as not to be regarded as a servant or agent of the Crown or as enjoying any status, immunity or privilege of the Crown.

In addition, the proposed adaptation of the Lingnan College Ordinance is removed as a consequence of the repeal of that Ordinance and the enactment of the Lingnan University Ordinance (54 of 1999). A copy of the proposed CSA is attached.

3. Annexes A and B of our main report (LS 103/98-99) are reproduced for ease of reference. Subject to Members' views, the Bill is ready for resumption of Second Reading debate.

Notes :

1. References to “Crown” are adapted to “Government” or “State” depending on context. For example, such a reference in the Hong Kong Examinations Authority Ordinance is amended to refer to the “State” where it is provided that the Hong Kong Examinations Authority is not the servant or agent of the Crown and does not enjoy any status, immunity or privilege of the Crown. In the Chinese University of Hong Kong Ordinance, such a reference is amended to refer to the “Government” where the provision is about payment of rent to the Crown in respect of land granted to the University.

2. These terms are so amended where they appear in clauses saving the rights of the Queen etc.
