**Present Status**

Site not available. Temporary use of the site by Arch SD as works area for Lai Chi Kok Park stage III (Landscape portion - Phase Ia). Arch SD has been requested to revise the design of the IGC to avoid blocking the views of some residential units nearby.

**Present Status**

Site is being used for vehicle parking under Short Term Tenancy. Part of the project site has been alienated to ED for construction of a primary school. In return, an open space in Lai Kok Estate (i.e. the compensatory site) will be incorporated in this project.

**Present Status**

Site available (i.e. existing venue). Consideration being given to redevelop the playground together with an adjacent housing site to be released by HD in 2000/01 for open space development.

This project contains LCS and FEH facilities. On the LCS side, we are reviewing the need for a new leisure centre in the light of the utilization rate of similar facilities in the district. The need for a music centre is also under review.

On the LCS side, we are reviewing the need for the proposed leisure centre as mentioned above. We do not see any pressing demand for additional library services in the district.

**Present Status**

The playground is rather remote and its usage rate is low. There does not appear to have a need to redevelop this playground.
