## MIDWIVES REGISTRATION (FEES) REGULATION

### INTRODUCTION

At the meeting of the Executive Council on 16 November 1999, the Executive Council ADVISED and the Chief Executive ORDERED that the Midwives Registration (Fees) Regulation at **Annex A** should be made under section 23(1) of the Midwives Registration Ordinance ("the Principal Ordinance").

### BACKGROUND AND ARGUMENT

#### General Background

2. The Midwives Registration Ordinance (Cap. 162) ("The Principal Ordinance") provides a statutory framework for regulating the profession of midwifery through a system of registration and discipline. The fees in relation to the registration of midwives are currently provided in the Midwives (Registration and Disciplinary Procedure) Regulations ("the existing Regulations") made under the Principal Ordinance.

3. The Principal Ordinance was updated in June 1997 via the enactment of the Midwives Registration (Amendment) Ordinance 1997 ("the Amendment Ordinance"). The Amendment Ordinance provides for, among other things, the requirement for a practising midwife to hold a valid practising certificate and the repealing of the existing Regulations. While most of the provisions of the Amendment Ordinance have come into operation on 30 September 1999, we have yet to bring into effect the provisions relating to practising certificate and the repeal of the existing Regulations, pending the making of the following subsidiary legislation:-

- (a) **Midwives Registration (Fees) Regulation** ("the Fees Regulation"), to be made by the Chief Executive-in-Council, prescribing the fees payable under the Principal Ordinance;

- (b) **Midwives (Registration and Disciplinary Procedure) Regulation**, to be made by the Midwives Council of Hong Kong subject to the approval of the Secretary for Health and Welfare, prescribing the registration and disciplinary procedures for the midwifery profession; and
- (c) **Midwives Registration (Miscellaneous Provisions) Regulation**, to be made by the Secretary for Health and Welfare, prescribing the functions of the legal adviser and the secretary to the Midwives Council of Hong Kong.

We shall bring the remaining provisions of the Amendment Ordinance into operation in tandem with the commencement of the above Regulations.

4. This Brief covers the Fees Regulation only. The other two Regulations will be enacted shortly.

## **THE REGULATION**

5. The Fees Regulation provides for the fee items in relation to registration of midwives and their disciplinary proceedings, including-

- (a) the fees related to first registration, re-registration, and the provision of a certified copy of a certificate of registration, the examination fee and the fee for providing record of disciplinary proceedings. The fee levels will remain unchanged as at present; and
- (b) a new fee of \$220 for issuance of a 3-year practising certificate, which is set on cost-recovery basis. The relevant cost computation is at **Annex B**. The practising certificate is renewable every 3 years. This new fee will replace the existing annual practising fee of \$65.

6. Section 1 of the Fees Regulation provides that the Regulation shall come into operation on a day to be appointed by the Secretary for Health and Welfare by notice in the Gazette.

7. Section 2 and the Schedule of the Regulation prescribe the amount of fees payable under the Ordinance.

## **LEGISLATIVE TIMETABLE**

8. The legislative timetable is as follows:

## **BASIC LAW IMPLICATIONS**

9. The Department of Justice advises that the Regulation is consistent with the Basic Law.

## **HUMAN RIGHTS IMPLICATIONS**

10. The Department of Justice advises that the Regulation has no human rights implications.

## **BINDING EFFECT OF THE LEGISLATION**

11. The Regulation will not affect the current binding effect of the Midwives Registration Ordinance.

## **FINANCIAL AND STAFFING IMPLICATIONS**

12. There are no additional staffing implications. The revenue arising from the new fee for practising certificate is estimated to be about \$400,000 per year.

## **PUBLIC CONSULTATION**

13. The Midwives Council of Hong Kong has been consulted about the Fees Regulation and it has raised no objection. Public consultation is not considered necessary as the Fees Regulation affects only registered midwives.

## **PUBLICITY**

14. The Regulation will be published in the Gazette on 19 November 1999. A press release will be issued on the same day. A spokesman from the Midwives Council Secretariat will be available to handle media and public enquiries.
