## Online educational activity—mock motion debate Enhancing the development of heritage tourism

The students who deliver speeches are required to prepare their own speeches. See the next page for the preparations required.

Hong Kong has many monuments and historic buildings such as the former Kowloon-Canton Railway Clock Tower in Tsim Sha Tsui and Wong Tai Sin Temple. This Council urges the Government to review the existing ways of conserving heritage to make sure the work being carried out will meet the purposes of preserving the historic buildings as well as developing heritage tourism.

## Online educational activity—mock motion debate Preparations by school

#### Motion: Enhancing the development of heritage tourism

The main preparations before the activity are outlined below:

- (a) Due to the time constraint of the activity, around six students will have a chance to speak, including the President of the Legislative Council (one student), Members (four students) and public officer (one student);
- (b) Except for the student who acts as the President of the Legislative Council, all students (Members/public officer) who will speak during the debate have to prepare speeches in advance and the speaking time limit for each is about one minute;
- (c) Preparations by those students include conducting research, collecting ideas through discussions and writing speeches (Member A (one student) to move the motion, Members B to D (three students) to express their views for or against the motion, and public officer (one student) to reply); and
- (d) The students who act as Members have to decide the corresponding constituencies (e.g. returned by the Election Committee, Tourism Functional Constituency and Geographical Constituency) they represent and write them down in the activity rundown on the next page.

#### Sample speeches by Members and public officer (for reference only)

The Member moving the motion (Member A)	Move the motion (Tourism Functional Constituency)	- I move that the motion be passed, to urge the Government to enhance the development of heritage tourism and review the existing ways of conserving heritage. In preserving historic buildings, the Government needs to work on putting the buildings to new uses after repairs. Besides, as the Government has not required that tourist features be added to the buildings, the tourist industry may not benefit from the current methods. I believe the Government should make more efforts in promoting the development of heritage tourism to attract tourists to Hong Kong.	
Other Members speaking on the motion (Members B to D)	For	- I support Member A's motion.  ➤ Sample (Sports, Performing Arts, Culture and Publication Functional Constituency): Wing Lee Street in Central was the filming location of an award winning movie. After the movie was released, many visitors came to visit it and the street became a tourist spot. The street has therefore been preserved completely. This shows that we may preserve historic buildings by making them attractive to tourists. In addition, when more tourists come to visit, shops nearby will get more business	

Role	Sample speech (for reference only)	
	Sample (Election Committee): Local history is attractive to tourists and historic buildings can showcase Hong Kong's East-meets-West culture, such as the former Central Police Station (Tai Kwun), and the Ex-Sham Shui Po Service Reservoir which has aroused much public concern recently. The Government should put special historic buildings to good use and add more tourist features, so that Hong Kong can have more destinations for recreational and leisure activities	
Against	<ul> <li>I oppose Member A's motion.</li> <li>➤ Sample (Geographical Constituency): When deciding which buildings should be preserved, the Government should consider not only the uses of the buildings, but also, among others, the special features of the nearby communities, future plans for the area, public views and needs of the community. More importantly, efforts made can help preserve historical and heritage sites. The Government should not place too much emphasis on developing tourist features</li> </ul>	
	Sample (Transport Functional Constituency): If historic buildings become tourist spots, the nearby streets and roads may become over-crowded and public facilities in the local area may not be enough to meet people's needs. This will only end up affecting the life of the people in the area. The Government should make sure that the people living around these buildings agree with the idea of turning these buildings into tourist spots before taking action	
Public officer (Secretary for Development)	I am pleased that many Members agree with the Government's plan to preserve our heritage. Historic buildings may have many uses. Developing them into tourist attractions is an option worthy of study. In the future, the Government will work harder to promote the historic buildings so that people will know more about Hong Kong. At the same time, we shall think about how to preserve historic buildings in other ways

<sup>(</sup>b) the passage of motions and amendments thereto introduced by individual Members requires a majority vote of each of the two groups of Members present, i.e. Members returned by the Election Committee, and those returned by functional constituencies and by geographical constituencies through direct elections.
